(3) IN PROMOTING THE EDUCATION, INCLUDING RELIGIOUS EDUCATION AND SOCIAL AND PHYSICAL TRAINING, OF PERSONS UNDER 25 YEARS OF AGE WHO ARE RESIDENT OR HAVE A PARENT OR PARENTS RESIDENT IN THE PARISH OF NEWBOROUGH AND WHO IN THE OPINION OF THE TRUSTEES ARE IN NEED OF FINANCIAL ASSISTANCE.
