Introduction

Notes to the Accounts

1. Accounting Policies

(a) Basis of Preparation

The financial statements have been prepared in accordance with the Charities SORP (FRS 102), the Charities Act 2011, and UK Generally Accepted Accounting Practice.

Kidderminster Covenant Church is an unincorporated charity based in England.

The accounts are prepared on a historical cost basis in pounds sterling. The trustees consider the charity to be a going concern.

(b) Funds

The charity holds unrestricted and restricted funds.

- Unrestricted funds are for general church purposes and may be used at the trustees' discretion.
- Restricted funds are to be used only for specific purposes set by donors, such as mission or building work.
The trustees may also set aside designated funds for future needs.
The charity does not hold any endowment funds.

(c) Income Recognition

Income is recognised when it is received or when entitlement is certain and can be measured reliably. This includes regular donations, tithes, Gift Aid, grants, and fundraising income.

Volunteer time is not included. Gifts in kind are recognised only if their value can be measured reliably.

Any investment or rental income is recognised when the right to receive it arises.

All incoming resources are included in the Statement of Financial Activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy.

Specific policies are applied as follows:

- Voluntary income from grants, donations, and gifts is included in full when receivable.
- Grants not conditional on performance are recognised when unconditionally receivable.
- Donated services and facilities are recognised where quantifiable.
- Gifts donated for resale are recognised when sold.
- Grants for fixed assets are recognised in full when receivable.

(d) Expenditure Recognition

Expenditure is recorded when incurred and includes all costs directly related to the charity's work. Charitable expenditure covers the costs of worship, mission, and community activities.

(d) Expenditure Recognition (continued)

Support and governance costs include administration, insurance, utilities, and general running costs. Fundraising costs are minimal. Irrecoverable VAT is included within the relevant expense category.

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered and is reported as part of the expenditure to which it relates.

Fundraising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of charitable activities.

(e) Support Costs

Support costs are those that assist the charity's operations but are not directly linked to specific activities.

These include administrative and governance costs. They are allocated to charitable activities based on staff time or use of premises.

Support costs are those costs incurred directly in support of expenditure on the objects of the charity and include project management.

(f) Fixed Assets

The charity holds no significant fixed assets. Any equipment costing over £500 is capitalised and depreciated over its expected useful life, normally between three and five years. The charity does not hold any goodwill or intangible assets.

(g) Going Concern

The trustees have reviewed the financial position and are satisfied that Kidderminster Covenant Church has sufficient funds to continue its activities for the foreseeable future.
