TO PROMOTE AND FUND SCIENTIFIC AND MEDICAL RESEARCH INTO THE EFFECTS OF HOLISTIC MEDICINE AND TO PUBLISH THE USEFUL RESULTS OF ANY SUCH RESEARCH7. TO PROMOTE AND ASSIST IN THE PROMOTION OF THE RELIEF AND TREATMENT OF INDIVIDUALS SUFFERING FROM ILLNESS OR DISEASE WHO WOULD OTHERWISE BE UNABLE TO AFFORD SUCH TREATMENT8.
