Trustees Annual Report 2021**

2021 was another challenging year with the Bookshop being closed for the first three months of the year due to the COVID-19 Pandemic – the third national lockdown. The shop re-opened to the public on 12<sup>th</sup> April but although some customers are back shopping, footfall and sales are 50% down and recovery is slow.

We are thankful for furlough payments for the three months and small business grants which were received from Central Bedfordshire Council. This made it possible to meet all financial obligations and pay all publishers and suppliers in full. A further one year roadmap for 2022 has been approved by the Trustees to help the shop navigate through the slow trading days.

Suitable protective measures were kept in place for staff and customers. Once the shop re-opened, the services of nine Volunteers has been available for cover and we are very thankful for the help and assistance they provide. Some ministry opportunities have arisen but with the restriction on numbers within the shop these have not been as frequent as pre-Pandemic days.

It was possible to hold bookstalls at two Conferences and also four Christmas bookstalls. We were able to sell all the entire stock of Christmas cards and calendars and this obviously helped towards the result of an operational profit for the year.

## **Christian Books. Trustees Annual Report 2020**

2020 has been a very tough year with the arrival of the Coronavirus COVID-19 pandemic, closure of the bookshop due to national lockdowns, Tier 4 restrictions and furloughed staff. The pandemic and closure of the bookshop has meant a tremendous loss in potential sales, hitting the bookshop hard with lost revenue from cancelled conferences and cancelled Christmas bookstalls. The shop was closed for 106 days during the year, of which 22 days were as a "Click and Collect" only basis during the November lockdown.

We are thankful for the receipt of COVID-19 small business grants and 80% furlough payments to help through the periods of closure. This enabled the shop to meet all its financial obligations and pay all of our suppliers, resulting in a small operational profit. However, overall sales were down by 55%, Christmas sales were poor, resulting in much unsold Christmas stock. A one year roadmap for 2021 has been approved by the Trustees to help the bookshop navigate through what might remain a turbulent time as far as trading is concerned.

Risk assessments were carried out and suitable protective measures put into place for staff and customers. Occasional ministry opportunities occurred but with the given restrictions on numbers within the shop at any one time, these occasions were obviously not as frequent as the previous year.

Volunteer staff were still available to help with cover during the hours the shop could open and we are very thankful for the help and assistance they provided.
