Structure, governance and management

Constitution

Streatham Choral Society is a registered charity governed by a constitution adopted on 20 March 1989, as amended 28 February 2000, 11 November 2002 and 9 May 2018.

Elections and Committee

The trustees of the Society are a Committee elected annually by members of the Society at their annual General Meeting. The Committee holds several meetings a year and is responsible for deciding what bank and building society accounts the Society should hold, and for approving levels of expenditure and reserves.

Objectives and activities

Objects

The objects of the Society are to "promote, improve, develop and maintain public education in and appreciation of the art and science of music in all its aspects by the presentation of public concerts and recitals and by such other ways as the Society through its committee may decide from time to time".

We aim to enrich local lives through music. How we do this is by performing quality music and educating & socialising inclusively.

We do this through weekly rehearsals, regular performances and through socialising.

Our three principles are friendliness, quality and inclusivity with the purpose of:

- promoting the love of music
- striving for musical excellence alongside complete inclusivity
- enriching local lives
- having fun whilst singing

Objectives and activities (continued)

We rebranded 'Streatham Choral' during the year. This is reflected in our website and other publicity opportunities ensuring that concert details are promoted in the locality. We are on Twitter, Facebook and Instagram.

In planning our activities the Committee have considered the Charity Commission's guidance on Public Benefit including the guidance on public benefit and fee charging. We rely on income from ticket sales and subscriptions to cover its running costs. In setting the level of ticket sales, membership subscriptions and the concessionary rates, the Committee gives careful consideration to those on low incomes. Accessibility to our concerts is important to us and is reflected in our pricing structure set out in the notes.

Achievements and performance

During the year to 31 July 2025 we performed four concerts. These were:

9 November 2024:	Verdi - Requiem
14 December 2024:	Carols, Songs and Readings including Bach's Jauchzet, frohlocket! & Howard Goodall's By-by, Lullaby, By-by
5 April 2025:	Bach - St John Passion
5 July 2025:	Poulenc - Gloria, Vierne - Messe Solenelle & other works

This year's music began with Verdi's Requiem followed by a day of very popular Christmas concerts which raised £1,345.64 for Streatham Youth & Community Trust. This enhanced publicity both for the Society and for the charity.

There was then an all day 'Workshop' in January 2025 working with vocal coaches in preparation for the highlight of the year, Bach's St John Passion, performed at Southwark Cathedral in April 2025.

After the Summer concert, the choir rounded off the year with its third tour, this time to Edinburgh, with 62 singing members going.

Membership paid numbers began exceedingly well at 161, were 164 in the Spring term and then, as is traditional during the Summer term, tailed off a little to end with 144 members. The average paid membership was 156. We currently have a limit of 160 members and are operating waiting lists for all voice parts except for tenors.

This leaves us well placed well for the coming 2025/26 season.

Financial review


Our main source of funds is the income raised by membership subscriptions and ticket sales. Subscriptions are bundled so that they include two free tickets for each concert.

The chief item of expenditure is the cost of hiring musicians for concerts followed by the cost of rehearsals. We aim to cover our costs each year and adjust prices as necessary.

Subscription income and ticket sales, particularly for the Spring concert, were good which meant a budgeted breakeven position became a surplus of £3.7k despite £39k being spent on concerts.

The overall unrestricted surplus was £3,856 (2024 - deficit £1,025) taking unrestricted reserves up to £38,527. Total unrestricted income amounted to £65,121 (2024 - £57,164) against unrestricted expenditure of £61,265 (2024 - £58,021).

Notes to the accounts

Accounting policies

(a) Basis of preparation

The accounts have been prepared under the historical cost convention and in accordance with applicable accounting standards, Charities Acts and the Statement of Recommended Practice - Accounting and Reporting by Charities - applicable to charities preparing their accounts in accordance with the Financial Reporting Standard for Smaller Entities (effective 1 January 2015).

(b) Income and expenditure

Total income as shown in the Statement of Financial Activities is the turnover of the charity. It represent the value of concert ticket sales, members' subscriptions and donations receivable in the ordinary course of activities.

Voluntary income received by way of donations and gifts to the charity is included in full in the Statement of Financial Activities when received.

Costs of raising funds comprise those operational costs directly attributable to promotional activities and the running of raffles and refreshments

Charitable activities include the costs of termly rehearsals, the staging of concerts and termly events.

Governance costs are those incurred in connection with the running of the Society as opposed to its charitable activity.

(c) Concerts and other fund-raising events

Each event is separately identified and all relevant income and expenditure allocated thereto.

(d) Restricted and unrestricted Funds

Restricted funds are to be used for specific purposes as laid down by the donors. Expenditure which meets this criterion is allocated to a restricted fund.

Unrestricted funds are donations and other income received or raised for the charity's purposes.

Achievements and performance

During the year to 31 July 2024 the Society performed four concerts. These were:

11 November 2023: Rossini - Petite Messe Solennelle
16 December 2023: Carols, Songs and Readings including Howard Goodall's By-by, Lullaby, By-by
6 April 2024: Mozart - Requiem, Haydn - Inanae et Vanae Curae
29 June 2024: Magnificat! - works by Rutter, Zelenka and Forbes L'Estrange

This year's music began with Rossini's operatic Petite Messe Solennelle followed by two very popular Christmas concerts which raised £990.07 for Streatham Youth & Community Trust. This enhanced publicity both for the Society and for the charity.

There was also a successful all day 'Come & Sing' in January 2024 working with vocal coaches and culminating in a performance of Fauré's Requiem.

The year's highlight was the performance of Mozart's Requiem at the Cadogan Hall which was very well received. After the Summer concert, the choir rounded off the year with its third tour, this time to Bristol, with 65 singing members going.

Membership numbers began exceedingly well at 159, peaked at 170 in the Spring term and then, as is traditional during the Summer term, tailed off a little to end with 154 members. These high numbers have led to a halt in recruitment, except for tenors.

This leaves us well placed well for the coming 2024/25 season.

Financial review


The Society's main source of funds is the income raised by membership subscriptions and ticket sales. Subscriptions are bundled so that they include two free tickets for each concert.

The chief item of expenditure is the cost of hiring musicians for concerts followed by the cost of rehearsals. The Society aims to cover its costs each year and adjusts prices as necessary.

Subscription income and ticket sales, particularly for the Mozart concert, were good which meant a budgeted loss of £11k became a deficit of just £1k despite over £40k being spent on concerts.

The overall unrestricted deficit was £1,025 (2023 - surplus £5,224) taking unrestricted reserves down to £34,671. Total unrestricted income amounted to £57,164 (2023 - £44,593) against unrestricted expenditure of £58,021 (2023 - £39,369).



Achievements and performance

During the year to 31 July 2023 the Society performed four concerts, the first full year since Covid. These were:

12 November 2022: Brahms - Ein Deutsches Requiem and works by Clara Schuman & Fanny Mendelssohn
17 December 2022: Carols, Songs and Readings
1 April 2023: Handel - Dixit Dominus, Durante - Magnificat plus orchestral pieces
1 July 2023: Songs of the Fleet' - works by Vaughan Williams, Stanford and Ireland

This year's music began with Brahms' lyrical Ein Deutsches Requiem followed by two very popular Christmas concerts which raised £1,567.25 for Rape Crisis South London. This enhanced publicity both for the Society and for the charity.

There was also a successful all day 'Come & Sing' in January 2023 working with vocal coaches and culminating in a performance of Rutter's Gloria.

The Spring concert performance of Handel's Dixit Dominus plus orchestral works including Eine Kleine Nachtmusik was very well received. After the Summer concert, the choir rounded off the year with its second tour, this time to Liverpool, with 45 singing members going.

Membership numbers began exceedingly well at 155, remained at that level in the Spring term and then, as is traditional during the Summer term, tailed off a little to end with 134 members.

This leaves us well placed well for the coming 2023/24 season which will include the Mozart Requiem at the Cadogan Hall and a specially commissioned Christmas piece, thanks to a very generous donation.

Financial review


The Society's main source of funds is the income raised by membership subscriptions and ticket sales. Subscriptions are bundled so that they include two free tickets for each concert.

The chief item of expenditure is the cost of hiring musicians for concerts followed by the cost of rehearsals. The Society aims to cover its costs each year and adjusts prices as necessary.

Increased numbers led to a 40% increase in subscription income. This meant a budgeted loss became a surplus despite £15k being spent on concerts.

The overall unrestricted surplus was £5,224 (2022 - surplus £2,301) taking unrestricted reserves up to £35,695. Total unrestricted income amounted to £44,593 (2022 - £37,986) against unrestricted expenditure of £39,369 (2022 - £35,685).

After a year of no concerts, the choir restarted rehearsals in Autumn 2021. During the year to 31 July 2022 the Society performed three concerts, only having to cancel the one Concert at Christmas due to Covid. These were:

13 November 2021: Handel - Zadok the Priest; Haydn - Little Organ Mass; and Vivaldi - Gloria
23 April 2022: Handel - Messiah
2 July 2022: Todd - Mass in Blue and Stay with me, Lord; Coleridge-Taylor - O ye that love the Lord

This year's music began with Vivaldi's uplifting Gloria and ended with the modern and exciting Mass in Blue. The undoubted highlight however, after two year's of postponement, was the performance of Handel's Messiah to a packed audience in the Cadogan Hall.

The choir was able to round off the year with a singing tour to Glasgow with 44 members going.

Membership numbers began very well at 112, peaked for the Cadogan Hall concert at 120 members and then, as is traditional during the summer term, tailed off a little to end with 108 singers.

This bodes well for the coming 2022/23 season.

Financial review


The Society's main source of funds is the income raised by membership subscriptions and ticket sales. Subscriptions are bundled so that they include two free tickets for each concert.

The chief item of expenditure is the cost of hiring players and soloists for concerts followed by regular rehearsal costs. The Society aims to cover its costs each year and adjusts prices as necessary.

Subscriptions returned to pre-Covid levels. This together with the excellent Cadogan Hall ticket sales led to a small surplus on the year.

The overall surplus was £2,301 (2021 - deficit £1,066) taking reserves up to £30,471. Total income amounted to £37,986 (2021 - £3,364) against expenditure of £35,685 (2021 - £4,430).

Notes to the accounts

Accounting policies

(a) Basis of preparation

The accounts have been prepared under the historical cost convention and in accordance with applicable accounting standards, Charities Acts and the Statement of Recommended Practice - Accounting and Reporting by Charities - applicable to charities preparing their accounts in accordance with the Financial Reporting Standard for Smaller Entities (effective 1 January 2015).

(b) Income and expenditure

Total income as shown in the Statement of Financial Activities is the turnover of the charity. It represents the value of concert ticket sales, members' subscriptions and donations receivable in the ordinary course of activities.

Voluntary income received by way of donations and gifts to the charity is included in full in the Statement of Financial Activities when received.

Costs of raising funds comprise those operational costs directly attributable to promotional activities and the running of raffles and refreshments.

Charitable activities include the costs of termly rehearsals, the staging of concerts and termly events.

Governance costs are those incurred in connection with the running of the Society as opposed to its charitable activity.

(c) Concerts and other fund-raising events

Each event is separately identified and all relevant income and expenditure allocated thereto.

(d) Restricted and unrestricted Funds

Restricted funds are to be used for specific purposes as laid down by the donors. Expenditure which meets this criterion is allocated to a restricted fund.

Unrestricted funds are donations and other income received or raised for the charity's purposes.

Committee members' expenses

Committee members are not paid. Members are reimbursed for expenses they properly incur on behalf of the Society.

Taxation

All the Society's trading activities are exercised in carrying out its primary charitable purposes, and any resulting profits are applied for these purposes. Accordingly these profits are exempt from taxation under Section 505 of the Income and Corporation Taxes Act 1988.
