REPORT OF THE TRUSTEES

YEAR ENDED 31 MARCH 2022

The trustees present their annual report and the financial statements of the charity for the year ended 31 March 2022, which have been prepared in accordance with the Governing Document. The trustees confirm they comply with the requirements of the Charities Act 2011 and the Charities SORP (FRS102).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The main objects of the Charity are to support and assist The Higgins Bedford and to promote its use and enjoyment by the public.

The Trustees confirm that they have referred to the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and in planning future activities and setting policy for the year.

FINANCIAL REVIEW

Monies held at the bank at 31 March 2022 amounted to £23,128 as unrestricted funds. Events and lectures are self-supporting and although the Covid pandemic has resulted in the cancellation of later events, there has been no loss to the Charity.

The restricted fund of £10,538 is held to support improvements to The Higgins Bedford. During the year £4,968 was expended on the conservation of paintings.

STRUCTURE, GOVERNANCE & MANAGEMENT

Governing document

The Charity is an unincorporated association set up with a governing document 15 June 1989. A new governing document was adopted 8 May 2012.

Trustees are appointed or reappointed annually at the Annual General Meeting normally held in May.

YEAR ENDED 31 MARCH 2022

I report on the accounts for the year ended 31 March 2022 set out on pages 4 to 6.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year (under Section 144(2) of the Charities Act 2011 (the 2011 Act)) and that an independent examination is required.

YEAR ENDED 31 MARCH 2022

1. ACCOUNTING POLICIES

Accounting convention

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Incoming resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees. Restricted funds can only be used for particular purposes.

Covid-19

Having assessed the potential impact, the trustees have provided their service to members by adopting educational zoom meetings instead of the former regular face to face meetings.
