Funding beyond 2025/26 is not yet determined but budgets are tighter than ever going forward.</p> <p>The trust is also likely to be asked to support a large capital project being planned to provide a new studio for pupils and other additional facilities. Planning permission had originally been granted for a slightly larger project so an amendment has been submitted and budget costings are being prepared.</p>

Of the total income £472,244 was from donations including gift aid. Grants of £248,710 were paid to South Farnham Educational Trust. This is a similar level to last year.
