The Trustees have met once in the Jan – Dec 2025 year and have had regard to the guidance issued by the Charity Commission on public benefit.

### **3. Financial review**


The Charity's reserves are held as cash, currently deposited with Barclays Bank and the United Trust Bank. The opening balance of total cash assets as at January 1<sup>st</sup> 2025 was £81,951.16 and the closing balance on December 31<sup>st</sup> 2025 was £136,200.42. There was a 'net' increase in reserves during the year of £50,249.26.

The Charity aims to maintain sufficient reserves to fulfil ongoing commitments and to develop further activities according to its Charitable aims.

In connection with my examination, no matter has come to my attention:


1. which gives me reasonable cause to believe that in, any material respect, the requirements
