### **Trustees' Report**

The Trustees present the Trustee's Report and Financial Statements for the period from 1<sup>st</sup> October 2020 to 30<sup>th</sup> September 2021.

The accounts have been prepared in accordance with the accounting policies and comply with the charity's constitution and applicable law. (Financial year runs 1<sup>st</sup> October to 30<sup>th</sup> September)

## **Structure, Governance and Management**

Knodishall Village Hall was registered as a Charitable Incorporated Organisation (CIO) on 15<sup>th</sup> June 1990 and is governed by a Scheme registered on 8<sup>th</sup> February 1990.

Trustees are elected at each Annual General Meeting to serve until the close of the next Annual General Meeting and are eligible for re-election.

Additional Trustees may be co-opted at general meetings during the year.

## **Objectives and Activities**

The object of Knodishall Village Hall charity shall be the provision and maintenance of the village hall for the use of the inhabitants of the Parish of Knodishall without distinction of political, religious, or other options, including use for meetings, lectures and classes, and for other forms of recreation and leisure-time occupation, with the object of improving the conditions of the said inhabitants.

## **Achievements and Performance**

Due to Covid restrictions the hall didn't reopen to hirers until 17<sup>th</sup> May 2021, although arrangements were made to facilitate polling day on 6<sup>th</sup> May 2021.

We maintained Covid restrictions and procedures; these were adjusted as and when according to advice given from Community Action Suffolk/Government.

During the closure Mrs Haxell organised and ran the Government Furlough Scheme to cover 80% of our Caretakers wages. A huge thanks to Mrs Haxell for all of the work relating to this.

Once the hall reopened the initial uptake was limited to Yoga, Thai-chi and Art classes. As the year progressed lettings increased but are nowhere near pre-pandemic take up.

During the year our maintenance work and routine checks have continued.

The Trustees have continued their hard work to ensure that the hall continues to function well. There are so many tasks for the Trustees to complete during the year and I feel sure that many in the village are unaware of what goes on behind the running of our hall.

I wish to extend my thanks to all of the Trustees for their help and hard work in, what has been, an especially difficult time for us all.

## **Financial Review**

The Trustees are responsible for keeping proper accounting records, which disclose with reasonable accuracy at any time the financial position of the Village Hall. The Trustees are also responsible for safeguarding the assets of the Village Hall and for taking reasonable steps for the prevention and detection of fraud and other irregularities. The Village Hall finances itself by a number of methods:

1. Fund raising, including lottery, bingo, quizzes
2. Hiring fees for activities organised by local organisations including exercise classes, art classes, dance, bowling, brownies, meetings, and polling station
3. Hiring fees from individuals for private gatherings
4. Donations, and in some cases gift aid on those donations.

The Village Hall's direct income is used to cover the cost of maintenance of the hall.

We started the year in October 2020 under the rule of 6 Covid restrictions, followed by the second lockdown in November and, with a brief respite, entered into a third lockdown in February which continued until 19<sup>th</sup> July 2021. This has meant that the hall has only been open for about 3 months and activities severely restricted.

Bookings were well down on previous years, only yielding £1,284. Other fundraising events could not take place.

We were able to run the 300 club, raising £1,616 and with Barclays matched funding raised a total of £2,446. Most of the costs of the 300 club will fall into the next financial year, but most of last year's costs are shown in the current year, giving a net profit of £1,641.

Knodishall Parish Council gave a donation of £150 and other donations received of £861. These donations were used to purchase a new entrance carpet.

Regular expenses continued, amounting to £9,241, but fortunately we were able to benefit from the job retention scheme receiving £1,940 and received another two Covid Grants (as we are a community hall) amounting to £18,708

Our costs in the coming year are likely to rise due to inflation, wage increases and the massive rise in energy costs. Hiring charges should be reviewed in order to avoid a loss in the next year.

The hall is in good shape and bookings are building back up.

Income for the period from 1<sup>st</sup> October 2020 to 30<sup>th</sup> September 2021 totalled £25,438.19

Expenditure amounted to £11,468.17

Surplus for the year was £13,970.02

On 30<sup>th</sup> September 2021, the Village Hall had a cash balance of £34,541.81 held in the following accounts:


