The Churchwardens are trustees as long as they remain Churchwardens and the Parish/Town Council Trustees are appointed by their respective councils for four years. The other trustees appoint the Co-optative Trustees for a term of five years. The vicar of Malborough Parish Church is the final Trustee and as is normal practice of the trustees, takes the role as Chairman.

The object of the charity is to provide funds for the upkeep of Malborough Parish Church and to provide benefit to poor persons living in the former Ancient Parish of Malborough; this includes the modern Parish of Salcombe, via The Church Lands Charity and The Parish Lands Charity respectively. The Parish Lands Educational Foundation objective is to provide benefit towards the education of persons who have not attained the age of twenty five years and are resident in the beneficial area.

The Charity's income is from investments made with the Charities Official Investment Fund (COIF) and from rent received from the Charity's last remaining cottage, Landscope.

It is the policy of the charity to maintain funds to provide sufficient funds to cover management, administration and support costs and to respond to applications for grants which may arise. The trustees have examined the operational risks which the charity faces and confirm that systems have been established to enable steps to be taken to lessen those risks.

Independent Examiner's report to the Trustees of the Estate Charity

I report on the Accounts of the Trust for the year ended 28 February 2023 which are set out on pages 3 to 5.

Respective responsibilities of Trustees and Examiner

The Charity's trustees are responsible for the preparation of the accounts. The Charity's trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed

Basis of independent Examiner's statement
