**DIRECTORS' ANNUAL REPORT**  
For the year ended 31 March 2025

The Directors present their Directors' Annual Report, combining the Directors' Report and Trustees' Report, and the unaudited financial statements for the year ended 31 March 2025.

The financial statements are prepared in accordance with the Companies Act 2006, FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and Accounting and Reporting by Charities Statement of Recommended Practice applicable to charities preparing their financial statements in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

The Directors' Report contains the information required to be provided in the Directors' Annual Report under the Statement of Recommended Practice (SORP) guidelines. The directors of the company are also charity trustees for the purpose of charity law and under the company's constitution are known as members of the board of trustees.

In this report the directors of Fermanagh Rural Community Network present a summary of its purpose, governance, activities, achievements and finances for the financial year 31 March 2025.

The company is a registered charity and hence the report and results are presented in a form which complies with the requirements of the Companies Act 2006 and, although not obliged to comply with the statement of Recommended Practice applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015), the organisation has implemented its recommendations where relevant in these financial statements.

### **Missions, Objectives and Strategy**

#### **Mission Statement**

Fermanagh Rural Community Network provides practical support, guidance, information, signposting and networking opportunities for member groups, through our locally based staff, resource centre and network services and programmes. This benefits rural community groups in developing sustainable rural communities, directly tackling issues that are causing disadvantage and poverty.

#### **Objectives**

The objectives of the Company shall be to relieve poverty and advance education for the benefit of the inhabitants of Fermanagh and its hinterland without distinction of sex, race or political, religious or other opinion and in particular to promote any charitable activity which give support to the local rural communities suffering disadvantage and poverty and which seeks to improve the conditions of life for the inhabitants of the area of benefit.

### **Structure, Governance and Management**

#### **Structure**

Fermanagh Rural Community Network is a company limited by guarantee not having a share capital. The company is governed by its Memorandum and Articles of Association. The directors, who are also the trustees of the charity at the date of this report and those who served during the financial year together with the dates of any changes are set out on page 5.

Fermanagh Rural Community Network has a Resource Centre and Staffed Office maintained with a Network Coordinator, Community Development Worker, Administrator and Community Development Officer.

**Review of Activities, Achievements and Performance**

Fermanagh Rural Community Network in its role as the Local Rural Support Network for County Fermanagh delivered the following key community development support activities to positively benefit and sustain County Fermanagh's rural communities over the year.

- 76 Full Member Groups and 75 Associate Member Groups.
  - 10 Network Management Committee Meetings.
  - Developing Group Capacity and Projects - 800+ Member Group support requests including development and governance assistance, responded to during the year.
  - 8 Member Group Support & Advice Workshops/ Information/ Consultation events.
  - Facebook, Twitter, and Website updated regularly, and information updates circulated.
  - Network representation on twenty strategic/theme-based partnerships
  - FRCN and Omagh Forum for Rural are working in partnership to deliver the 'DAERA Local Rural Community Development Support Service Programme' contract for the Fermanagh and Omagh District Council area, with key areas of work being under the following identified themes:
    - Support for Community Planning
    - Support for isolated Rural People
    - Support for the sustainability of Rural Villages
    - Marginalised minority communities in rural border areas
- This contract, funded by Department of Agriculture, Environment and Rural Affairs (DAERA), through the Tackling Rural Poverty and Social Isolation (TRPSI) Programme Framework, commenced on 1st November 2023.
- FRCN and Omagh Forum for Rural Associations worked in partnership to deliver the DAERA Rural Micro Capital Grant Scheme 2024/2025. Over Tranche 1 and 2 of this scheme, 386 applicants from across the rural communities of Fermanagh & Omagh District received grant aid payments of £627,092.70
  - FRCN continued strategic partnership with Lakeland Community Care Limited to deliver and expand the range of healthy living, social engagement, and community relations projects, delivered within and from Belcoo Healthy Living Centre.
  - FRCN have a Start Here Programme Grant from The Rank Foundation which is being used for employment of a Community Development Officer. The Department of Communities (DfC) provide the funding for the Start Here Programme Grant awards under their Covid Employment and Skills Initiative.
  - *FRCN in partnership with Lakeland Community Care Limited; Erne East Community Partnership-OAK Healthy Living Centre; ARC Healthy Living Centre; The Courthouse Kesh Limited; Omagh Forum for Rural Associations delivered 'Poverty Support Programme' that was operated under the working title of 'WRAP-Western Response & Action on Poverty' for Fermanagh and Omagh District Council.*

*The WRAP Programme operated over period October 2024 to March 2025 during which 204 Households comprising 656 Individuals from across the entire Fermanagh and Omagh District received an Individual Personalised Tailored Plan of support that assisted their household in becoming better off in terms of food security, fuel provision and income level. £64,000 was provided in direct financial support through vouchers for food and essential items. Through the Bryson Care Emergency Relief Fund direct financial support of £24,400 was provided to 122 participating households in the form of £200 electricity top-up credits.*

- FRCN received funding from the Northern Ireland Housing Executive Housing under their Sustaining Tenancies Funding Programme to deliver the 'Erne West Sustaining Tenancies Project' that supported 66 NIHE tenant households in the Erne West Area with a range of actions that have the overall aim of increasing their levels of social interaction and wellbeing over the two-year time period July 2022 to June 2024.
- FRCN managed the Screggagh Windfarm Community Benefit Fund in which 27 eligible community & voluntary organisations received donations totalling £57,070.00
- FRCN are a Registered Helper Group with the Charity Commission for Northern Ireland, advise and support those groups registering as a charity and assist registered charities with their annual reporting and compliance.
- FRCN have promoted the Community Planning process for the Fermanagh and Omagh District, are members of the Community Voluntary Sector Forum and Community Planning Strategic Partnership Board.
- FRCN are a member group of Fermanagh & Omagh Interagency Forum for Older People facilitated by South West Age Partnership that comprises of a community, voluntary and statutory organisations.
- FRCN are supporting and have representation as social partners on Fermanagh and Omagh PEACEPLUS Partnership which has been established to oversee the effective development and implementation of a Local Community Peace Action Plan. The partnership is representative of communities across the district and includes Councillors, Social Partners, and Statutory Representatives.
- FRCN are members of Fermanagh and Omagh District Council's Agricultural Liaison Group that undertakes liaison with and makes representation to the relevant bodies and agencies on behalf of the rural communities of the district.
- FRCN are members of and have Board representatives on Rural Community Network NI the regional voluntary organisation that articulates the voice of rural communities on issues relating to poverty, disadvantage, and equality.
- FRCN were a partner organisation on The Lough Erne Landscape Partnership (LELP) programme which ran for 6 years from January 2019 – December 2024. Funded by The National Lottery Heritage Fund, the programme focus was to promote and preserve the unique built, natural and cultural heritage of Lough Erne and the people who surround it. The programme was led by RSPB NI, and other partners included Fermanagh and Omagh District Council, Lough Erne Heritage, National Trust, Upper Lough Erne Region and Waterways Ireland.
- FRCN organise the Annual Community Achievement Awards and Networking Event recognising achievements of local Groups and Individuals. This event with the FRCN Annual General Meeting promotes and celebrates the extensive levels of voluntary community activity taking place throughout County Fermanagh.
- Fermanagh Rural Community Network Trustees have considered Charity Commission for Northern Ireland's general guidance on public benefit when reviewing its objectives and in planning its future activities to ensure that these achieve the networks purposes and provide a benefit to beneficiaries.

**Financial Review**

Fermanagh Rural Community Network is non-profit making with income in excess of expenditure of £45,707. The trustees and staff continue to manage resources in an efficient and sustainable manner.

**Financial Results**

In so far as the directors are aware:


- there is no relevant information (information needed by the charity's independent examiner in connection with preparing the independent examiners report) of which the charity's independent examiner is unaware and

**INDEPENDENT EXAMINER'S REPORT TO THE BOARD OF DIRECTORS  
OF FERMANAGH RURAL COMMUNITY NETWORK**

We have examined the financial statements of the company for the year ended 31 March 2025, which comprise the Statement of Financial Activities, the Summary Income and Expenditure Accounts, the Balance Sheet and the related notes.

**NOTES TO THE FINANCIAL STATEMENTS**

for the year ended 31 March 2025

**1. GENERAL INFORMATION**

Fermanagh Rural Community Network is a company limited by guarantee not having a share capital incorporated in Northern Ireland. The registered office of the company is 3 Queen Street, Enniskillen, Co. Fermanagh, BT74 7JR which is also the principle place of business of the company. The financial statements have been presented in Pound Sterling (£) which is also the functional currency of the company.

**2. ACCOUNTING POLICIES**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the charity's financial statements.

**Basis of Preparation**





This contract, funded by Department of Agriculture, Environment and Rural Affairs (DAERA), through the Tackling Rural Poverty and Social Isolation (TRPSI) Programme Framework, commenced on 1st November 2023.

- FRCN in partnership with Lakeland Community Care Limited; Erne East Community Partnership-OAK Healthy Living Centre; ARC Healthy Living Centre; The Courthouse Kesh Limited; Omagh Forum for Rural Associations delivered 'The Food Poverty – Financial and Wraparound Support Programme' that was operated under the working title of 'WRAP-Western Response & Action on Poverty' for Fermanagh and Omagh District Council. The WRAP Programme operated over timeframe November 2023 to March 2024 and 143 Households from across the entire Fermanagh and Omagh District received an Individual Personalised Tailored Plan of support that assisted their household in becoming better off in terms of food security, fuel provision and income level.

- FRCN managed the Screggagh Windfarm Community Benefit Fund in which twenty-nine eligible community & voluntary organisations received donations totalling £59,923.

- FRCN are a Registered Helper Group with the Charity Commission for Northern Ireland and advise and support those groups undergoing charity registration charities with their annual reporting.

- FRCN have promoted the Community Planning process for the Fermanagh and Omagh District, are members of the Community Voluntary Sector Forum and Community Planning Strategic Partnership Board.

This event with the FRCN Annual General Meeting promotes and celebrates the extensive levels of voluntary community activity taking place throughout County Fermanagh.

**Review of Activities, Achievements and Performance**

Fermanagh Rural Community Network in its role as the Local Rural Support Network for County Fermanagh delivered the following key community development support activities to positively benefit and sustain County Fermanagh's rural communities over the year.

- 71 Full Member Groups and 75 Associate Member Groups.
- 10 Network Management Committee Meetings.
- Developing Group Capacity and Projects - 800+ Member Group support requests including development assistance, funding information & project grant application assistance responded to during the year.
- 4 Member Group Support & Advice Workshops/ Information/ Consultation events.
- Facebook, Twitter, and Website updated regularly, and information updates circulated.
- Network representation on twenty strategic/theme-based partnerships

**1. GENERAL INFORMATION**

Fermanagh Rural Community Network is a company limited by guarantee not having a share capital incorporated in Northern Ireland. The registered office of the company is 3 Queen Street, Enniskillen, Co. Fermanagh, BT74 7JR which is also the principle place of business of the company. The financial statements have been presented in Pound Sterling (£) which is also the functional currency of the company.

**2. ACCOUNTING POLICIES**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the charity's financial statements.

**Basis of Preparation**

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006 and Part 8 of the Charities Act (Northern Ireland) 2008. They also comply with the Statement of Recommended Practice (SORP 2005, as updated in 2008) and with the financial reporting standards. The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

**Statement of compliance**

The financial statements of the company for the year ended 31 March 2024 have been prepared on the going concern basis and in accordance with the Statement of Recommended Practice (SORP) 'Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)' and FRS102 'The Financial Reporting Standard applicable in the UK and Republic', applying Section 1A of that Standard.

**Cash flow statement**

The company has availed of the exemption in FRS102 from the requirement to produce a cash flow statement because it is classified as a small company.

**Incoming Resources**

Voluntary income or capital is included in the Statement of Financial Activities when the company is legally entitled to it, its financial value can be quantified with reasonable certainty and there is reasonable certainty of its ultimate receipt. Entitlement to legacies is considered established when the company has been notified of a distribution to be made by the executors. Income received in advance of due performance under a contract is accounted for as deferred income until earned. Grants for activities are recognised as income when the related conditions for legal entitlement have been met. All other income is accounted for on an accruals basis.

**Resources Expended**

All resources expended are accounted for on an accruals basis. Charitable activities include costs of services and grants, support costs and depreciation on related assets. Costs of generating funds similarly include fundraising activities. Non-staff costs not attributed to one category of activity are allocated of apportioned pro-rata to the staffing of the relevant service. Finance, HR, IT and administrative staff costs are directly attributable to individual activities by objective. Governance costs are those associated with constitutional and statutory requirements.

**Tangible fixed assets and depreciation**

Tangible fixed assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible fixed assets, less their estimated residual value, over their expected useful lives as follows:-





This contract, funded by Department of Agriculture, Environment and Rural Affairs (DAERA), through the Tackling Rural Poverty and Social Isolation (TRPSI) Programme Framework, commenced on 1st November 2023.

- FRCN in partnership with Lakeland Community Care Limited; Erne East Community Partnership-OAK Healthy Living Centre; ARC Healthy Living Centre; The Courthouse Kesh Limited; Omagh Forum for Rural Associations delivered 'The Food Poverty – Financial and Wraparound Support Programme' that was operated under the working title of 'WRAP-Western Response & Action on Poverty' for Fermanagh and Omagh District Council. The WRAP Programme operated over timeframe November 2023 to March 2024 and 143 Households from across the entire Fermanagh and Omagh District received an Individual Personalised Tailored Plan of support that assisted their household in becoming better off in terms of food security, fuel provision and income level.

- FRCN managed the Screggagh Windfarm Community Benefit Fund in which twenty-nine eligible community & voluntary organisations received donations totalling £59,923.

- FRCN are a Registered Helper Group with the Charity Commission for Northern Ireland and advise and support those groups undergoing charity registration charities with their annual reporting.

- FRCN have promoted the Community Planning process for the Fermanagh and Omagh District, are members of the Community Voluntary Sector Forum and Community Planning Strategic Partnership Board.

- FRCN are a member group of Fermanagh & Omagh Interagency Forum for Older People facilitated by South West Age Partnership and comprises of a community, voluntary and statutory organisations.

This event with the FRCN Annual General Meeting promotes and celebrates the extensive levels of voluntary community activity taking place throughout County Fermanagh.

Fermanagh Rural Community Network in its role as the Local Rural Support Network for County Fermanagh delivered the following key community development support activities to positively benefit and sustain County Fermanagh's rural communities over the year.

- 71 Full Member Groups and 75 Associate Member Groups.
- 10 Network Management Committee Meetings.
- Developing Group Capacity and Projects - 800+ Member Group support requests including development assistance, funding information & project grant application assistance responded to during the year.
- 4 Member Group Support & Advice Workshops/ Information/ Consultation events.
- Facebook, Twitter, and Website updated regularly, and information updates circulated.
- Network representation on twenty strategic/theme-based partnerships

**1. GENERAL INFORMATION**

Fermanagh Rural Community Network is a company limited by guarantee not having a share capital incorporated in Northern Ireland. The registered office of the company is 3 Queen Street, Enniskillen, Co. Fermanagh, BT74 7JR which is also the principle place of business of the company. The financial statements have been presented in Pound Sterling (£) which is also the functional currency of the company.

**2. ACCOUNTING POLICIES**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the charity's financial statements.

**Basis of Preparation**

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006 and Part 8 of the Charities Act (Northern Ireland) 2008. They also comply with the Statement of Recommended Practice (SORP 2005, as updated in 2008) and with the financial reporting standards. The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

**Statement of compliance**

The financial statements of the company for the year ended 31 March 2024 have been prepared on the going concern basis and in accordance with the Statement of Recommended Practice (SORP) 'Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)' and FRS102 'The Financial Reporting Standard applicable in the UK and Republic', applying Section 1A of that Standard.

**Cash flow statement**

The company has availed of the exemption in FRS102 from the requirement to produce a cash flow statement because it is classified as a small company.

**Incoming Resources**

Voluntary income or capital is included in the Statement of Financial Activities when the company is legally entitled to it, its financial value can be quantified with reasonable certainty and there is reasonable certainty of its ultimate receipt. Entitlement to legacies is considered established when the company has been notified of a distribution to be made by the executors. Income received in advance of due performance under a contract is accounted for as deferred income until earned. Grants for activities are recognised as income when the related conditions for legal entitlement have been met. All other income is accounted for on an accruals basis.

**Resources Expended**

All resources expended are accounted for on an accruals basis. Charitable activities include costs of services and grants, support costs and depreciation on related assets. Costs of generating funds similarly include fundraising activities. Non-staff costs not attributed to one category of activity are allocated of apportioned pro-rata to the staffing of the relevant service. Finance, HR, IT and administrative staff costs are directly attributable to individual activities by objective. Governance costs are those associated with constitutional and statutory requirements.

**Tangible fixed assets and depreciation**

Tangible fixed assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible fixed assets, less their estimated residual value, over their expected useful lives as follows:-





This contract, funded by Department of Agriculture, Environment and Rural Affairs (DAERA), through the Tackling Rural Poverty and Social Isolation (TRPSI) Programme Framework, commenced on 1st November 2023.

- FRCN in partnership with Lakeland Community Care Limited; Erne East Community Partnership-OAK Healthy Living Centre; ARC Healthy Living Centre; The Courthouse Kesh Limited; Omagh Forum for Rural Associations delivered 'The Food Poverty – Financial and Wraparound Support Programme' that was operated under the working title of 'WRAP-Western Response & Action on Poverty' for Fermanagh and Omagh District Council. The WRAP Programme operated over timeframe November 2023 to March 2024 and 143 Households from across the entire Fermanagh and Omagh District received an Individual Personalised Tailored Plan of support that assisted their household in becoming better off in terms of food security, fuel provision and income level.

- FRCN managed the Screggagh Windfarm Community Benefit Fund in which twenty-nine eligible community & voluntary organisations received donations totalling £59,923.

- FRCN are a Registered Helper Group with the Charity Commission for Northern Ireland and advise and support those groups undergoing charity registration charities with their annual reporting.

- FRCN have promoted the Community Planning process for the Fermanagh and Omagh District, are members of the Community Voluntary Sector Forum and Community Planning Strategic Partnership Board.

Fermanagh Rural Community Network in its role as the Local Rural Support Network for County Fermanagh delivered the following key community development support activities to positively benefit and sustain County Fermanagh's rural communities over the year.

- 71 Full Member Groups and 75 Associate Member Groups.
- 11 Network Management Committee Meetings.
- Developing Group Capacity and Projects - 800+ Member Group support requests including development assistance, funding information & project grant application assistance responded to during the year.
- 4 Member Group Support & Advice Workshops/ Information/ Consultation events.
- Facebook, Twitter, and Website updated regularly, and information updates circulated.
- Network representation on twenty strategic/theme-based partnerships
- FRCN continued strategic partnership with Lakeland Community Care Limited to deliver and expand the range of healthy living, social engagement, and community relations projects, delivered within and from Belcoo Healthy Living Centre.

- FRCN are supporting and have representation on *Fermanagh and Omagh PEACEPLUS Partnership* which has been established to oversee the effective development and implementation of a *Local Community Peace Action Plan*. The Partnership formed in June 2022 is representative of communities across the district and includes Councilors, Social Partners and Statutory Representatives.
- FRCN are members of Fermanagh and Omagh District Council's Agricultural Liason Group that undertakes liaison with and makes representation to the relevant bodies and agencies on behalf of the rural communities of the district.



**Basis of independent examiner's report**





**1. GENERAL INFORMATION**

Fermanagh Rural Community Network is a company limited by guarantee not having a share capital incorporated in Northern Ireland. The registered office of the company is 3 Queen Street, Enniskillen, Co. Fermanagh, BT74 7JR which is also the principle place of business of the company. The financial statements have been presented in Pound Sterling (£) which is also the functional currency of the company.

**2. ACCOUNTING POLICIES**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the charity's financial statements.

**Basis of Preparation**

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006 and Part 8 of the Charities Act (Northern Ireland) 2008. They also comply with the Statement of Recommended Practice (SORP 2005, as updated in 2008) and with the financial reporting standards. The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

**Statement of compliance**

The financial statements of the company for the year ended 31 March 2023 have been prepared on the going concern basis and in accordance with the Statement of Recommended Practice (SORP) 'Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)' and FRS102 'The Financial Reporting Standard applicable in the UK and Republic', applying Section 1A of that Standard.

**Cash flow statement**

The company has availed of the exemption in FRS102 from the requirement to produce a cash flow statement because it is classified as a small company.

**Incoming Resources**

Voluntary income or capital is included in the Statement of Financial Activities when the company is legally entitled to it, its financial value can be quantified with reasonable certainty and there is reasonable certainty of its ultimate receipt. Entitlement to legacies is considered established when the company has been notified of a distribution to be made by the executors. Income received in advance of due performance under a contract is accounted for as deferred income until earned. Grants for activities are recognised as income when the related conditions for legal entitlement have been met. All other income is accounted for on an accruals basis.

**Resources Expended**

All resources expended are accounted for on an accruals basis. Charitable activities include costs of services and grants, support costs and depreciation on related assets. Costs of generating funds similarly include fundraising activities. Non-staff costs not attributed to one category of activity are allocated or apportioned pro-rata to the staffing of the relevant service. Finance, HR, IT and administrative staff costs are directly attributable to individual activities by objective. Governance costs are those associated with constitutional and statutory requirements.

**Tangible fixed assets and depreciation**

Tangible fixed assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible fixed assets, less their estimated residual value, over their expected useful lives as follows:-

**Debtors**

Debtors are recognised at the settlement amount due after any discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due. Income recognised by the company from government agencies and other co-funders, but not yet received at year ended, is included in debtors.

Cash at bank and in hand comprises cash on deposit at banks requiring less than three months notice withdrawal.

**Taxation and deferred taxation**

No current or deferred taxation arises as the company has been granted charitable exemption. Irrecoverable valued added tax is expensed as incurred.

The Directors/Trustees confirm that it is appropriate to prepare the financial statements on a going concern basis. The financial statements do not include any adjustments that would result if the going concern basis was not appropriate.

The Directors present their Directors' Annual Report, combining the Directors' Report and Trustees' Report, and the unaudited financial statements for the year ended 31 March 2023.

The financial statements are prepared in accordance with the Companies Act 2006, FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and Accounting and Reporting by Charities Statement of Recommended Practice applicable to charities preparing their financial statements in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

### **Missions, Objectives and Strategy**

#### **Mission Statement**

Fermanagh Rural Community Network provides practical support, guidance, information, signposting and networking opportunities for member groups, through our locally based staff, resource centre and network services and programmes. This benefits rural community groups in developing sustainable rural communities, directly tackling issues that are causing disadvantage and poverty.

#### **Objectives**

The objectives of the Company shall be to relieve poverty and advance education for the benefit of the inhabitants of Fermanagh and its hinterland without distinction of sex, race or political, religious or other opinion and in particular to promote any charitable activity which give support to the local rural communities suffering disadvantage and poverty and which seeks to improve the conditions of life for the inhabitants of the area of benefit.

### **Structure, Governance and Management**

#### **Structure**

Fermanagh Rural Community Network is a company limited by guarantee not having a share capital. The company is governed by its Memorandum and Articles of Association. The directors, who are also the trustees of the charity at the date of this report and those who served during the financial year together with the dates of any changes are set out on page 3.

**Review of Activities, Achievements and Performance**

Fermanagh Rural Community Network in its role as the Local Rural Support Network for County Fermanagh delivered the following key community development support activities to positively benefit and sustain County Fermanagh's rural communities over the year.

- 71 Full Member Groups and 75 Associate Member Groups.
- 11 Network Management Committee Meetings.
- Developing Group Capacity and Projects - 800+ Member Group support requests including development assistance, funding information & project grant application assistance responded to during the year.
- 4 Member Group Support & Advice Workshops/ Information/ Consultation events.
- Facebook, Twitter, and Website updated regularly, and information updates circulated.
- Network representation on twenty strategic/theme-based partnerships
- FRCN continued strategic partnership with Lakeland Community Care Limited to deliver and expand the range of healthy living, social engagement, and community relations projects, delivered within and from Belcoo Healthy Living Centre.
- FRCN have received funding from the Northern Ireland Housing Executive under their Sustaining Tenancies Funding Programme to deliver the Erne West Sustaining Tenancies Project that is supporting NIHE tenants living in the Erne West Area with a range of actions that have the overall aim of increasing their levels of social interaction and wellbeing.
- FRCN working in collaboration with Lakeland Community Care Limited have a contract to deliver the 'The *SPRING Rural Enhanced Social Prescribing Project (SREP)*', focusing on the communities in Erne West District Electoral Area of County Fermanagh. This project is a collaborative partnership project led by Derg Valley Care Healthy Living Centre on behalf of the Healthy Living Centre Alliance (HLCA) to deliver social prescriptions in local communities across Northern Ireland. The rural enhanced project is funded by the Department of Agriculture, Environment and Rural Affairs (DAERA).
- FRCN have been awarded a *Start Here Programme Grant* from *The Rank Foundation* which is being used for employment of a new Community Development Officer for three years. *The Department of Communities (DfC)* provide the funding for the Start Here Programme Grant awards under their *Covid Employment and Skills Initiative*.
- FRCN managed the *Screggagh Windfarm Community Benefit Fund* in which twenty-eight eligible community & voluntary organisations received donations totalling £48,197.00.
- FRCN are a Registered Helper Group with the *Charity Commission for Northern Ireland* and advise and support those groups undergoing charity registration charities with their annual reporting.
- FRCN have promoted the *Community Planning process for the Fermanagh and Omagh district*, are members of the *Community Voluntary Sector Forum and Community Planning Strategic Partnership Board*.
- FRCN are a member group of *Fermanagh & Omagh Interagency Forum for Older People* facilitated by South West Age Partnership and comprises of a community, voluntary and statutory organisations.
- FRCN are a partner organisation on *Lough Erne Landscape Partnership*, which has the aim of reconnecting local people with their Lough Erne Landscape and its built, natural & cultural history and heritage.
- FRCN supported the *2014-2020 Rural Development Programme* through working with *Fermanagh and Omagh Local Action Group*, promoting funding opportunities available to local groups and businesses.

- FRCN are supporting and have representation on *Fermanagh and Omagh PEACEPLUS Partnership* which has been established to oversee the effective development and implementation of a *Local Community Peace Action Plan*. The Partnership formed in June 2022 is representative of communities across the district and includes Councilors, Social Partners and Statutory Representatives.
- FRCN are members of Fermanagh and Omagh District Council's Agricultural Liason Group that undertakes liaison with and makes representation to the relevant bodies and agencies on behalf of the rural communities of the district.
- FRCN are members of and have been Board representation on *Rural Community Networks NI* the regional voluntary organisation that articulates the voice of rural communities on issues relating to poverty, disadvantage, and equality.
- FRCN organise the Annual Community Achievement Awards and Networking Event recognising achievements of local Groups and Individuals. This event with the FRCN Annual General Meeting promotes and celebrates the extensive levels of voluntary community activity taking place throughout County Fermanagh.

Fermanagh Rural Community Network Trustees have considered Charity Commission for Northern Ireland's general guidance on public benefit when reviewing its objectives and in planning its future activities to ensure that these achieve the networks purposes and provide a benefit to beneficiaries.

**Financial Review**

Fermanagh Rural Community Network is non-profit making with income in excess of expenditure of £4,513. The trustees and staff continue to manage resources in an efficient and sustainable manner.

**Financial Results**

At the end of the year the company has assets of £ 145,709 (2022 - £134,464) and liabilities of £ 61,431 (2022 - £54,700). The net assets of the company have increased by £ 4,514 .

In so far as the directors are aware:



**Basis of independent examiner's report**



**NOTES TO THE FINANCIAL STATEMENTS**

for the year ended 31 March 2023

**1. GENERAL INFORMATION**

Fermanagh Rural Community Network is a company limited by guarantee not having a share capital incorporated in Northern Ireland. The registered office of the company is 3 Queen Street, Enniskillen, Co. Fermanagh, BT74 7JR which is also the principle place of business of the company. The financial statements have been presented in Pound Sterling (£) which is also the functional currency of the company.

**2. ACCOUNTING POLICIES**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the charity's financial statements.

**Basis of Preparation**

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006 and Part 8 of the Charities Act (Northern Ireland) 2008. They also comply with the Statement of Recommended Practice (SORP 2005, as updated in 2008) and with the financial reporting standards. The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

**Statement of compliance**

The financial statements of the company for the year ended 31 March 2023 have been prepared on the going concern basis and in accordance with the Statement of Recommended Practice (SORP) 'Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)' and FRS102 'The Financial Reporting Standard applicable in the UK and Republic', applying Section 1A of that Standard.

**Cash flow statement**

The company has availed of the exemption in FRS102 from the requirement to produce a cash flow statement because it is classified as a small company.

**Incoming Resources**

Voluntary income or capital is included in the Statement of Financial Activities when the company is legally entitled to it, its financial value can be quantified with reasonable certainty and there is reasonable certainty of its ultimate receipt. Entitlement to legacies is considered established when the company has been notified of a distribution to be made by the executors. Income received in advance of due performance under a contract is accounted for as deferred income until earned. Grants for activities are recognised as income when the related conditions for legal entitlement have been met. All other income is accounted for on an accruals basis.

**Resources Expended**

All resources expended are accounted for on an accruals basis. Charitable activities include costs of services and grants, support costs and depreciation on related assets. Costs of generating funds similarly include fundraising activities. Non-staff costs not attributed to one category of activity are allocated or apportioned pro-rata to the staffing of the relevant service. Finance, HR, IT and administrative staff costs are directly attributable to individual activities by objective. Governance costs are those associated with constitutional and statutory requirements.

**Tangible fixed assets and depreciation**

Tangible fixed assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible fixed assets, less their estimated residual value, over their expected useful lives as follows:-

**Debtors**

Debtors are recognised at the settlement amount due after any discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due. Income recognised by the company from government agencies and other co-funders, but not yet received at year ended, is included in debtors.

**Cash at bank and in hand**

Cash at bank and in hand comprises cash on deposit at banks requiring less than three months notice withdrawal.

**Taxation and deferred taxation**

No current or deferred taxation arises as the company has been granted charitable exemption. Irrecoverable valued added tax is expensed as incurred.

The Directors/Trustees confirm that it is appropriate to prepare the financial statements on a going concern basis. The financial statements do not include any adjustments that would result if the going concern basis was not appropriate.

**DIRECTORS' ANNUAL REPORT**

For the year ended 31 March 2023

The Directors present their Directors' Annual Report, combining the Directors' Report and Trustees' Report, and the unaudited financial statements for the year ended 31 March 2023.

The financial statements are prepared in accordance with the Companies Act 2006, FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and Accounting and Reporting by Charities Statement of Recommended Practice applicable to charities preparing their financial statements in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

The Directors' Report contains the information required to be provided in the Directors' Annual Report under the Statement of Recommended Practice (SORP) guidelines. The directors of the company are also charity trustees for the purpose of charity law and under the company's constitution are known as members of the board of trustees.

In this report the directors of Fermanagh Rural Community Network present a summary of its purpose, governance, activities, achievements and finances for the financial year 31 March 2023.

The company is a registered charity and hence the report and results are presented in a form which complies with the requirements of the Companies Act 2006 and, although not obliged to comply with the statement of Recommended Practice applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015), the organisation has implemented its recommendations where relevant in these financial statements.

### **Missions, Objectives and Strategy**

#### **Mission Statement**

Fermanagh Rural Community Network provides practical support, guidance, information, signposting and networking opportunities for member groups, through our locally based staff, resource centre and network services and programmes. This benefits rural community groups in developing sustainable rural communities, directly tackling issues that are causing disadvantage and poverty.

#### **Objectives**

The objectives of the Company shall be to relieve poverty and advance education for the benefit of the inhabitants of Fermanagh and its hinterland without distinction of sex, race or political, religious or other opinion and in particular to promote any charitable activity which give support to the local rural communities suffering disadvantage and poverty and which seeks to improve the conditions of life for the inhabitants of the area of benefit.

### **Structure, Governance and Management**

#### **Structure**

Fermanagh Rural Community Network is a company limited by guarantee not having a share capital. The company is governed by its Memorandum and Articles of Association. Fermanagh Rural Community Network in its role as the Local Rural Support Network for County Fermanagh delivered the following key community development support activities to positively benefit and sustain County Fermanagh's rural communities over the year.

- 11 Network Management Committee Meetings.
- Developing Group Capacity and Projects - 800+ Member Group support requests including development assistance, funding information & project grant application assistance responded to during the year.
- 4 Member Group Support & Advice Workshops/ Information/ Consultation events.
- Facebook, Twitter, and Website updated regularly, and information updates circulated.
- Network representation on twenty strategic/theme-based partnerships
- FRCN continued strategic partnership with Lakeland Community Care Limited to deliver and expand the range of healthy living, social engagement, and community relations projects, delivered within and from Belcoo Healthy Living Centre.
- FRCN have received funding from the Northern Ireland Housing Executive under their Sustaining Tenancies Funding Programme to deliver the Erne West Sustaining Tenancies Project that is supporting NIHE tenants living in the Erne West Area with a range of actions that have the overall aim of increasing their levels of social interaction and wellbeing.
- FRCN working in collaboration with Lakeland Community Care Limited have a contract to deliver the 'The *SPRING Rural Enhanced Social Prescribing Project (SREP)*', focusing on the communities in Erne West District Electoral Area of County Fermanagh. - FRCN have been awarded a *Start Here Programme Grant* from *The Rank Foundation* which is being used for employment of a new Community Development Officer for three years. *The Department of Communities (DfC)* provide the funding for the Start Here Programme Grant awards under their *Covid Employment and Skills Initiative*.
- FRCN managed the *Screggagh Windfarm Community Benefit Fund* in which twenty-eight eligible community & voluntary organisations received donations totalling £48,197.00.
- FRCN are a Registered Helper Group with the *Charity Commission for Northern Ireland* and advise and support those groups undergoing charity registration charities with their annual reporting.
- FRCN have promoted the *Community Planning process for the Fermanagh and Omagh district*, are members of the *Community Voluntary Sector Forum and Community Planning Strategic Partnership Board*.

The Partnership formed in June 2022 is representative of communities across the district and includes Councilors, Social Partners and Statutory Representatives.
- FRCN are members of Fermanagh and Omagh District Council's Agricultural Liason Group that undertakes liaison with and makes representation to the relevant bodies and agencies on behalf of the rural communities of the district.
- FRCN are members of and have been Board representation on *Rural Community Networks NI* the regional voluntary organisation that articulates the voice of rural communities on issues relating to poverty, disadvantage, and equality.



**Basis of independent examiner's report**



**NOTES TO THE FINANCIAL STATEMENTS**

for the year ended 31 March 2023

**1. GENERAL INFORMATION**

Fermanagh Rural Community Network is a company limited by guarantee not having a share capital incorporated in Northern Ireland. The registered office of the company is 3 Queen Street, Enniskillen, Co. Fermanagh, BT74 7JR which is also the principle place of business of the company. The financial statements have been presented in Pound Sterling (£) which is also the functional currency of the company.

**2. ACCOUNTING POLICIES**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the charity's financial statements.

**Basis of Preparation**

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006 and Part 8 of the Charities Act (Northern Ireland) 2008. They also comply with the Statement of Recommended Practice (SORP 2005, as updated in 2008) and with the financial reporting standards. The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

**Statement of compliance**

The financial statements of the company for the year ended 31 March 2023 have been prepared on the going concern basis and in accordance with the Statement of Recommended Practice (SORP) 'Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)' and FRS102 'The Financial Reporting Standard applicable in the UK and Republic', applying Section 1A of that Standard.

**Cash flow statement**

The company has availed of the exemption in FRS102 from the requirement to produce a cash flow statement because it is classified as a small company.

**Incoming Resources**

Voluntary income or capital is included in the Statement of Financial Activities when the company is legally entitled to it, its financial value can be quantified with reasonable certainty and there is reasonable certainty of its ultimate receipt. Entitlement to legacies is considered established when the company has been notified of a distribution to be made by the executors. Income received in advance of due performance under a contract is accounted for as deferred income until earned. Grants for activities are recognised as income when the related conditions for legal entitlement have been met. All other income is accounted for on an accruals basis.

**Resources Expended**

All resources expended are accounted for on an accruals basis. Charitable activities include costs of services and grants, support costs and depreciation on related assets. Costs of generating funds similarly include fundraising activities. Non-staff costs not attributed to one category of activity are allocated or apportioned pro-rata to the staffing of the relevant service. Finance, HR, IT and administrative staff costs are directly attributable to individual activities by objective. Governance costs are those associated with constitutional and statutory requirements.

**Tangible fixed assets and depreciation**

Tangible fixed assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible fixed assets, less their estimated residual value, over their expected useful lives as follows:-

**Debtors**

Debtors are recognised at the settlement amount due after any discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due. Income recognised by the company from government agencies and other co-funders, but not yet received at year ended, is included in debtors.

Cash at bank and in hand comprises cash on deposit at banks requiring less than three months notice withdrawal.

**Taxation and deferred taxation**

No current or deferred taxation arises as the company has been granted charitable exemption. Irrecoverable valued added tax is expensed as incurred.

The Directors/Trustees confirm that it is appropriate to prepare the financial statements on a going concern basis. The financial statements do not include any adjustments that would result if the going concern basis was not appropriate.
