Governing Document

LGBTNI is a charitable company limited by guarantee, incorporated on the 6 February 2014. The company was registered with the new Charity Commission for Northern Ireland (Regulator of Charities in Northern Ireland) on the 19 May 2016.

The company was established under a Memorandum of Association which established the objects and powers of the charitable company and is governed under its Articles of Association. In the event of the company being wound up, members are required to contribute an amount not exceeding £1. The number of members at the 17 July 2018 was 1.

Principal Activities

LGBTNI's mission is to promote the health and well-being of gay, lesbian, bisexual and transgender people and their families in Northern Ireland.

Plans for Future Periods

There are no plans for future periods as company was dissolved on 17 July 2018.



1 Accounting Policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year.

a Basis of accounting

The financial statements have been prepared under the historical cost convention, and in accordance with the relevant Companies legislation, and the Statement of Recommended Practice: Accounting and Reporting by Charities issued in March 2005. All items of a capital nature costing less than £2000 individually are written off in the Income and Expenditure Account in the year of acquisition.

b Fund accounting

Unrestricted funds are available for use at the discretion of the Directors in furtherance of the general objectives of the charity.

Designated funds are unrestricted funds earmarked by the Directors for particular purposes.

Restricted funds are subject to restrictions on their expenditure imposed by the donor or through the terms of an appeal.

c Incoming resources

All incoming resources are included in the Statement of Financial Activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of grants, donations and gifts, and is included in full in the Statement of Financial Activities when receivable. Grants, where entitlement on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.

Donated services and facilities are included at the value to the charity where this can be quantified.

Investment income is included when receivable.

Incoming resources from grants, where related to performance and specific deliverables, are accounted for as the charity earns the right to consideration by its performance.

d Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes VAT which cannot be recovered, and is included therein.

Charitable expenditure comprises those costs incurred by the charity in delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and necessary indirect costs.

Governance costs relate to the constitutional and statutory requirements.

All costs are allocated between the expenditure categories of the Statement of Financial Activities on a basis designed to reflect the use of the resource. Costs allocated to restricted funds are based on the allocation of the income across the cost heads agreed by the funder based on the applications made to funders.

e Fixed Assets

The Company has acquired no Fixed Assets as at the Balance Sheet date.
