DIRECTORS' REPORT FOR THE YEAR ENDED 31 OCTOBER 2024

The directors present their report and the financial statements for the year ended 31 October 2024.

Details of how the Charity is constituted and its Governing Document:

Family Spectrum Ltd. is a Company limited by guarantee, and governed by its Memorandum and Articles of Association initially ratified on 12 October 2004, amended on 11 January 2013. We were notified that we had been registered as a Charity in Northern Ireland on 22 April 2016.

Summary description of the Purposes of the Charity:

The purposes of the Charity are to promote good practice within Christian communities in relation to marriage, family life and the many complex issues and difficulties that arise in this area, through training, consultation, conferences, publications and support of Christian leaders and others, and through direct pastoral care in difficult cases alongside such leaders where necessary.

Authorisation of new Directors, and the method used for such appointments:

As provided for in Article 3 of the Charity's Articles of Association, "The subscribers to the Memorandum of Association of the Company and such other persons as are admitted to membership in accordance with the articles shall be members/Directors of the Company. No person shall be admitted as a member/Director of the Company unless invited to membership by the then current Members/Directors."

Main Activities Furthering the Charity's Purposes for the Public Benefit:

Purpose 1: To promote good practice within Christian communities, congregations and fellowships in relation to marriage and family life, and responding to the complex issues that arise in this area.

Related Activities:

- (i) Net-working with Christian leaders to inform them of the range of inputs offered by Family Spectrum;
- (ii) Consultations with Christian leaders in respect of difficult cases (in areas such as those identified at Purpose 4 below).

Public Benefit:

Ongoing net-working with Christian leaders is a key means of informing them or updating them about the services offered by Family Spectrum. This in turn leads to contacts from leaders to discuss difficult pastoral issues in their congregations. The public benefit is both to the individuals, couples or families experiencing the specific difficulties, and to the leaders in question, who are supported and developed in their provision of pastoral care, primarily to the specific person in need, but then, through the enhancement of experience and skills, for situations that may arise in the future.

Purpose 2: To support church leaders in relation to marriage and family issues, including parenting, marriage preparation, enrichment and restoration, and the pastoral care of those in family crisis.

Related Activities:

- (i) Direct professional supervision of a professional Social Worker employed by a large local church;
- (ii) Consultation and professional support of Christian Social Workers and volunteers in various projects.
- (iii) Consultation and/or co-working with pastoral leaders in difficult cases.

Public Benefits:

One Family Spectrum representative provides direct professional supervision to a Social Worker employed by a local church. This included regular discussion of a number of very complex situations with which he is in touch through the church's outreach (including ex-prisoners - some of whom may be a risk to children - broken families and mental health issues). It also includes input and support in the development of some new supportive services. Supervision takes place monthly and is professionally recorded. The public benefits are both to the individuals/families involved and to the organisation through the Social Worker, who although work-managed within the church does not have professional supervision available within that context. The outcome is better decision making (including possible referral to statutory agencies) in the difficult cases.

The support for pastoral leaders helps give confidence in dealing with difficult issues, and constitutes on the job learning for them.

Purpose 3: To provide specialist input in relation to child abuse/protection issues including youth leader training, pastoral training, consultancy in respect of the management of Schedule One offenders or high risk participants in a congregation, and the development of child protection policy and procedures.

Related Activities:

- (i) Public Training events in relation to Youth Leader training, Child Sexual Abuse Recovery of adults abused as children, and Child Sex Offender Management;
- (ii) Direct work with a number of child sex offenders and leaders on issues around their participation in local churches, and on other issues;
- (iii) Consultations for church leaders regarding the management or potential management of a child sex offender in their congregations;
- (iv) The updating of local church Child Protection Policy and Procedures.
- (v) An informal group of semi-retired child care professionals meets occasionally for mutual support.

Public Benefits:

The public training events are detailed under purpose 5 below. Family Spectrum has contributed to the development of a Child Sex Offender Project and Course for offenders who have served their sentence, in partnership with another voluntary organisation working in prisons. The aim of the course is engagement with those prisoners who have committed serious offences, but who have come to faith in prison, their discipleship and, if possible, integration into suitable church settings, with full risk management arrangements in place. This course comprises 10 x 3 hour sessions and is now available.

Work continues in supporting church leaders manage the risks child sex offenders may pose in congregational settings, this has included a case where the Probation Service referred an offender who wished to participate in a local church.

The public benefits are in several directions. The public and statutory agencies benefit because support is available for the offenders in the evenings and weekends when the agencies are usually closed. Supported offenders are also much safer than isolated individuals. Church leadership teams are benefitted by developing hands on skills in monitoring and supporting potentially dangerous individuals, while ensuring that all available protections are in place for vulnerable church members and children. The offenders themselves benefit through engagement with supports, sometimes with their own families, which gives them a stake in society and inhibits reoffending. Reintegrating these lower risk offenders into a congregation whose leaders are prepared and informed constitutes a considerable public benefit.

The working group (see (v) above) continues to provide great mutual support for its members, and a forum to explore child protection work and how it has to adapt in different cultural settings.

Purpose 4: To provide pastoral care and ministry to individuals, couples and church leaders in relation to marriage and family related issues such as sexual abuse, divorce and remarriage, sexual orientation, mixed-faith marriage, fostering, reconstituted families, single parenting and abortion recovery.

Related Activities:

(i) Direct pastoral care to individuals, and couples, often (and preferably) referred and supported by local church leaders, regarding issues such as marriage difficulties, pornography, separation/custody issues, bereavement, family estrangement/tensions, child sexual abuse victims, child care/development, divorce/cohabitation, crisis pregnancy, and anger management;

(ii) Pro-Life work involves supporting individuals running the ‘Surrendering the Secret’ course, financial support to Pro-Life organisations, and individual engagement with a number of post-abortive women and men as situations arise.

Public Benefits:

There are a significant number of people in congregational settings who have experienced/are experiencing extensive and complicated family related needs. Family Spectrum personnel provide direct pastoral input to such people, as often as possible in partnership with their local church leaders. The issues that arise are varied as detailed above.

The public benefits are to the individuals or couples concerned (provided that they are willing to undertake the work necessary), and also to the church leaders, for whom there is an element of support in an otherwise lonely task, and an element of training through partnership working.

Our engagement with Pro-Life work and other organisations that work in this area gives valuable support to women who have regretted past abortions and, having themselves experienced real healing in their lives, wish to support each other, and reach to other women starting on their healing journey. Some are emboldened to be able to share their journey for the help of others, which has proved especially powerful. Often, however, these women do not feel able to be open about their past in their local congregations.

Purpose 5: To provide consultancy and training on family, marriage and difficult related issues through conferences, publications and other appropriate means.

Related Activities:

(i) Planning and delivery of training sessions for churches, other charities, child care professionals and church leaders, including discussions with leadership teams of highly complex family cases.

Public Benefits:

Conferences, training session and publications provide leaders and committed lay people with the opportunity to think through how they might engage with various complex family related issues, and so enhance the pastoral input they are in turn able to give. It is difficult to quantify accurately the public benefit derived, however subsequent consultations with these leaders about specific cases, or undertaking direct work with congregation members on behalf of or in harness with these leaders indicates that they found the inputs helpful.

Family Spectrum runs events for friends and supporters to share about an area of our work, usually with some folk sharing their personal journey. This reinforces the engagement of those supporters with us and is a public benefit to them. It is also of great benefit to those who share their stories.

Family Spectrum has created and financed a series of podcasts covering the areas of (a) marriage, (b) recovery for victims of child sexual abuse, (c) management of and work with child sex offenders in the local congregation, and (d) parenting. These are now available via the Family Spectrum web site and other means.

Two books published by Family Spectrum Publications are now available for purchase through Amazon and Kindle

Purpose 6: To provide practical assistance to promote and support the well-being of families.

Related Activities:

(i) One Family Spectrum representative is involved as a regular Prayer Pastor for the Street Pastors organisation operating in the Coleraine and Triangle area;

(ii) A donation was made towards the work of Both Lives Matter to assist with Pro-Life advocacy work and the provision of support services for post-abortive women

Public Benefits:

Through personal relationship connections Family Spectrum personnel have become involved in several projects outlined above which are the prime responsibility of other charities but to which we can offer professional expertise and support. These involvements have variously involved financial support for acute needs, consultation/advice about service developments for other charities, and occasionally, direct involvement with the clients or staff of the other charities.

The public benefits accrue to the individuals and families who receive the aid, and to the other charities whose staff and services are enhanced by the professional input.

Those benefitting from the use of funds donated are the families and children who will benefit from the new school, and those working directly with them.

Review of the Charity's financial position for the year:

Unrestricted funds - Opening reserves of £7,802. Deficit for the year of £3,801. Closing reserves of £4,001



(ii) Pro-Life work involves supporting individuals running the ‘Surrendering the Secret’ course, financial support to Pro-Life organisations, and individual engagement with a number of post-abortive women and men as situations arise.

Public Benefits:

There are a significant number of people in congregational settings who have experienced/are experiencing extensive and complicated family related needs. Family Spectrum personnel provide direct pastoral input to such people, as often as possible in partnership with their local church leaders. The issues that arise are varied as detailed above.

The public benefits are to the individuals or couples concerned (provided that they are willing to undertake the work necessary), and also to the church leaders, for whom there is an element of support in an otherwise lonely task, and an element of training through partnership working.

Our engagement with Pro-Life work and other organisations that work in this area gives valuable support to women who have regretted past abortions and, having themselves experienced real healing in their lives, wish to support each other, and reach to other women starting on their healing journey. Some are emboldened to be able to share their journey for the help of others, which has proved especially powerful. Often, however, these women do not feel able to be open about their past in their local congregations.

Purpose 5: To provide consultancy and training on family, marriage and difficult related issues through conferences, publications and other appropriate means.

Related Activities:

(i) Planning and delivery of training sessions for churches, other charities, child care professionals and church leaders, including discussions with leadership teams of highly complex family cases.

Public Benefits:

Conferences, training session and publications provide leaders and committed lay people with the opportunity to think through how they might engage with various complex family related issues, and so enhance the pastoral input they are in turn able to give. DIRECTORS' REPORT FOR THE YEAR ENDED 31 OCTOBER 2023

The directors present their report and the financial statements for the year ended 31 October 2023.

Details of how the Charity is constituted and its Governing Document:

Family Spectrum Ltd. is a Company limited by guarantee, and governed by its Memorandum and Articles of Association initially ratified on 12 October 2004, amended on 11 January 2013. We were notified that we had been registered as a Charity in Northern Ireland on 22 April 2016.

Summary description of the Purposes of the Charity:

The purposes of the Charity are to promote good practice within Christian communities in relation to marriage, family life and the many complex issues and difficulties that arise in this area, through training, consultation, conferences, publications and support of Christian leaders and others, and through direct pastoral care in difficult cases alongside such leaders where necessary.

Authorisation of new Directors, and the method used for such appointments:

As provided for in Article 3 of the Charity's Articles of Association, "The subscribers to the Memorandum of Association of the Company and such other persons as are admitted to membership in accordance with the articles shall be members/Directors of the Company. No person shall be admitted as a member/Director of the Company unless invited to membership by the then current Members/Directors."

Main Activities Furthering the Charity's Purposes for the Public Benefit:

Purpose 1: To promote good practice within Christian communities, congregations and fellowships in relation to marriage and family life, and responding to the complex issues that arise in this area.

Related Activities:

- (i) Net-working with Christian leaders to inform them of the range of inputs offered by Family Spectrum;
- (ii) Consultations with Christian leaders in respect of difficult cases (in areas such as those identified at Purpose 4 below).

Public Benefit:

Ongoing net-working with Christian leaders is a key means of informing them or updating them about the services offered by Family Spectrum. This in turn leads to contacts from leaders to discuss difficult pastoral issues in their congregations. The public benefit is both to the individuals, couples or families experiencing the specific difficulties, and to the leaders in question, who are supported and developed in their provision of pastoral care, primarily to the specific person in need, but then, through the enhancement of experience and skills, for situations that may arise in the future.

Purpose 2: To support church leaders in relation to marriage and family issues, including parenting, marriage preparation, enrichment and restoration, and the pastoral care of those in family crisis.

Related Activities:

- (i) Direct professional supervision of a professional Social Worker employed by a large local church;
- (ii) Consultation and professional support of Christian Social Workers and volunteers in various projects.
- (iii) Consultation and/or co-working with pastoral leaders in difficult cases.
- (iv) Running Holy Trinity Brompton Marriage Courses.

Public Benefits:

One Family Spectrum representative provides direct professional supervision to a Social Worker employed by a local church. This included regular discussion of a number of very complex situations with which he is in touch through the church's outreach (including ex-prisoners - some of whom may be a risk to children -, broken families and mental health issues). It also includes input and support in the development of some new supportive services. Supervision takes place monthly and is professionally recorded. The public benefits are both to the individuals/families involved and to the organisation through the Social Worker, who although work-managed within the church does not have professional supervision available within that context. The outcome is better decision making (including possible referral to statutory agencies) in the difficult cases.

The support for pastoral leaders helps give confidence in dealing with difficult issues, and constitutes on the job learning for them.

Purpose 3: To provide specialist input in relation to child abuse/protection issues including youth leader training, pastoral training, consultancy in respect of the management of Schedule One offenders or high risk participants in a congregation, and the development of child protection policy and procedures.

Related Activities:

- (i) Public Training events in relation to Youth Leader training, Child Sexual Abuse Recovery of adults abused as children, and Child Sex Offender Management;
- (ii) Direct work with a number of child sex offenders and leaders on issues around their participation in local churches, and on other issues;
- (iii) Consultations for church leaders regarding the management or potential management of a child sex offender in their congregations;
- (iv) The updating of local church Child Protection Policy and Procedures.
- (v) A working group of child care professionals and mission/denominational representatives meets bi-monthly to develop strategies for the church to deal with child protection issues where there is institutional resistance to change culture in the established churches, and also for the underground church in countries where the government is very hostile to Christians, and where reporting may pose serious risks to other church members.

Public Benefits:

The public training events are detailed under purpose 5 below. Family Spectrum has contributed to the development of a Child Sex Offender Project, in partnership with another voluntary organisation working in prisons, the aim of which is engagement with those prisoners who have committed serious offences, but who have come to faith in prison, their discipleship and, if possible, integration into suitable church settings, with full risk management arrangements in place.

Work continues in supporting church leaders manage the risks child sex offenders may pose in congregational settings, this has included a case where the Probation Service referred an offender who wished to participate in a local church.

The public benefits are in several directions. The public and statutory agencies benefit because support is available for the offenders in the evenings and weekends when the agencies are usually closed. Supported offenders are also much safer than isolated individuals. Church leadership teams are benefitted by developing hands on skills in monitoring and supporting potentially dangerous individuals, while ensuring that all available protections are in place for vulnerable church members and children. The offenders themselves benefit through engagement with supports, sometimes with their own families, which gives them a stake in society and inhibits reoffending. Reintegrating these lower risk offenders into a congregation whose leaders are prepared and informed constitutes a considerable public benefit.

The working group (see (v) above) continues to provide great mutual support for its members, and a forum to explore child protection work and how it has to adapt in different cultural settings.

Purpose 4: To provide pastoral care and ministry to individuals, couples and church leaders in relation to marriage and family related issues such as sexual abuse, divorce and remarriage, sexual orientation, mixed-faith marriage, fostering, reconstituted families, single parenting and abortion recovery.

Related Activities:

(i) Direct pastoral care to individuals, and couples, often (and preferably) referred and supported by local church leaders, regarding issues such as marriage difficulties, pornography, separation/custody issues, bereavement, family estrangement/tensions, child sexual abuse victims, child care/development, divorce/cohabitation, crisis pregnancy, and anger management;

(ii) Pro-Life work involves supporting individuals running the ‘Surrendering the Secret’ course, financial support to Pro-Life organisations, and individual engagement with a number of post-abortive women and men as situations arise.

Public Benefits:

There are a significant number of people in congregational settings who have experienced/are experiencing extensive and complicated family related needs. Family Spectrum personnel provide direct pastoral input to such people, as often as possible in partnership with their local church leaders. The issues that arise are varied as detailed above.

The public benefits are to the individuals or couples concerned (provided that they are willing to undertake the work necessary), and also to the church leaders, for whom there is an element of support in an otherwise lonely task, and an element of training through partnership working.

Our engagement with Pro-Life work and other organisations that work in this area gives valuable support to women who have regretted past abortions and, having themselves experienced real healing in their lives, wish to support each other, and reach to other women starting on their healing journey. Some are emboldened to be able to share their journey for the help of others, which has proved especially powerful. Often, however, these women do not feel able to be open about their past in their local congregations.

Purpose 5: To provide consultancy and training on family, marriage and difficult related issues through conferences, publications and other appropriate means.

Related Activities:

(i) Planning and delivery of training sessions for churches, other charities, child care professionals and church leaders, including discussions with leadership teams of highly complex family cases.

Public Benefits:

Conferences, training session and publications provide leaders and committed lay people with the opportunity to think through how they might engage with various complex family related issues, and so enhance the pastoral input they are in turn able to give. It is difficult to quantify accurately the public benefit derived, however subsequent consultations with these leaders about specific cases, or undertaking direct work with congregation members on behalf of or in harness with these leaders indicates that they found the inputs helpful.

Family Spectrum runs events for friends and supporters to share about an area of our work, usually with some folk sharing their personal journey. This reinforces the engagement of those supporters with us and is a public benefit to them. It is also of great benefit to those who share their stories.

Preparation is under way to develop a series of podcasts on key pastoral themes.

Purpose 6: To provide practical assistance to promote and support the well-being of families.

Related Activities:

(i) One Family Spectrum representative is involved as a regular Prayer Pastor for the Street Pastors organisation operating in the Coleraine and Triangle area;

(ii) Use of designated funds received from Causeway Care in Crisis (a charity now closed whose residual funds are managed by Family Spectrum) for Pro-Life purposes. This included donations to Pro-Life organisations. Disbursement of these funds was completed during this year.

(iii) A considerable donation was also made from general funds to relief work in Morocco following the massive earthquake in September 2023. This was to assist in the building of a new school in a village in the Atlas mountain region which was worst affected.

Public Benefits:

Through personal relationship connections Family Spectrum personnel have become involved in several projects outlined above which are the prime responsibility of other charities but to which we can offer professional expertise and support. These involvements have variously involved financial support for acute needs, consultation/advice about service developments for other charities, and occasionally, direct involvement with the clients or staff of the other charities.

The public benefits accrue to the individuals and families who receive the aid, and to the other charities whose staff and services are enhanced by the professional input.

Those benefitting from the use of funds donated are the families and children who will benefit from the new school, and those working directly with them.

Review of the Charity's financial position for the year:

Unrestricted funds - Opening reserves of £8,087. Deficit for the year of £285. Closing reserves of £7,802.

Restricted funds - Opening reserves of £513. Surplus for the year of £Nil. Closing reserves of £513.

Restricted funds relate to funds received from Causeway Care in Crisis (a charity now closed).

Funds held by the Charity as a 'custodian trustee':

Family Spectrum Ltd. has held funds received from the now ceased charity, Causeway Care in Crisis. These funds were passed to Family Spectrum Ltd., on the understanding that they would be used solely for purposes in harmony with the aims and purposes of CCinC. The purposes of the former CCinC all fall within the range of purposes of Family Spectrum Ltd, These monies were held in a separate account known as Family Spectrum Ltd. No. 2 Account (CPCI). Funds from this account have been used as detailed at point 9 Purpose 6 (iii) above. As funds are now fully disbursed this account has been closed.

Family Spectrum Limited is a Company limited by guarantee, and governed by its Memorandum and Articles of Association initially ratified on 12/10/2004, amended on 11/1/13. We were notified that we had been registered as a Charity in Northern Ireland on 22/4/16.

Summary description of the Purposes of the Charity:

The purposes of the Charity are to promote good practice within Christian Communities in relation to marriage, family life and the many complex issues and difficulties that arise in this area, through training, consultation, conferences, publications and support of Christian leaders and others, and through direct pastoral care in difficult cases alongside such leaders where necessary.

Authorisation of new Directors, and the method used for such appointments:

As provided for in Article 3 of the Charity's Articles of Association, "The subscribers to the Memorandum of Association of the Company and such other persons as are admitted to membership in accordance with the articles shall be members/Directors of the Company. No person shall be admitted as a member/Director of the Company unless invited to membership by the then current Members/Directors".

Main Activities Furthering the Charity's Purposes for the Public Benefit:

Purpose 1: To promote good practice within Christian communities, congregations and fellowships in relation to marriage and family life, and responding to the complex issues that arise in this area.

Related Activities:

- (i) Net-working with Christian leaders to inform them of the range of inputs offered by Family Spectrum;
- (ii) Consultations with Christian leaders in respect of difficult cases (in areas such as those identified at Purpose 4 below);
- (iii) Support for a project – Causeway Marriage and Family Network – which encourages and supports the running of Marriage Preparation, Marriage Enrichment and Parenting courses in local churches and the community.

Public Benefit:

Ongoing networking with Christian leaders is a key means of informing them or updating them about the services offered by Family Spectrum. This in turn leads to contacts from leaders to discuss difficult pastoral issues in their congregations. The public benefit is both to the individuals, couples or families experiencing the specific difficulties, and to the leaders in question, who are supported and developed in their provision of pastoral care, primarily to the folk in question, but then, through the enhancement of experience and skills, for situations that may arise in the future.

Causeway Marriage and Family Network is an independent project started in 2008 by Family Spectrum personnel in harness with others. CM&FN runs training events for those wanting to learn how to run marriage preparation, marriage enrichment and parenting courses, and which supports and encourages those trained to set up and run these courses to the benefit of the participants. Feedback from those trained is consistently positive, and a number of past participants in the courses have shared their positive experiences at subsequent events.

Purpose 2: To support church leaders in relation to marriage and family issues, including parenting, marriage preparation, enrichment and restoration, and the pastoral care of those in family crisis.

Related Activities:

- (i) Direct professional supervision of a professional Social Worker employed by a large local church;
- (ii) Session for young parents on children and sex education;
- (iii) Initiated and supported the running of the Holy Trinity Brompton Marriage Preparation, Marriage and Parenting courses;
- (iv) Professional support and training for Life Changer, a Social Work project based in Pietermaritzburg, S Africa. This project is three-pronged, working with young street people (often recent care leavers), young people in Children's Homes (in preparation for leaving care and re-engaging with their families) and in couples and individuals to provide fostering, adoption and befriending opportunities for these children and young people.

Public Benefits:

As well as training and supporting church representatives in running the above Marriage and Parenting courses, Family Spectrum personnel have also led courses themselves.

The public benefits were for the various participants i.e. (mainly) young couples giving them the opportunity to develop solid foundations for their future marriages, for various married couples seeking to enhance their marriages, and for those parents seeking to improve their parenting.

One Family Spectrum representative provides direct professional supervision to a Social Worker employed by a local church. This included regular discussion of a number of very complex situations with which he is in touch (including ex-prisoners, some of whom may be a risk to children, broken families and mental health issues). It also includes input and support in the development of some new supportive services. Supervision takes place monthly and is professionally recorded. The public benefits are both to the individuals/families involved and to the organisation through the Social Worker, who although work-managed within the church does not have professional supervision available within that context. The outcome is better decision making (including possible referral to statutory agencies) in the difficult cases.

One Family Spectrum representative has a similar role and input into the Life Changer project in SA. This includes supervision by skype at least three times a month, covering project development and the management of difficult cases. The project has been visited during the year and training given, and it is planned to repeat this in the current year. The public benefit accrues from the support of the project spear head, his support staff and the clients receiving input from them, delivering an improved all-round service.

Purpose 3: To provide specialist input in relation to child abuse/protection issues including youth leader training, pastoral training, consultancy in respect of the management of Schedule One offenders or high risk participants in a congregation, and the development of child protection policy and procedures.

Related Activities:

- (i) Public Training events (detailed at purpose 5) in relation to Child Sexual Abuse Recovery, and Child Sex Offender Management;
- (ii) A Child Sex Offender Project – this involves a support group for ex-prisoners with convictions for child sexual abuse who have come to faith in prison. It is run in partnership with Prison Fellowship (NI);
- (iii) The video recording of the story of one such offender who has been successfully integrated into a fellowship with necessary safeguards, as training material for use with church leaders;
- (iv) Direct work with a number of child sex offenders on issues around participation in local churches, and on other issues;
- (v) Consultations with church leaders regarding the management or potential management of a child sex offender in their congregations;
- (vi) Preparation for the training of personal from prisoner support charities in the Republic of Ireland, especially in the post release support of child sex offenders in the community;
- (vi) Updating of local church Child Protection Policy and Procedures.

Public Benefits:

The public training events are detailed under purpose 5 below. Family Spectrum is developing a Child Sex Offender Project, in partnership with Prison Fellowship (NI) and Release (Dublin), the aim of which is engagement with those who have committed serious offences, but who have come to faith, and their integration into suitable church settings, as far as is possible, with full risk management arrangements in place.

The public benefits are in several directions. The public and statutory agencies benefit because support is available for the offenders in the evenings and weekends when the agencies are usually closed. Supported offenders are also much safer than isolated individuals. Church leadership teams are benefitted by developing hands on skills in monitoring and supporting potentially dangerous individuals, while ensuring that all available protections are in place for vulnerable church members and children. The offenders themselves benefit through engagement with supports, sometimes with their own families, which give them a stake in society and inhibit reoffending. Reintegrating these lower risk offenders into a congregation whose leaders are prepared and informed constitutes a considerable public benefit.

For each party this is a learning process. We have recorded the story (anonymously) of one offender who has engaged well and benefitted a great deal with this input, including the re-establishment of his family.

Purpose 4: To provide pastoral care and ministry to individuals, couples and church leaders in relation to marriage and family related issues such as sexual abuse, divorce and remarriage, sexual orientation, mixed-faith marriage, fostering, reconstituted families, single parenting and abortion recovery.

Related Activities:

(i) Direct pastoral care to individuals, and couples, often (and preferably) referred by local church leaders, regarding issues such as marriage difficulties, pornography, separation/custody issues, bereavement, family estrangement/tensions, child sexual abuse victims, child care/development, divorce/cohabitation, crisis pregnancy, and anger management.

(ii) Engagement with the 'Both Lives Matter' campaign run by Evangelical Alliance, Care for the Family and Life (NI). More recently this has led to co-ordinating with the Pregnancy Crisis Network (England) in seeking to develop services in NI;

(iii) Support group for pre- and post-abortive women – Causeway Pregnancy Crisis Initiative – who run a recovery Bible Study course, and support other women troubled by past abortions

Public Benefits:

There are a significant number of people in congregational settings who have experienced/are experiencing extensive and complicated family related needs. Family Spectrum personnel provide direct pastoral input to such people, as often as possible in harness with their local church leaders. The issues that arise are varied as detailed above.

The public benefits are to the individuals or couples concerned (provided that they are willing to undertake the work necessary), and also to the church leaders, for whom there is an element of support in an otherwise lonely task, and an element of training through partnership working.

Our engagement with the 'Both Lives Matter' campaign and Causeway Pregnancy Crisis Initiative, and now the Pregnancy Network gives valuable support to women who have regretted past abortions and, having themselves experienced real healing in their lives, wish to support each other and other women starting on their healing journey. Some are emboldened to be able to share their journey for the help of others, which has proved especially powerful. Often these women do not feel able to be open about their past in their local congregations.

Purpose 5: To provide consultancy and training on family, marriage and difficult related issues through conferences, publications and other appropriate means.

Related Activities:

(i) Meeting for Family Spectrum supporters and friends outlining the development of our Child Sex Offender Project, including the use of the recorded testimony of one offender's story;

(ii) Planning and delivery of training sessions for churches, at conferences (New Horizon) and for Voluntary groups (CPCI, CM & FN, Release (Dublin), Life Changer (S Africa));

(iii) Training session for the National Prosecuting Authority (Pietermatitzburg, S Africa) and their Court Preparation Workers who support rape and child sexual abuse victims through the court process and the giving on evidence.

Public Benefits:

Conferences, training session and publications provide leaders and committed lay people with the opportunity to think through how they might engage with various complex family related issues, and so enhance the pastoral input they are in turn able to give. It is difficult to quantify accurately the public benefit derived, however subsequent consultations with these leaders about specific cases, or undertaking direct work with congregation members on behalf of or in harness with these leaders indicates that they found the inputs helpful.

Family Spectrum runs events for friends and supporters to share about an area of our work, usually with some folk sharing their personal journey. This reinforces the engagement of those supporters with us and is a public benefit to them. It is also of great benefit to those who share their stories.

Purpose 6: To provide practical assistance to promote and support the well-being of families.

Related Activities:

(i) In November 2017 we provided £700 financial support to the work of Life Line Trust for their work on two of the Caribbean Islands devastated by severe hurricanes in September 2017. This finance was for the rebuilding of homes and immediate aid to affected families;

(ii) Kosovo Support Group – two Family Spectrum personnel have been involved in annual visits of teams to Kosovo in the aftermath of the Balkan unrest in the 1990s to help with rebuilding. This has now developed into other forms of support, and includes facilitating visits of a full-time worker there to update supporters in NI;

(iii) One Family Spectrum representative is involved as a regular Prayer Pastor for the Street Pastors organisation operating in Coleraine and Triangle area;

(iv) Two Family Spectrum personnel are involved in consultation work with friends in Pietermaritzburg, South Africa, who have been working for 14 years with families infected and affected by AIDS. This is currently setting up a project supporting kinship care/fostering/adoption of children orphaned by AIDS. This has developed into a church network-based project in Pietermaritzburg, S Africa. We have provided financial support (£900) during the year and are seeking to access trust funds for further support. Two Family Spectrum representatives have visited the project providing professional advice and consultation, and plan to visit again this year.

(vi) Use of designated funds received from Causeway Care in Crisis (a charity now closed) for pro-life purposes. This includes donations to Life Institute, and Evangelical Alliance (Both Lives Matter campaign) and costs incurred in running public meetings for Both Lives Matter, and other related expenses.

Public Benefits:

Through personal relationship connections Family Spectrum personnel have become involved in several projects outlined above which are the prime responsibility of other charities but to which we can offer professional expertise and support. These involvements have variously involved financial support for acute needs, consultation/advice about service developments for other charities, and occasionally, direct involvement with the clients or staff of the other charities.

The public benefits accrue to the individuals and families who receive the aid, and to the other charities whose staff and services are enhanced by the professional input e.g. we have had discussion and sharing of best practice with a social worker who is based in the |Life Line projects in the Caribbean on child protection issues, as well as the financial aid sent after the hurricanes.

The work in Kosovo has been mainly practical rebuilding of homes and also some work in schools and with youth affected through teams going from NI since 2000, but it is also sustained by regular meetings in NI of previous team members who seek to remain informed and who continue to support the people we know there. This involves meeting up with Kosovo based workers who come to NI from time to time.

The project in South Africa is in its early stages. Family Spectrum personnel with fostering and adoption experience have now visited, and are planning to present several seminars at the SA Association of SWs conference from 2 to 4 July 2019, along with other church based training.

Those benefitting from the use of funds donated to Life Institute and Both Lives Matter, and in running two public meetings are the unborn children that we trust will be helped, their mothers and possibly families, and those working directly with them.

Review of the Charity's financial position for the year:

Unrestricted funds - Opening reserves of £6,591. Deficit for the year of £1,003. Closing reserves of £5,588.

Restricted funds - Opening reserves of £2,238. Deficit for the year of £518. Closing reserves of £1,720.

Restricted funds relate to funds received from Causeway Care in Crisis (a charity now closed)


Funds held by the Charity as a 'custodian trustee':

DIRECTORS REPORT FOR THE YEAR ENDED 31 OCTOBER 2018

The directors present their report and the financial statements for the year ended 31 October 2018.

Details of how the Charity is constituted and its Governing Document:

Family Spectrum Limited is a Company limited by guarantee, and governed by its Memorandum and Articles of Association initially ratified on 12/10/2004, amended on 11/1/13. We were notified that we had been registered as a Charity in Northern Ireland on 22/4/16.

Summary description of the Purposes of the Charity:

The purposes of the Charity are to promote good practice within Christian Communities in relation to marriage, family life and the many complex issues and difficulties that arise in this area, through training, consultation, conferences, publications and support of Christian leaders and others, and through direct pastoral care in difficult cases alongside such leaders where necessary.

Authorisation of new Directors, and the method used for such appointments:

As provided for in Article 3 of the Charity's Articles of Association, "The subscribers to the Memorandum of Association of the Company and such other persons as are admitted to membership in accordance with the articles shall be members/Directors of the Company. No person shall be admitted as a member/Director of the Company unless invited to membership by the then current Members/Directors".

Main Activities Furthering the Charity's Purposes for the Public Benefit:

Purpose 1: To promote good practice within Christian communities, congregations and fellowships in relation to marriage and family life, and responding to the complex issues that arise in this area.

Related Activities:

- (i) Net-working with Christian leaders to inform them of the range of inputs offered by Family Spectrum;
- (ii) Consultations with Christian leaders in respect of difficult cases (in areas such as those identified at Purpose 4 below);
- (iii) Support for a project – Causeway Marriage and Family Network – which encourages and supports the running of Marriage Preparation, Marriage Enrichment and Parenting courses in local churches and the community.

Causeway Marriage and Family Network is an independent project started in 2008 by Family Spectrum personnel in harness with others. CM&FN runs training events for those wanting to learn how to run marriage preparation, marriage enrichment and parenting courses, and which supports and encourages those trained to set up and run these courses to the benefit of the participants. Feedback from those trained is consistently positive, and a number of past participants in the courses have shared their positive experiences at subsequent events.

Purpose 2: To support church leaders in relation to marriage and family issues, including parenting, marriage preparation, enrichment and restoration, and the pastoral care of those in family crisis.

Related Activities:

- (i) Direct professional supervision of a professional Social Worker employed by a large local church;
- (ii) Session for young parents on children and sex education;
- (iii) Initiated and supported the running of the Holy Trinity Brompton Marriage Preparation, Marriage and Parenting courses;
- (iv) Professional support and training for Life Changer, a Social Work project based in Pietermaritzburg, S Africa. Family Spectrum runs events for friends and supporters to share about an area of our work, usually with some folk sharing their personal journey. This reinforces the engagement of those supporters with us and is a public benefit to them. It is also of great benefit to those who share their stories.

Purpose 6: To provide practical assistance to promote and support the well-being of families.

Related Activities:

(i) In November 2017 we provided £700 financial support to the work of Life Line Trust for their work on two of the Caribbean Islands devastated by severe hurricanes in September 2017. This finance was for the rebuilding of homes and immediate aid to affected families;

(ii) Kosovo Support Group – two Family Spectrum personnel have been involved in annual visits of teams to Kosovo in the aftermath of the Balkan unrest in the 1990s to help with rebuilding. This has now developed into other forms of support, and includes facilitating visits of a full-time worker there to update supporters in NI;

(iii) One Family Spectrum representative is involved as a regular Prayer Pastor for the Street Pastors organisation operating in Coleraine and Triangle area;

(iv) Two Family Spectrum personnel are involved in consultation work with friends in Pietermaritzburg, South Africa, who have been working for 14 years with families infected and affected by AIDS. This is currently setting up a project supporting kinship care/fostering/adoption of children orphaned by AIDS. This has developed into a church network-based project in Pietermaritzburg, S Africa. We have provided financial support (£900) during the year and are seeking to access trust funds for further support. Two Family Spectrum representatives have visited the project providing professional advice and consultation, and plan to visit again this year.

(vi) Use of designated funds received from Causeway Care in Crisis (a charity now closed) for pro-life purposes. This includes donations to Life Institute, and Evangelical Alliance (Both Lives Matter campaign) and costs incurred in running public meetings for Both Lives Matter, and other related expenses.

Public Benefits:

Through personal relationship connections Family Spectrum personnel have become involved in several projects outlined above which are the prime responsibility of other charities but to which we can offer professional expertise and support. These involvements have variously involved financial support for acute needs, consultation/advice about service developments for other charities, and occasionally, direct involvement with the clients or staff of the other charities.

The public benefits accrue to the individuals and families who receive the aid, and to the other charities whose staff and services are enhanced by the professional input e.g. we have had discussion and sharing of best practice with a social worker who is based in the |Life Line projects in the Caribbean on child protection issues, as well as the financial aid sent after the hurricanes.

The work in Kosovo has been mainly practical rebuilding of homes and also some work in schools and with youth affected through teams going from NI since 2000, but it is also sustained by regular meetings in NI of previous team members who seek to remain informed and who continue to support the people we know there. This involves meeting up with Kosovo based workers who come to NI from time to time.

The project in South Africa is in its early stages. Family Spectrum personnel with fostering and adoption experience have now visited, and are planning to present several seminars at the SA Association of SWs conference from 2 to 4 July 2019, along with other church based training.

Those benefitting from the use of funds donated to Life Institute and Both Lives Matter, and in running two public meetings are the unborn children that we trust will be helped, their mothers and possibly families, and those working directly with them.



DIRECTORS REPORT FOR THE YEAR ENDED 31 OCTOBER 2018

The directors present their report and the financial statements for the year ended 31 October 2018.

Details of how the Charity is constituted and its Governing Document:

Family Spectrum Limited is a Company limited by guarantee, and governed by its Memorandum and Articles of Association initially ratified on 12/10/2004, amended on 11/1/13. We were notified that we had been registered as a Charity in Northern Ireland on 22/4/16.

Summary description of the Purposes of the Charity:

The purposes of the Charity are to promote good practice within Christian Communities in relation to marriage, family life and the many complex issues and difficulties that arise in this area, through training, consultation, conferences, publications and support of Christian leaders and others, and through direct pastoral care in difficult cases alongside such leaders where necessary.

Authorisation of new Directors, and the method used for such appointments:

As provided for in Article 3 of the Charity's Articles of Association, "The subscribers to the Memorandum of Association of the Company and such other persons as are admitted to membership in accordance with the articles shall be members/Directors of the Company. No person shall be admitted as a member/Director of the Company unless invited to membership by the then current Members/Directors".

Main Activities Furthering the Charity's Purposes for the Public Benefit:

Purpose 1: To promote good practice within Christian communities, congregations and fellowships in relation to marriage and family life, and responding to the complex issues that arise in this area.

Related Activities:

- (i) Net-working with Christian leaders to inform them of the range of inputs offered by Family Spectrum;
- (ii) Consultations with Christian leaders in respect of difficult cases (in areas such as those identified at Purpose 4 below);
- (iii) Support for a project – Causeway Marriage and Family Network – which encourages and supports the running of Marriage Preparation, Marriage Enrichment and Parenting courses in local churches and the community.

Public Benefit:

Ongoing networking with Christian leaders is a key means of informing them or updating them about the services offered by Family Spectrum. This in turn leads to contacts from leaders to discuss difficult pastoral issues in their congregations. The public benefit is both to the individuals, couples or families experiencing the specific difficulties, and to the leaders in question, who are supported and developed in their provision of pastoral care, primarily to the folk in question, but then, through the enhancement of experience and skills, for situations that may arise in the future.

Causeway Marriage and Family Network is an independent project started in 2008 by Family Spectrum personnel in harness with others. CM&FN runs training events for those wanting to learn how to run marriage preparation, marriage enrichment and parenting courses, and which supports and encourages those trained to set up and run these courses to the benefit of the participants. Feedback from those trained is consistently positive, and a number of past participants in the courses have shared their positive experiences at subsequent events.

Purpose 2: To support church leaders in relation to marriage and family issues, including parenting, marriage preparation, enrichment and restoration, and the pastoral care of those in family crisis.

Related Activities:

- (i) Direct professional supervision of a professional Social Worker employed by a large local church;
- (ii) Session for young parents on children and sex education;
- (iii) Initiated and supported the running of the Holy Trinity Brompton Marriage Preparation, Marriage and Parenting courses;
- (iv) Professional support and training for Life Changer, a Social Work project based in Pietermaritzburg, S Africa. This project is three-pronged, working with young street people (often recent care leavers), young people in Children's Homes (in preparation for leaving care and re-engaging with their families) and in couples and individuals to provide fostering, adoption and befriending opportunities for these children and young people.

Public Benefits:

As well as training and supporting church representatives in running the above Marriage and Parenting courses, Family Spectrum personnel have also led courses themselves.

The public benefits were for the various participants i.e. (mainly) young couples giving them the opportunity to develop solid foundations for their future marriages, for various married couples seeking to enhance their marriages, and for those parents seeking to improve their parenting.

One Family Spectrum representative provides direct professional supervision to a Social Worker employed by a local church. This included regular discussion of a number of very complex situations with which he is in touch (including ex-prisoners, some of whom may be a risk to children, broken families and mental health issues). It also includes input and support in the development of some new supportive services. Supervision takes place monthly and is professionally recorded. The public benefits are both to the individuals/families involved and to the organisation through the Social Worker, who although work-managed within the church does not have professional supervision available within that context. The outcome is better decision making (including possible referral to statutory agencies) in the difficult cases.

One Family Spectrum representative has a similar role and input into the Life Changer project in SA. This includes supervision by skype at least three times a month, covering project development and the management of difficult cases. The project has been visited during the year and training given, and it is planned to repeat this in the current year. The public benefit accrues from the support of the project spear head, his support staff and the clients receiving input from them, delivering an improved all-round service.

Purpose 3: To provide specialist input in relation to child abuse/protection issues including youth leader training, pastoral training, consultancy in respect of the management of Schedule One offenders or high risk participants in a congregation, and the development of child protection policy and procedures.

Related Activities:

- (i) Public Training events (detailed at purpose 5) in relation to Child Sexual Abuse Recovery, and Child Sex Offender Management;
- (ii) A Child Sex Offender Project – this involves a support group for ex-prisoners with convictions for child sexual abuse who have come to faith in prison. It is run in partnership with Prison Fellowship (NI);
- (iii) The video recording of the story of one such offender who has been successfully integrated into a fellowship with necessary safeguards, as training material for use with church leaders;
- (iv) Direct work with a number of child sex offenders on issues around participation in local churches, and on other issues;
- (v) Consultations with church leaders regarding the management or potential management of a child sex offender in their congregations;
- (vi) Preparation for the training of personal from prisoner support charities in the Republic of Ireland, especially in the post release support of child sex offenders in the community;
- (vi) Updating of local church Child Protection Policy and Procedures.

Public Benefits:

The public training events are detailed under purpose 5 below. Family Spectrum is developing a Child Sex Offender Project, in partnership with Prison Fellowship (NI) and Release (Dublin), the aim of which is engagement with those who have committed serious offences, but who have come to faith, and their integration into suitable church settings, as far as is possible, with full risk management arrangements in place.

The public benefits are in several directions. The public and statutory agencies benefit because support is available for the offenders in the evenings and weekends when the agencies are usually closed. Supported offenders are also much safer than isolated individuals. Church leadership teams are benefitted by developing hands on skills in monitoring and supporting potentially dangerous individuals, while ensuring that all available protections are in place for vulnerable church members and children. The offenders themselves benefit through engagement with supports, sometimes with their own families, which give them a stake in society and inhibit reoffending. Reintegrating these lower risk offenders into a congregation whose leaders are prepared and informed constitutes a considerable public benefit.

For each party this is a learning process. We have recorded the story (anonymously) of one offender who has engaged well and benefitted a great deal with this input, including the re-establishment of his family.

Purpose 4: To provide pastoral care and ministry to individuals, couples and church leaders in relation to marriage and family related issues such as sexual abuse, divorce and remarriage, sexual orientation, mixed-faith marriage, fostering, reconstituted families, single parenting and abortion recovery.

Related Activities:

(i) Direct pastoral care to individuals, and couples, often (and preferably) referred by local church leaders, regarding issues such as marriage difficulties, pornography, separation/custody issues, bereavement, family estrangement/tensions, child sexual abuse victims, child care/development, divorce/cohabitation, crisis pregnancy, and anger management.



1. Principal accounting policies
