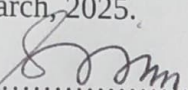
Mid Antrim Historical Group NIC 102790

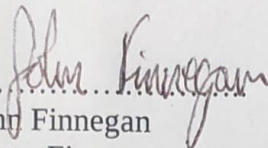
