The directors have adopted the provisions of the Companies Act 2006 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (Charities SORP – FRS102), in preparing the annual report and financial statements of the charity.

Structure, governance and management

The Company is a charity limited by guarantee without share capital which avails of the "Limited" exemption.

The company is governed by its Memorandum and Articles of Association dated 15 February 2006 and updated in January 2022. In the event of the Company being wound up members are required to contribute an amount not exceeding £10. The Board is responsible for the overall governance of the Company and is actively involved in the day to day management of the organisation.

Directors are appointed in line with the Memorandum & Articles of Association of the company.

The Board of Directors are also known as Trustees for the purposes of the Charity Commission.

Appointment of Trustees

As set out in the Articles, Directors of the Company (who serve as Trustees of the Charity for the purposes of Charity Law) are elected by the members of the company, or can be co-opted by the Directors.

Trustee Induction and Training

Incoming Members of the Board of Directors are aware of the aims and objectives of the Charity and the manner in which the Trustees carry out their responsibilities. The Chair, supported by the Chief Executive, oversees an induction process for new Directors, who are provided with key documents, including the Articles of Association of the company. An overview of the operations of the company is provided by the Chief Executive and new Directors are afforded the opportunity to meet with key staff and view the key elements of the company's operations.

Organisation

The Board of Trustees administers the Charity. The Board meets a minimum of 4 times per annum.

The operations of the charity are managed on a day-to-day basis by a Chief Executive, appointed by the Board of Trustees.

Risk management

The directors have conducted a review of the major risks to which the charity is exposed. Financial risk is reviewed on a monthly basis having due regard to ongoing income and expenses.

Objectives and Activities (and how they deliver public benefit)

The Company is a non-profit making entity. The principal activity of Coaching4Christ is that of a charity which is registered according to the law of Northern Ireland to advance the Christian faith via sport. The Ministry operates in 6 aspects:- youth development through our Youth Academy (5-12 year olds) League teams (13-17 year olds) our schools work (5-18 year olds), summer camps and International work, with support in all of this through our Prayer Warriors.

In setting our objectives and planning our activities for the year the trustees have given careful consideration to the Charity Commission for Northern Ireland's guidance on public benefit to ensure that the activities have helped to achieve the charity's purposes and provide a benefit to its beneficiaries.

Achievements and performance

Youth Academy

Our Youth Academy has again seen growth in the last year, not just in kids coming but also with new volunteer coaches coming on board. As well as this we are now offering a Young Volunteering Initiative to our players from the u 17 team who wish to volunteer as part of their DOE award, allowing these young people to grow and develop as leaders whilst received training and mentoring.

On a weekly basis between our Youth Academy and Schools Ministry we have the privilege of Ministry to and coaching 2,000 young people

Our Youth Academy runs from Monday-Thursday evenings with matches on Friday nights and Saturday's. Offering 3 areas of coaching – social, development and league football no-one is excluded. We have now have 12 teams in the South Belfast League, and they are performing very well. In September we introduced our Friday evening soccer sessions for kids aged 8-10 and CFC mini's which allows children from age 5 to 8 to come along to the coaching sessions on Saturday mornings. From this they progress right up through CFC until the age of 18.

Every evening at our various coaching locations throughout mid and East Antrim the young people take part in the sessions which include development both on and off the pitch through group discussions on biblical stories and topical issues.

These values for life are from a faith-based perspective and help engage young people who have never encountered the Christian faith, see a real modern-day example of how to have a relationship with God. For any young person who already has a relationship with God we help disciple them throughout their time with us by the coaches offering mentoring in small groups.

We place a high value on our Volunteers, many who serve two nights a week and/or a Friday night or a Saturday morning or afternoon and offer many other opportunities such as coach education, coach mentoring and coaching badges.

Schools

We are very privileged to be invited into schools in the mid and east antrim area - 18 in total including primary and secondary level, which allows us to share the Gospel with 1700 young people weekly.

Achievements and performance ctd...

Alongside this we offer programmes which are age relevant and offer help around issues that the young people are facing, such as bullying, poor mental health and low self-worth. The recorded outcomes have been very encouraging so much so that we have been asked to outreach into more schools in the wider N.I. area. The Vision for our schools' work is tremendous and we are working alongside the schools to offer Leadership Training and Development. Along with our services being availed of as part of the PE and sports curriculum we are also involved in running 3 of the schools football teams.

As the relationship with schools grows the coaches are getting more opportunities to share in School Assemblies.

We currently have a waiting list of 30 schools, and we continue to offer opportunities for further volunteer coaches to help make all this reality.

In the month of May we launched school festival days, where we go into 1 school for the whole day offering coaching and sharing the beautiful Gospel message. This is then repeated in all our schools throughout the month.

Full time Team

We have 2 coaches progressing onto completing their 'A' licence, in the next two years. In the last year, 2 interns came on board for a year with CFC. In partnership with Stranmillis College, Belfast we offer 2-week placement to final year students to help them experience the Ministry and allow them opportunity to use their gifts to serve others. A number of these students have joined the team on overseas mission, with others coming onto our Internship Programme.

In the last year we had teams running summer camps locally all over Ireland, north and south, also in Spain, north and south and Indonesia. Allowing us to expand the reach into the Nations. This year will have been our 11th year in the Cordoba region of Spain.

Talk-plans based on scriptures, written by two of our full-time team to complement the plans already used, have been implemented and used widely within our own Youth Academy and Schools, they have also been seen by our mission partners who wish to see them translated into Spanish.

Two highlights of the ministry must be noted as we celebrated 20 years of Ministry in February and sent our first overseas full-time missionary to Atlanta, Georgia in the USA where he will set up CFC.

The Future

Coaching for Christ ministry was founded to see lives and communities transformed by Christ through sport; the Vision of which has always been to have our own outdoor facility to accommodate the ever-growing Youth Academy and we continue to look for a site in the Mid and East Antrim area as a home for our Youth Academy and to allow us to grow.

Multiplication and Planting

In summer of 2024 we travelled to North Spain and have established a further link in this country with church planters who wish to plant CFC in Spain. February 2025 saw us sending our first missionary to the USA to plant the work there.

We would also like to acknowledge those who support the work, through prayer, serving or financially, you are all part of Ministry and we are truly thankful for each of you. For the faithfulness for each volunteer, Director, full time team, thank you.

Prayer

Everything we do is overseen by our Team of Prayer Warriors, ever expanding in number. This committed group cover each coach and the work daily in prayer. We consider them the backbone of CFC.

Financial review and funds policy

During the year the charity received donations totalling £303,286 and had expenditure of £281,610. At the year end the charity had £189,060 of unrestricted liquid funds to meet the continuing running costs of the company.

The company plans to continue its activities in the forthcoming years.

The reserve policy of Coaching4Christ is to aim to hold reserves of 6 months of unrestricted running costs. At present Coaching for Christ have unrestricted reserves equal to 9 months unrestricted running costs.

Coaching for Christ ministry was founded to see lives and communities transformed by Christ through sport; the Vision of which has always been to have our own outdoor facility to accommodate the ever-growing Youth Academy and we continue to look for a site in the Mid and East Antrim area as a home for our Youth Academy and to allow us to grow.

1. ACCOUNTING POLICIES

The principal accounting policies adopted, judgements and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

a) Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Coaching for Christ meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s).

b) Preparation of the accounts on a going concern basis

At the time of approving the financial statements, the trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

c) Fund Accounting

Unrestricted funds are funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the Charity and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the Charity for particular purposes. The cost of raising and administering such funds are charged against the specific fund. The aim and use of restricted funds is set out in the notes to the financial statements. Restricted funds may only be transferred to general or designated funds once the criteria for restriction have been discharged or no longer apply.

d) Income

Income is recognised when the charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received. Cash donations are recognised on receipt. Other donations are recognised once the charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

e) Donated services and facilities

In accordance with the Charities SORP (FRS 102), the general volunteer time of supporters is not recognised.

f) Expenditure and irrecoverable VAT

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably. Expenditure is classified under the following activity heading:

- Expenditure on charitable activities comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

f) Expenditure and irrecoverable VAT ctd...

All costs are allocated between the expenditure categories of the Statement of Financial Activities on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly, others are apportioned on an appropriate basis.

Irrecoverable VAT is charged as a cost against the activity for which the expenditure was incurred.

g) Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation.

Depreciation is provided at rates calculated to write off the cost or valuation of fixed assets, less their estimated residual value, over their expected useful lives on the following basis:

Office equipment	20% reducing balance
Gym equipment	10% on cost
Sports clothing and equipment	50% on cost

The carrying values of tangible fixed assets are reviewed for impairment when events or circumstances indicate the carrying value may not be recoverable.

h) Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid after taking account of any trade discounts due.

i) Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term current accounts.

j) Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

k) Financial instruments

The trust only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at the carrying value plus accrued interest less repayments. The financing charge to expenditure is at a constant rate calculated using the effective interest method.

l) Taxation

The company is a registered charity and the charitable tax exemptions are therefore being claimed to the extent that income and/or gains are applicable and applied to charitable purposes only. These exemptions will remain in place as long as income and expenditure is applied to charitable purposes only.

m) Critical accounting estimates and judgements

In the application of the charity's accounting policies, the trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.

Structure, governance and management

The Company is a charity limited by guarantee without share capital which avails of the "Limited" exemption.

The company is governed by its Memorandum and Articles of Association dated 15 February 2006 and updated in January 2022. In the event of the Company being wound up members are required to contribute an amount not exceeding £10. The Board is responsible for the overall governance of the Company and is actively involved in the day to day management of the organisation.

Directors are appointed in line with the Memorandum & Articles of Association of the company.

The Board of Directors are also known as Trustees for the purposes of the Charity Commission.

Appointment of Trustees

As set out in the Articles, Directors of the Company (who serve as Trustees of the Charity for the purposes of Charity Law) are elected by the members of the company, or can be co-opted by the Directors.

Trustee Induction and Training

Incoming Members of the Board of Directors are aware of the aims and objectives of the Charity and the manner in which the Trustees carry out their responsibilities. The Chair, supported by the Chief Executive, oversees an induction process for new Directors, who are provided with key documents, including the Articles of Association of the company. An overview of the operations of the company is provided by the Chief Executive and new Directors are afforded the opportunity to meet with key staff and view the key elements of the company's operations.

Organisation

The Board of Trustees administers the Charity. The Board meets a minimum of 4 times per annum.

The operations of the charity are managed on a day-to-day basis by a Chief Executive, appointed by the Board of Trustees.

Risk management

The directors have conducted a review of the major risks to which the charity is exposed. Financial risk is reviewed on a monthly basis having due regard to ongoing income and expenses.

Objectives and Activities (and how they deliver public benefit)

The Company is a non-profit making entity. The principal activity of Coaching4Christ is that of a charity which is registered according to the law of Northern Ireland to advance the Christian faith via sport. The Ministry operates in 6 aspects:- youth development through our Youth Academy (5-12 year olds) League teams (13-17 year olds) our schools work (5-18 year olds), summer camps and International work, with support in all of this through our Prayer Warriors.

In setting our objectives and planning our activities for the year the trustees have given careful consideration to the Charity Commission for Northern Ireland's guidance on public benefit to ensure that the activities have helped to achieve the charity's purposes and provide a benefit to its beneficiaries.

Achievements and performance

Youth Academy

Our Youth Academy has again seen growth in the last year, not just in kids coming but also with new volunteer coaches coming on board. As well as this we are now offering a Young Volunteering Initiative to our players from the u 17 team who wish to volunteer as part of their DOE award, allowing these young people to grow and develop as leaders whilst received training and mentoring.

On a weekly basis between our Youth Academy and Schools Ministry we have the privilege of Ministry to and coaching 2,000 young people

Our Youth Academy runs from Monday-Thursday evenings with matches on Friday nights and Saturday's. Offering 3 areas of coaching – social, development and league football no-one is excluded. We have now have 10 teams in the South Belfast League, and they are performing very well.

Every evening at our various coaching locations throughout mid and East Antrim the young people take part in the sessions which include development both on and off the pitch through group discussions on biblical stories and topical issues.

These values for life are from a faith-based perspective and help engage young people who have never encountered the Christian faith, see a real modern-day example of how to have a relationship with God. For any young person who already has a relationship with God we help disciple them throughout their time with us by the coaches offering mentoring in small groups.

We place a high value on our Volunteers, many who serve two nights a week and a Saturday morning or afternoon and offer many other opportunities such as coach education, coach mentoring and coaching badges.

Schools

We are very privileged to be invited into schools in the mid and east antrim area - 17 in total including primary and secondary level, which allows us to share the Gospel with 1600 young people weekly. Alongside this we offer programmes which are age relevant and offer help around issues that the young people are facing, such as bullying, poor mental health and low self-worth. The recorded outcomes have been very encouraging so much so that we have been asked to outreach into more

schools in the wider N.I. area. The Vision for our schools' work is tremendous and we are working alongside the schools to offer Leadership Training and Development. We have also been asked to offer our services within the curriculum for PE and sports which we have introduced in the last year. We are also involved in running three schools' teams.

As the relationship with schools grows the coaches are getting more opportunities to share in School Assemblies.

We currently have a waiting list of 30 schools, and we continue to offer opportunities for further volunteer coaches to help make all this reality.

In the month of May we launched school festival days, where we go into 1 school for the whole day offering coaching and sharing the beautiful Gospel message.

Full time Team

As a full time, team, we actively look at our personal development in areas relevant such as coach education with 3 of our coaches obtaining their 'B' Licence and 1 their 'C' licence progressing onto completing their 'A' and 'B' licence respectively, in the next year. We have one new full-time self-employed coach and 1 intern. In partnership with Stranmillis College, Belfast we offer 2 week placement to final year students to help them experience the Ministry, and allow them opportunity to use their gifts to serve others. A number of these students have joined the team on overseas mission, with others coming onto our Internship Programme.

In the last year we had teams running summer camps locally and also in Kilkenny, Spain, and North Africa. Allowing us to expand the reach into the Nations. This year will have been our 10th year in the Cordoba region of Spain.

The Future

Thankfulness

We would also like to acknowledge those who support the work, through prayer, serving or financially, you are all part of Ministry and we are truly thankful for each of you. For the faithfulness for each volunteer, Director, full time team, thank you.

Prayer

Everything we do is overseen by our Team of Prayer Warriors, ever expanding in number. This committed group cover each coach and the work daily in prayer. We consider them the backbone of CFC.

Financial review and funds policy

During the year the charity received donations totalling £307,874 and had expenditure of £293,141. At the year end the charity had £156,871 of unrestricted cash funds to meet the continuing running costs of the company.

The company plans to continue its activities in the forthcoming years.

The reserve policy of Coaching4Christ is to aim to hold reserves of 6 months of unrestricted running costs. At present Coaching for Christ have unrestricted reserves equal to 3 months unrestricted running costs.



Notes to the Financial Statements for the year ended 29 February 2024

1. ACCOUNTING POLICIES

The principal accounting policies adopted, judgements and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

a) Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) - (Charities SORP (FRS 102), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Coaching for Christ meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s).

b) Preparation of the accounts on a going concern basis

At the time of approving the financial statements, the trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

c) Fund Accounting

Unrestricted funds are funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the Charity and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the Charity for particular purposes. The cost of raising and administering such funds are charged against the specific fund. The aim and use of restricted funds is set out in the notes to the financial statements. Restricted funds may only be transferred to general or designated funds once the criteria for restriction have been discharged or no longer apply.

d) Income

Income is recognised when the charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received. Cash donations are recognised on receipt. Other donations are recognised once the charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

e) Donated services and facilities

In accordance with the Charities SORP (FRS 102), the general volunteer time of supporters is not recognised.

f) Expenditure and irrecoverable VAT

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably. Expenditure is classified under the following activity heading:

- Expenditure on charitable activities comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

1. ACCOUNTING POLICIES ctd...

f) Expenditure and irrecoverable VAT ctd...

All costs are allocated between the expenditure categories of the Statement of Financial Activities on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly, others are apportioned on an appropriate basis.

Irrecoverable VAT is charged as a cost against the activity for which the expenditure was incurred.

g) Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation.

Depreciation is provided at rates calculated to write off the cost or valuation of fixed assets, less their estimated residual value, over their expected useful lives on the following basis:

Property	2% on cost
Office equipment	20% reducing balance
Gym equipment	10% on cost
Sports clothing and equipment	50% on cost

The carrying values of tangible fixed assets are reviewed for impairment when events or circumstances indicate the carrying value may not be recoverable.

h) Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid after taking account of any trade discounts due.

i) Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term current accounts.

j) Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

k) Financial instruments

The trust only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at the carrying value plus accrued interest less repayments. The financing charge to expenditure is at a constant rate calculated using the effective interest method.

l) Taxation

The company is a registered charity and the charitable tax exemptions are therefore being claimed to the extent that income and/or gains are applicable and applied to charitable purposes only. These exemptions will remain in place as long as income and expenditure is applied to charitable purposes only.

m) Critical accounting estimates and judgements

In the application of the charity's accounting policies, the trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.

Organisation

The Board of Trustees administers the Charity. The Board meets a minimum of 4 times per annum.

The operations of the charity are managed on a day-to-day basis by a Chief Executive, appointed by the Board of Trustees.

Risk management

The directors have conducted a review of the major risks to which the charity is exposed. Financial risk is reviewed on a monthly basis having due regard to ongoing income and expenses.

Objectives and Activities (and how they deliver public benefit)

The Company is a non-profit making entity. The principal activity of Coaching4Christ is that of a charity which is registered according to the law of Northern Ireland to advance the Christian faith via sport. The Ministry operates in 6 aspects:- youth development through our Youth Academy (5-12 year olds) League teams (13-17 year olds) our schools work (5-18 year olds), summer camps and International work, with support in all of this through our Prayer Warriors.

In setting our objectives and planning our activities for the year the trustees have given careful consideration to the Charity Commission for Northern Ireland's guidance on public benefit to ensure that the activities have helped to achieve the charity's purposes and provide a benefit to its beneficiaries.

Achievements and performance

Youth Academy

Our Youth Academy has again seen growth in the last year, not just in kids coming but also with new volunteer coaches coming on board. As well as this we are now offering a Young Volunteering Initiative to our players from the u 17 team who wish to volunteer as part of their DOE award, allowing these young people to grow and develop as leaders whilst received training and mentoring.

On a weekly basis between our Youth Academy and Schools Ministry we have the privilege of Ministry to and coaching 2,000 young people

Our Youth Academy runs from Monday-Thursday evenings with matches on Friday nights and Saturday's. Offering 3 areas of coaching – social, development and league football no-one is excluded. We have now have 10 teams in the South Belfast League, and they are performing very well.

Every evening at our various coaching locations throughout mid and East Antrim the young people take part in the sessions which include development both on and off the pitch through group discussions on biblical stories and topical issues.

These values for life are from a faith-based perspective and help engage young people who have never encountered the Christian faith, see a real modern-day example of how to have a relationship with God. For any young person who already has a relationship with God we help disciple them throughout their time with us by the coaches offering mentoring in small groups.

We place a high value on our Volunteers, many who serve two nights a week and a Saturday morning or afternoon and offer many other opportunities such as coach education, coach mentoring and coaching badges.

Schools

We are very privileged to be invited into schools in the mid and east antrim area - 17 in total including primary and secondary level, which allows us to share the Gospel with 1600 young people weekly. Alongside this we offer programmes which are age relevant and offer help around issues that the young people are facing, such as bullying, poor mental health and low self-worth. The recorded outcomes have been very encouraging so much so that we have been asked to outreach into more

schools in the wider N.I. area. The Vision for our schools' work is tremendous and we are working alongside the schools to offer Leadership Training and Development. We have also been asked to offer our services within the curriculum for PE and sports which we have introduced in the last year. We are also involved in running three schools' teams.

As the relationship with schools grows the coaches are getting more opportunities to share in School Assemblies.

We currently have a waiting list of 30 schools, and we continue to offer opportunities for further volunteer coaches to help make all this reality.

In the month of May we launched school festival days, where we go into 1 school for the whole day offering coaching and sharing the beautiful Gospel message.

Full time Team

As a full time, team, we actively look at our personal development in areas relevant such as coach education with 3 of our coaches obtaining their 'B' Licence and 1 their 'C' licence progressing onto completing their 'A' and 'B' licence respectively, in the next year. We have one new full-time self-employed coach and 1 intern. In partnership with Stranmillis College, Belfast we offer 2 week placement to final year students to help them experience the Ministry, and allow them opportunity to use their gifts to serve others. A number of these students have joined the team on overseas mission, with others coming onto our Internship Programme.

In the last year we had teams running summer camps locally and also in Kilkenny, Spain, and North Africa. Allowing us to expand the reach into the Nations. This year will have been our 10th year in the Cordoba region of Spain.

The Future

Coaching for Christ ministry founded to see lives and communities transformed by Christ through sport; the Vision of which has always been to have our own outdoor facility to accommodate the ever-growing Youth Academy. For the faithfulness for each volunteer, Director, full time team, thank you.

Prayer

Everything we do is overseen by our Team of Prayer Warriors, ever expanding in number. This committed group cover each coach and the work daily in prayer. We consider them the backbone of CFC.

Financial review and funds policy

During the year the charity received donations totalling £307,874 and had expenditure of £293,141. At the year end the charity had £156,871 of unrestricted cash funds to meet the continuing running costs of the company.



Structure, governance and management

Organisation

The Board of Trustees administers the Charity. The Board meets a minimum of 4 times per annum.

The operations of the charity are managed on a day-to-day basis by a Chief Executive, appointed by the Board of Trustees.

Risk management

The directors have conducted a review of the major risks to which the charity is exposed. Financial risk is reviewed on a monthly basis having due regard to ongoing income and expenses.

Objectives and Activities (and how they deliver public benefit)

The Company is a non-profit making entity. The principal activity of Coaching4Christ is that of a charity which is registered according to the law of Northern Ireland to advance the Christian faith via sport. The Ministry operates in 6 aspects:- youth development through our Youth Academy (5-12 year olds) League teams (13-17 year olds) our schools work (5-18 year olds), summer camps and International work, with support in all of this through our Prayer Warriors.

In setting our objectives and planning our activities for the year the trustees have given careful consideration to the Charity Commission for Northern Ireland's guidance on public benefit to ensure that the activities have helped to achieve the charity's purposes and provide a benefit to its beneficiaries.

Achievements and performance

Our Youth Academy has grown considerably in the last year, and we now have 400 young people attending on a weekly basis where we share the transforming Gospel message and offer high quality coaching. Offering 3 areas of coaching – social, development and league football no-one is excluded. We have 8 teams in the South Belfast League, and they are performing very well with two league winners and a trophy win.

We are very privileged to be invited into schools in the mid and east antrim area - 17 in total including primary and secondary level, which allows us to share the Gospel with 2000 young people weekly. Alongside this we offer programmes which are age relevant and offer help around issues that the young people are facing, such as bullying, poor mental health and low self-worth. The recorded outcomes have been very encouraging so much so that we have been asked to outreach into more schools in the wider N.I. area. The Vision for our schools' work is tremendous and we are working alongside the schools to offer Leadership Training and Development. We have also been asked to offer our services within the schools' curriculum for PE and sports which we have introduced in the last year. We are also involved in running three schools' teams.

As the relationship with schools grows the coaches are getting more opportunities to share in School Assemblies.

We currently have a waiting list of schools, and we continue to offer opportunities for further volunteer coaches to help make all this reality.

As a full time, team, we actively look at our personal development in areas relevant such as coach education with 3 of our coaches obtaining their 'C' Licence and progressing onto completing their 'B' licence in the next year. We have one new full-time – self-employed coach.

Our New Young Volunteer Initiative continues to be a huge success where we offer the opportunity to shadow our coaches and for the coaches to mentor them in a physical and spiritual capacity.

Training Ground was launched in September 2022 and is an online community created to IMPART wisdom and IMPRINT our vision so people can IMPACT their world.

Four main themes of teaching.

- EVANGELISM: ENCOURAGE- *Encourage people to know Jesus*
- DISCIPLESHIP: EQUIP- *Equip people to follow Jesus*
- LEADERSHIP: *Empower people to live like Jesus*
- COACH EDUCATION-*Coach Education/Coaching Sessions*

Financial review and funds policy

During the year the charity received donations totalling £263,764 and had expenditure of £243,988. At the year end the charity had £29,842 of unrestricted cash funds to meet the continuing running costs of the company.

The company plans to continue its activities in the forthcoming years.

The reserve policy of Coaching4Christ is to aim to hold reserves of 3 months of unrestricted running costs. At present Coaching4Christ have unrestricted reserves equal to 3 months unrestricted running costs.

Plans for future periods

As a ministry we have outgrown our building based in Ahoghill, Co. Antrim, the building is now up for sale. Our plans upon sale are to look for offices which will meet our needs. We are so thankful for the building and the Ministry it has been used for but also for the fact that the sale of the building will free up resources and allow us to actively look for ground on which to build the stadium that has always been the Vision of the Ministry. Our Youth Academy has grown and continues to grow, with our own stadium it will allow us to increase our capacity to outreach to an extra 1000 young people a week.

Planting the work of Coaching for Christ in the Nations - we are actively working with partners in Spain and America to take CFC global.

1. ACCOUNTING POLICIES

The principal accounting policies adopted, judgements and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

a) Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) - (Charities SORP (FRS 102), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Coaching4Christ meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s).

b) Preparation of the accounts on a going concern basis

At the time of approving the financial statements, the trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

c) Fund Accounting

Unrestricted funds are funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the Charity and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the Charity for particular purposes. The cost of raising and administering such funds are charged against the specific fund. The aim and use of restricted funds is set out in the notes to the financial statements. Restricted funds may only be transferred to general or designated funds once the criteria for restriction have been discharged or no longer apply.

d) Income

Income is recognised when the charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received. Cash donations are recognised on receipt. Other donations are recognised once the charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

e) Donated services and facilities

In accordance with the Charities SORP (FRS 102), the general volunteer time of supporters is not recognised.

f) Expenditure and irrecoverable VAT

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably. Expenditure is classified under the following activity heading:
- Expenditure on charitable activities comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

f) Expenditure and irrecoverable VAT ctd...

All costs are allocated between the expenditure categories of the Statement of Financial Activities on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly, others are apportioned on an appropriate basis.

Irrecoverable VAT is charged as a cost against the activity for which the expenditure was incurred.

g) Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation.

Depreciation is provided at rates calculated to write off the cost or valuation of fixed assets, less their estimated residual value, over their expected useful lives on the following basis:

Property	2% on cost
Office equipment	20% reducing balance
Gym equipment	10% on cost
Sports clothing and equipment	50% on cost

The carrying values of tangible fixed assets are reviewed for impairment when events or circumstances indicate the carrying value may not be recoverable.

h) Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid after taking account of any trade discounts due.

i) Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term current accounts.

j) Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

k) Financial instruments

The trust only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at the carrying value plus accrued interest less repayments. The financing charge to expenditure is at a constant rate calculated using the effective interest method.

l) Taxation

The company is a registered charity and the charitable tax exemptions are therefore being claimed to the extent that income and/or gains are applicable and applied to charitable purposes only. These exemptions will remain in place as long as income and expenditure is applied to charitable purposes only.

We are very privileged to be invited into schools in the mid and east antrim area - 17 in total including primary and secondary level, which allows us to share the Gospel with 2000 young people weekly. Alongside this we offer programmes which are age relevant and offer help around issues that the young people are facing, such as bullying, poor mental health and low self-worth. The recorded outcomes have been very encouraging so much so that we have been asked to outreach into more schools in the wider N.I. area. The Vision for our schools'

work is tremendous and we are working alongside the schools to offer Leadership Training and Development. We have also been asked to offer our services within the schools' curriculum for PE and sports which we have introduced in the last year. We are also involved in running three schools' teams.

As the relationship with schools grows the coaches are getting more opportunities to share in School Assemblies.

We currently have a waiting list of schools, and we continue to offer opportunities for further volunteer coaches to help make all this reality.

As a full time, team, we actively look at our personal development in areas relevant such as coach education with 3 of our coaches obtaining their 'C' Licence and progressing onto completing their 'B' licence in the next year. We have one new full-time – self-employed coach.

Our New Young Volunteer Initiative continues to be a huge success where we offer the opportunity to shadow our coaches and for the coaches to mentor them in a physical and spiritual capacity.

Training Ground was launched in September 2022 and is *an online community created to IMPART wisdom and IMPRINT our vision so people can IMPACT their world.*

Four main themes of teaching.

- EVANGELISM: ENCOURAGE- *Encourage people to know Jesus*
- DISCIPLESHIP: EQUIP- *Equip people to follow Jesus*
- LEADERSHIP: *Empower people to live like Jesus*
- COACH EDUCATION-*Coach Education/Coaching Sessions*


