## **Trustees' Annual Report for the year ended 5 April 2024**

The Trustees present their Annual Report and Statements of Receipts and Payments and Assets and Liabilities for the year ended 5 April 2024.

### **Objectives and Activities**

The Trustees are responsible for all the assets of the Trust Fund and the administration of Trustee meetings.

The Charity makes financial donations to chosen recipient charities which are active in delivering practical aid and provision to needy situations. A Memorandum of Wishes, signed by Morris and Sally Phillips on 21 December 2007, has been distributed to all Trustees for their guidance. The following extract from that document sets out the purposes of the Charitable Trust:

“In principle, we would anticipate the funds being applied – as the Trustees direct – in furtherance of the following (although this is not intended to be an exhaustive list and is simply by way of example):

- (a) the relief of hardship now and for the future through the furtherance of general education and the promotion of the Christian faith in underdeveloped countries;
- (b) the provision of funding to help disaster recovery, where that occurs within the world;
- (c) the development of missionary work throughout the world;
- (d) the support of charities involved in a) to c) above which illustrate good stewardship by applying a large percentage of donations received to the work on the ground;
- (e) the support of charities operating in the United Kingdom on behalf of needy causes considered by the Trustees to be worthy of assistance.”

### **Achievements, Performance & Public Benefit**

The Charity has given careful consideration to the Charity Commission for Northern Ireland's guidance on public benefit to ensure that the activities entered into during the year have helped to achieve the Charity's objectives and activities, as well as providing public benefit.






