Annual report for the year ended 31 March 2024

The Trustees of the Thomas Devlin Fund are pleased to present the annual report for the year ended 31 March 2024.

Achievements and Performance

In this document we are reporting on activities including grants awarded in the 2023/2024 round for the Thomas Devlin Fund Individual Bursaries.

Summary

In 2023-2024 the Fund was in its seventeenth year of operation, offering awards of up to £1750 to young people between the ages of 15 and 19 in order to pursue a career or study in fine and creative arts including moving images and literacy art, the performing arts or music.

Grant Analysis and Applications Supported

CFNI administer the arrangements for the Bursaries on behalf of the Thomas Devlin Fund. Following agreement at a meeting with CFNI on 8 February 2023, the application process was opened on 6 March 2023 and closed on 5 April 2023.

The Guidance notes had been reviewed and revised in discussion with CFNI. The Advisory Panel met on 17 May 2023 to review applications and allocate the bursaries.

A total of 16 applications were received and 11 were successful. The total amount awarded in this round was £17180 and the average award was £1562

The Advisory Panel were pleased with the number and quality of the applications in the 2023 round.

Feedback has been received from the individual bursary winners. The individual award winners have sent feedback on their use of the bursaries to the Trustees via responses through CFNI together with information as to how the bursary has benefitted them as individuals. One successful applicant has subsequently been awarded a full bursary

for a Music degree course at Brandeis University in Boston USA following his attendance at the weeklong residential that was supported by the Fund.

Examples of bursaries awarded include:

- Support for attendance at the Berklee College of Music's singing and piano week long residential program in Boston, Massachusetts, USA
- Support for harpsichord lessons at Royal Irish Academy of Music
- Support for Diploma in Professional Dance based in Manchester

A further meeting of the Trustees and CFNI was held on 18th January 2024 to discuss the application process for 2024. It was agreed that the Fund would open for applications on 19 February 2024 and close on 25 March 2024 with a date of 23 May 2024 agreed for a meeting of the Advisory Panel to consider applications. The outcome of this process will be reported in the Annual Report ending on 31 March 2025. A meeting was held with INVESTEC on 18 January 2024 to discuss the investment strategy for the Endowment Fund.

3. Public Benefit Statement

The Trustees of the Thomas Devlin Fund confirm they have complied with their duty and have had regard to the Charity Commission Northern Ireland's Public Benefit Statutory Guidance in their activities throughout the year.

The benefits which flow from the activities outlined above include enhanced educational skills and qualifications and increased participation in the creative arts and music by young people in Northern Ireland.

These benefits have been demonstrated through feedback from bursary recipients.

No harm has been identified from this purpose.

The benefits of this purpose are provided to young people in Northern Ireland.

There is no private benefit from this purpose.

4. Financial Position at the end of the financial year 31 March 2023

The opening balance of the Danske Bank Account was £13,304. The closing balance of the Danske Bank Account at 31 March 2024 was £13,387. A signed independent full statement of accounts is registered with the Charity Commission NI. The Fund has no debts. These accounts were approved by the Treasurer and Chairperson and independently examined.

The Thomas Devlin Fund also holds a restricted endowment fund with the Community Foundation for Northern Ireland. This fund is managed by the Community Foundation and invested for the long term to generate funds each year for bursaries. We work in partnership with the Community Foundation each year to deliver the bursary scheme which supports gifted young people offering exciting and unique opportunities to develop their skills and talent in music and the arts. The value of the endowment fund at 31 March 2024 was £229,185

Annual report for the year ended 31 March 2023

The Trustees of the Thomas Devlin Fund are pleased to present the annual report for the year ended 31 March 2023.

Achievements and Performance

In this document we are reporting on activities including grants awarded in the 2022/2023 round for the Thomas Devlin Fund Individual Bursaries.

Summary

In 2022-2023 the Fund was in its sixteenth year of operation, offering awards of up to £1750 to young people between the ages of 15 and 19 in order to pursue a career or study in fine and creative art including moving images.

Grant Analysis and Applications Supported

In January 2022 and following a discussion with CFNI the Trustees agreed to re-open the Fund for applications for individual bursaries. The Fund had been closed for two years during the COVID-19 Pandemic. The application process was opened on 7 March 2022 and closed on 18 April 2022.

The Guidance notes had been reviewed and revised in discussion with CFNI. The Advisory Panel met on 9 May 2022 to review applications and allocate the bursaries.

A total of 11 applications were received and 5 were approved. The amount awarded in this round was £6325 and the average award was £1265.

Following the closure of the Fund for two years the Advisory Panel were pleased with the number and quality of the applications.

Feedback has been received from both the individual bursary winners. The individual award winners have sent feedback on their use of the bursaries to the Trustees via responses through CFNI together with information as to how the bursary has benefitted them as individuals.

Examples of bursaries awarded include:

- Support for study of French Horn at Royal Conservatoire in Scotland
- Support for study at Urdang Dance Academy in London
- Support for attendance to a printmaking course in Chichester

A further meeting of the Trustees and CFNI was held on 8th February 2023 to discuss the application process for 2023. It was agreed that the Fund would open for applications on 6 March 2023 and close on 5 April 2023 with a date of 17 May 2023 set for a meeting of the Advisory Panel to consider applications. The outcome of this process will be reported in the Annual Report ending on 31 March 2024
