Trustees Report for Financial Year 1st January 2024 - 31st December 2024

Main Activities/Achievements

In this financial year, the next phase of our restoration has almost been completed. The internal gable wall at the back of the church where we had discovered dry rot and all the plaster and timber had been removed in 2023, the stonework has now been pointed with a lime mortar.

We also removed eight pews from the back of the church on the left side. A few tables and chairs have been placed in this area and is used for serving refreshments after family service once a month or any other special morning service. This is known as The Alexander Corner.

The old toilet and kitchen facilities were removed, this area has been replaced with a kitchenette and a store to keep surplus chairs and tables when not in use.

A new oil heating system was installed replacing the old electric heating system.

Various fundraising events organised by the parishioners took place, which amounted to a total of £2,040 being raised.

No grants were received in 2024.

We continue to recover the VAT element through the listed places of worship scheme.

As in previous years, our parishioners continue to use their monthly envelopes to support this project.
