We had 14 girls join our Brownie Pack this year, they said their Promise at our Annual Ceremony where they were presented with their Promise Badge and we had a celebration with the whole Brownie Pack parents were invited in to watch the ceremony and we sang campfire songs.

We took part in the Remembrance Day Parade and service in Hillsborough with other uniformed organisations.

We went to the Girlguiding showing of Wish in the Odeon cinema in Belfast as our Christmas outing.

We completed many crafts, including a room in a shoebox, a Christmas tree decoration and firework pictures, we explored different techniques for painting. We also learned how to use tools like hammers and screwdrivers properly and learned how to change a plug and made plaques of the Guiding Trefoil by hammering nails into wood.

As an end of year celebration we had a Fun Day at Lorne where the girls enjoyed taking part in archery, the High Ropes course and playing games.

The Brownies all completed one of the Theme awards from our programme and these badges were presented to the girls on our penultimate night of Brownies.

There was no harm flowing from the Charities purposes and there was no private benefit.
