### **FINANCIAL REVIEW**

#### **Overview**

The charity incurred a deficit of £18,195 in the year ended 30 September 2025 (2024: deficit of £16,504).

#### **Incoming resources**

Total incoming resources for the year were £29,964 (2024: £33,325). A National Lottery grant of £20,000 was received in July 2025 and the income for this will be recognised in the year ended 30th September 2026 together with corresponding expenditure. The charity continues to be thankful for peoples' wonderful efforts and generosity.

#### **Total resources expenses**

Total resources expended were £48,158 (2024: £49,829) for the year ended 30 September 2025. It must be noted that included in expenses is depreciation of the building amounting to £21,547 (2024: £21,547).

#### **Balance sheet**

Net funds are positive at £88,794 (2024: £106,989) as at 30 September 2025.

#### **Reserves policy**

The charity's policy is to maintain a level of free reserves which meets the needs of the Company both at the current time and for the foreseeable future. Free reserves are its total funds excluding restricted funds, and designated funds. The Company had £15,892 (2024: £18,034) free reserves at 30 September 2025.

#### **Future developments**

The charity remains true to its founding principles "to promote the benefit of the community of the Tullysaran area".

Future plans for the centre focus on cutting running costs while reducing environmental impact. We installed solar panels in August 2025 to generate our own electricity and lower energy bills long term. We aim to switch all lighting to LED to cut power use immediately and last longer than standard bulbs.

### **STRUCTURE, GOVERNANCE AND MANAGEMENT**

#### **Governing document**

The Charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

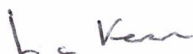

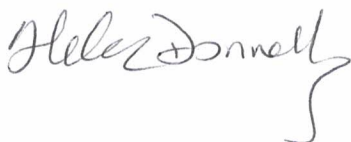

**1 Accounting policies**

***Basis of preparing the financial statements***

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

***Income***

***Depreciation***

Depreciation has been provided at the following rates in order to write off the assets over their estimated useful lives.

Fixtures, fittings and equipment

Straight line over 15 years

***Taxation***

The charity is exempt from corporation tax on its charitable activities.

***Expenditure***

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings that have been allocated to activities on a basis consistent with the use of resources.

***Fund accounting***

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

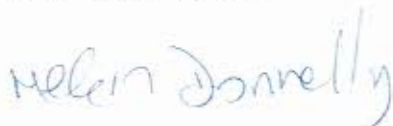

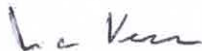

**1 Accounting policies**

***Basis of preparing the financial statements***

We acknowledge funding from Covid Recovery Programme from Department of Communities which was a lifeline for us to help us get back on our feet again after the effects of covid on our charity.

#### **FINANCIAL REVIEW**

##### **Overview**

The company incurred a deficit of £22,089 in the year ended 30 September 2022 (2021: deficit of £27,913).

##### **Incoming resources**

Total incoming resources for the year were £18,026 (2021: £14,495). The charity continues to be thankful for peoples' wonderful efforts and generosity.

##### **Total resources expenses**

Total resources expended were £40,115 (2021: £42,408) for the year ended 30 September 2022. It must be noted that included in expenses is depreciation of the building amounting to £21,547 (2021: £21,547).

##### **Balance sheet**

Net funds are positive at £145,203 (2021: £167,292) as at 30 September 2022.

##### **Reserves policy**

The charity's policy is to maintain a level of free reserves which meets the needs of the Company both at the current time and for the foreseeable future. Free reserves are its total funds excluding restricted funds, and designated funds. The Company had £14,719 (2021: £14,955) free reserves at 30 September 2022.

##### **Future developments**

The charity remains true to its founding principles "to promote the benefit of the community of the Tullysaran area".

It is hoped that a Youth Club will be set up in the near future.

#### **STRUCTURE, GOVERNANCE AND MANAGEMENT**

##### **Governing document**

The Charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

**Basis of the independent examiner's report**

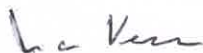
