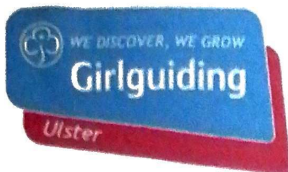

We took part in the annual Guide concert where prizes were distributed and entertainment was provided for approximately 140 parents and friends. We also contributed to the community at Christmas by Carol singing to the elderly and providing them with a Christmas gift. There was no harm flowing from the Charities purposes and that there was no private benefit.
