Principal Activities

The principal activity of the charitable company continue to be that of property rental. Carnlough Community Development Group provides office, workspace and retail space to community groups and small businesses on favourable terms as well as general support to community sector organisations.

The Trustees are satisfied that the charity has achieved its objectives in the year under review.

Financial Review

Total incoming resources amounted to £8,600 (2024 - £9,950) and after deducting total resources expended of £18,600.37 (2024 - £8,374.75) net incoming resources amounted to (£10,000.37) (2024 - £1,575.25).

At the year-end unrestricted funds amounted to (£3,483), there were no restricted funds.

The Trustees' Report

The trustees of the charity, present their report and the financial statements for the year ended 31 March 2023.

Principal Activities

The principal activity of the charitable company continue to be that of property rental. Carlough Community Development Group provides office, workspace and retail space to community groups and small businesses on favourable terms as well as general support to community sector organisations.

The Trustees are satisfied that the charity has achieved its objectives in the year under review.

In accordance with the Articles of Association Trustees shall be elected by the members at an Annual General Meeting.

The Trustees have assessed major risks to which the charitable company is exposed, in particular those related to the operations and finances, and are satisfied that systems are in place to mitigate exposure.

Financial Review

Total incoming resources amounted to £9,750 (2022 - £8,550) and after deducting total resources expended of £4,808 (2022 - £6,538) net incoming resources amounted to £4,942 (2022 – (£2,012)).

At the year-end unrestricted funds amounted to £8,795, there were no restricted funds.

Statement of Trustees/Directors' Responsibilities

The Trustees/Directors are responsible for preparing the Trustees/Directors' Annual Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).


- select suitable accounting policies and then apply them consistently;


My role is to state whether any material matters have come to my attention giving me cause to believe:




