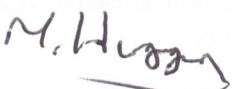

1.ACCOUNTING POLICIES

Basis of Preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice, applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the United Kingdom and Ireland (FRS 102) (effective 1 January 2015) – (Charities SORP (FRS102)), the Financial Reporting Standard applicable in the United Kingdom (FRS102)- (Charities SORP(FRS102)).

The preparation of financial statements in compliance with FRS102 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the Charities accounting policies.

The financial statements have been prepared under the historical cost convention. The financial statements include all transactions, assets and liabilities for which the company is responsible in law. The Charity meets the definition of a public benefit entity under FRS (remove space)102.

The following principal accounting policies have been applied:

Going Concern

The financial statements are prepared on the going concern basis.

Funding Accounting

General funds are unrestricted funds which are available for use at the discretion of the Directors in furtherance of the objectives of the Charity and have not been designated for other purposes. Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for specific purposes. Costs relating to such funds are charged against the specific fund.

Incoming Resources

All incoming resources are included in the Statement of Financial Activities when the charity is legally entitled to the income, normally on receipt.

Tangible Fixed Assets and Depreciation

Fixed assets comprise the premises at 45, and 47, Mount Street, Ballymena. 45 Mount Street was previously included in the balance sheet at £85,000 in line with an independent valuation obtained in 2017. During 2022 47 Mount Street was purchased at a cost of £54,127. During the financial years ended 31 March 2023 and 31 March 2024 the premises were amalgamated and an initial £36,290 was spent on renovation.

Tangible Fixed Assets and Depreciation (continued)

During the year ending 31 March 2025 the premises were further developed at a cost of £119,371. On 28th February 2025 following completion of the works an independent professional valuation of £200,000 was obtained and is now reflected in the balance sheet. The revaluation reserve has been updated accordingly and the cost of the renovations shown in the income and expenditure account.

Resources expended

All expenditure is accounted for as incurred and has been classified under headings that aggregate all costs related to that category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with use of resources. Support costs have been allocated on the basis of spend to programme areas and to Fundraising and Governance activities. The Charity is not registered for VAT, thus all costs are shown inclusive of VAT charged.

Volunteer help

The value of any voluntary help received is not included in the accounts, in line with the SORP (FRS 102).

Cash on hand

Cash consists of cash on hand and on deposit.

Taxation

The Charity is not liable to corporation tax or capital gains tax on its charitable activities.

Directors' Report

for the year ended 31 March 2024

The Directors hereby present their report and financial statements, together with the independent examiner's report, for the year ended 31 March 2024.

Structure, Governance and Management

Samaritans of Ballymena was incorporated on 21 April 2017 and is a Private Company, Limited by Guarantee.

Management, Internal Control and Risk Management

The management of the Charity is the responsibility of the Directors of the Charity, who are responsible for the implementation of Samaritans strategy and to support the work of Samaritan volunteers in the Charity.

The Directors have the overall responsibility for the system of internal control for the Charity, including the safety of Charity assets and the integrity of the accounting procedures.

Public Benefit Statement

Samaritans of Ballymena offer support to those at risk of suicide by being there to listen and encourage the recognition and exploration of their options. By doing so we aim to help people find ways of coping with their distress without choosing to die by suicide. We also seek to support those whose distress is less acute, in the hope that they will not reach the point of feeling that they wish to end their lives. We make our support available in many ways, including by telephone, live chat, email, and letter.

Samaritans' service is open to people who are suicidal, despairing or in distress. The branch provides a service primarily intended for the benefit of persons in Ballymena and the surrounding area. However, it also works with all Samaritans branches to ensure 24-hour availability of the service across the UK.

The Directors confirm that they have referred to the Charity Commission's guidance on public benefit when reviewing the Branch's aims and objectives in planning future activities.

Directors' Report

for the year ended 31 March 2024

Objectives and Activities

The objects of the Charity are:

- (a) to enable persons in Ballymena and the surrounding area (but without specific limitations as to area) who are experiencing feelings of distress or despair, including those who may be at risk of suicide, to receive confidential emotional support at any time of the day or night in order to improve their emotional health and to reduce the incidence of suicide;
- (b) to promote a better understanding in society of suicide, suicidal behaviour and the value of expressing feelings which may otherwise lead to suicide or impaired emotional health; and
- (c) to collaborate with and support the Samaritans Central Charity and its affiliated branches in fulfilling these objectives.

Mission and Values

Samaritans' **Vision** is that fewer people die by suicide. We work to achieve this by making it our **Mission** to alleviate emotional distress and reduce the incidence of suicidal feelings and suicidal behaviour. We do this by:

- being available round the clock to provide emotional support for people who are experiencing feelings of emotional distress or despair, including those which may lead to suicide;
- reaching out to high-risk groups and communities to reduce the risk of suicide;
- working in partnership with other organisations, agencies and experts to achieve our Vision; and
- influencing public policy and raising awareness of the challenges of reducing suicide.

Outreach and Awareness Raising

Throughout the year Ballymena Samaritans provided outreach activities within the community, both to groups who may be at increased risk of suicide and to raise awareness of how to promote emotional wellbeing and good mental health. Our emphasis is on prevention, information giving and skills building.

In September and October 2023, we attended Freshers week in local colleges.

In November we were invited to a local grammar school where we gave a speech to a group of about 150, 6th formers. The speech dealt with problems associated with young people in today's society and how the Samaritans can provide non-judgmental support for everyone no matter what age.

In December we received an invitation to the Mayor's Parlour in recognition of the work we do raising awareness within the local community.

In February 2024 we spoke at the club for retired people and at a local U3A group.

Between February 22nd and 19th March, we were involved with the 'Small Talk Saves Lives' campaign where a group of volunteers went to Ballymena Train Station on a number of occasions to raise awareness among the community.

In March the Mid Antrim 150 club invited us to their 2 day annual show.

We were also asked back to participate in an event at one of the local colleges.

Financial Review

At the year-end, the charity had unrestricted funds of £173,841.

The principal sources of income were donations from the public. With the exception of the current building works, expenditure is focused on core service provision, together with property maintenance and running costs. Income and expenditure for the year were £18,744 and £33,275 respectively, resulting in a deficit of £14,531.

Principal Risks

The principal risks facing the branch are insufficient volunteers to keep the branch open and the possibility of breach of confidentiality.

- New volunteer recruitment is essential to ensure that we always have adequate cover. Through a comprehensive training programme, with the theory and role-play once again delivered face-to-face to 10 new volunteers, we have maintained 59 listening volunteers at the year end.
- Fundraising is also essential in order to meet running costs as well as to pay a contribution to the central charity towards the costs of the services and systems, without which branches could not operate.

- A corner-stone of Samaritans' service is that all those who contact us are guaranteed absolute confidentiality. Policies and procedures, including DBS checks for all volunteers, are in place to reduce the possibility of inadvertent breach of confidentiality.

Directors' Report

Reserves policy

As branch income is heavily dependent on donations and fundraising activities it cannot be guaranteed. The directors consider that around 18 months of annual, non-capital, expenditure (£17,000) is an appropriate level of reserves to maintain in order to meet working capital needs. Expendable reserves, which excludes fixed assets, were £173,841 at the year-end (2023: £191,274).

Appointment of Directors

Directors are elected by the members of the Branch at the Annual General Meeting. Appointment of the Director is subject to approval by the Samaritans Central Charity.

Organisational Structure

The Branch Board, which is responsible for the day-to-day management of the charity, meets on a monthly basis.

Samaritans of Ballymena is a recognised branch of Samaritans, a company limited by guarantee (No 757372), having its registered office at The Upper Mill, Kingston Road, Ewell, Surrey KT17 2AF.

The Branch operates entirely through its dedicated volunteers without whom the service could not be provided.

Induction and Training of Directors

Directors are inducted and trained in accordance with Samaritans' national policy.

Training and new recruits

Two training programmes were completed this year, with 10 new recruits completing their training and being registered on the Register of Members. Six new recruits were selected for the spring 2024 training programme.

Statement of responsibilities of members of the Board in respect of Financial Statements


The Trustees (who are also the Directors of Samaritans of Ballymena for the purposes of company law) are responsible for preparing the Report of the Trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice) including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland'.

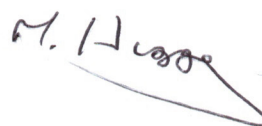
- select suitable accounting policies and then apply them consistently;

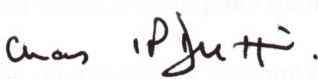

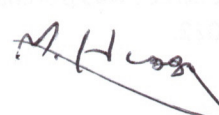

Details of historic costs of the building at 45, Mount Street are not available and as a result an independent valuation of £85,000, obtained in 2017, is included in the accounts. During 2022 47 Mount Street was purchased at a cost of £54,127. Land and Buildings were valued at £139,127 at 1st April 2022.

Tangible Fixed Assets and Depreciation (continued)

In the year ending 31 March 2023, £33,388 was spent on the installation of a lift and the valuation was increased to £172,515. In the year ending 31 March 2024 £2,902 was spent on fees related to the renovation of the property and the valuation was increased to £175,417.

During the year ending 31 March 2025 there are plans to further develop the premises. A builder's quotation of £85,000 plus VAT has been accepted. The work is anticipated to commence by 31/07/24 and will last for approximately 6 months. The additions will be capitalized and added to the 31st March 2024 valuation of £175,417.

By 31st March 2025 an independent valuation will be obtained and included in the accounts. The shortfall, if any, will be recorded as a deficit on revaluation.

Resources expended

All expenditure is accounted for as incurred and has been classified under headings that aggregate all costs related to that category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with use of resources. Support costs have been allocated on the basis of spend to programme areas and to Fundraising and Governance activities. The Charity is not registered for VAT, thus all costs are shown inclusive of VAT charged.

Volunteer help

The value of any voluntary help received is not included in the accounts, in line with the SORP (FRS 102).

Outreach and Awareness Raising

Throughout the year Ballymena Samaritans provided outreach activities within the community, both to groups who may be at increased risk of suicide and to raise awareness of how to promote emotional wellbeing and good mental health. Our emphasis is on prevention, information giving and skills building.

In September and October 2023, we attended Freshers week in local colleges.

In November we were invited to a local grammar school where we gave a speech to a group of about 150, 6th formers. The speech dealt with problems associated with young people in today's society and how the Samaritans can provide non-judgmental support for everyone no matter what age.

In December we received an invitation to the Mayor's Parlour in recognition of the work we do raising awareness within the local community.

In February 2024 we spoke at the club for retired people and at a local U3A group.

Between February 22nd and 19th March, we were involved with the 'Small Talk Saves Lives' campaign where a group of volunteers went to Ballymena Train Station on a number of occasions to raise awareness among the community.

In March the Mid Antrim 150 club invited us to their 2 day annual show.

We were also asked back to participate in an event at one of the local colleges.

Financial Review

At the year-end, the charity had unrestricted funds of £173,841.

The principal sources of income were donations from the public. With the exception of the current building works, expenditure is focused on core service provision, together with property maintenance and running costs. Income and expenditure for the year were £18,744 and £33,275 respectively, resulting in a deficit of £14,531.

Principal Risks

The principal risks facing the branch are insufficient volunteers to keep the branch open and the possibility of breach of confidentiality.

- New volunteer recruitment is essential to ensure that we always have adequate cover. Through a comprehensive training programme, with the theory and role-play once again delivered face-to-face to 10 new volunteers, we have maintained 59 listening volunteers at the year end.
- Fundraising is also essential in order to meet running costs as well as to pay a contribution to the central charity towards the costs of the services and systems, without which branches could not operate.

Expendable reserves, which excludes fixed assets, were £173,841 at the year-end (2023: £191,274).

Organisational Structure

The Branch Board, which is responsible for the day-to-day management of the charity, meets on a monthly basis.

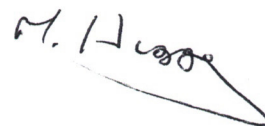

Outreach and Awareness Raising

For the first time since the Covid19 lockdown we had a stand at the Ballymena Agriculture Show and distributed leaflets with information about Samaritans. We were invited to attend a civic reception hosted by the borough's Mayor on the longest night, 21st December. This was reported in the local papers, raising awareness of the work of Samaritans. A number of articles were published throughout the year, encouraging people to take care of their mental health and informing them how to contact Samaritans if they needed our support. Our street collections were augmented with information stands at Tesco supermarkets in the local towns, including a collection on the 24th July to highlight Samaritans' availability around the clock (24:7). Volunteers attended the two day annual flower show in Antrim and took part in an awareness-raising walk to Lough Neagh on 21st June, the longest day of the year. The Mid Antrim 150 motorcycle club continues to have the branch as their nominated charity and volunteers attended their meeting in Ballymena Rugby Club building in November to raise awareness of Samaritans among the club members. They invited us to attend the two-day Ballymoney Motorcycle Show in March and a rota of volunteers ensured we were available to speak to people throughout the event.

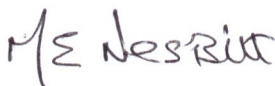

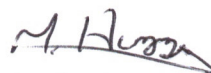

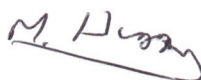

1.ACCOUNTING POLICIES

Basis of Preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice, applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the United Kingdom and Ireland (FRS 102) (effective 1 January 2015) – (Charities SORP (FRS102)), the Financial Reporting Standard applicable in the United Kingdom (FRS102)- (Charities SORP(FRS102)).

Structure, Governance and Management

Samaritans of Ballymena was incorporated on 21 April 2017 and is a Private Company, Limited by Guarantee.

Management, Internal Control and Risk Management

The management of the Charity is the responsibility of the Directors of the Charity, who are responsible for the implementation of Samaritans strategy and to support the work of Samaritan volunteers in the Charity.

Public Benefit Statement

Samaritans of Ballymena offers support to those at risk of suicide by being there to listen and encourage the recognition and exploration of their options. Outreach and Awareness Raising

For the first time since the Covid19 lockdown we had a stand at the Ballymena Agriculture Show and distributed leaflets with information about Samaritans. We were invited to attend a civic reception hosted by the borough's Mayor on the longest night, 21st December. This was reported in the local papers, raising awareness of the work of Samaritans. A number of articles were published throughout the year, encouraging people to take care of their mental health and informing them how to contact Samaritans if they needed our support. Our street collections were augmented with information stands at Tesco supermarkets in the local towns, including a collection on the 24th July to highlight Samaritans' availability around the clock (24:7). Volunteers attended the two day annual flower show in Antrim and took part in an awareness-raising walk to Lough Neagh on 21st June, the longest day of the year. The Mid Antrim 150 motorcycle club continues to have the branch as their nominated charity and volunteers attended their meeting in Ballymena Rugby Club building in November to raise awareness of Samaritans among the club members. They invited us to attend the two-day Ballymoney Motorcycle Show in March and a rota of volunteers ensured we were available to speak to people throughout the event.

Financial Review

At the year-end, the charity had unrestricted funds of £191,274.

The principal sources of income were donations from the public and also grant funding. Among grants received was £1,000 received from the Black Santa Christmas sit-out. The purchase and installation of a lift at a cost of £33,000 is the first phase of ongoing renovations to 45 Mount Street. With the exception of the current building works, expenditure is focused on core service provision, together with property maintenance and running costs. Income and expenditure for the year were £24,205 and £12,207 respectively, resulting in a surplus of £11,998.

Principal Risks

The principal risks facing the branch are insufficient volunteers to keep the branch open and the possibility of breach of confidentiality.

- New volunteer recruitment is essential to ensure that we always have adequate cover. Through a comprehensive training programme, with the theory and role-play once again delivered face-to-face to 12 new volunteers, we have maintained the number of volunteers with 62 listening volunteers at the year end.
- Fundraising is also essential in order to meet running costs as well as to pay a contribution to the central charity towards the costs of the services and systems, without which branches could not operate.
- A corner-stone of Samaritans' service is that all those who contact us are guaranteed absolute confidentiality. Policies and procedures, including DBS checks for all volunteers, are in place to reduce the possibility of inadvertent breach of confidentiality.

Reserves policy

As branch income is heavily dependent on donations and fundraising activities it cannot be guaranteed. The directors consider that around 18 months of annual, non-capital, expenditure (£18,000) is an appropriate level of reserves to maintain in order to meet working capital needs. Expendable reserves, which excludes fixed assets, were £191,274 at the year-end (2022: £212,664).

Appointment of Directors

Directors are elected by the members of the Branch at the Annual General Meeting. Appointment of the Director is subject to approval by the Samaritans Central Charity.

Organisational Structure

The Branch Board, which is responsible for the day-to-day management of the charity, meets on a monthly basis.

Samaritans of Ballymena is a recognised branch of Samaritans, a company limited by guarantee (No 757372), having its registered office at The Upper Mill, Kingston Road, Ewell, Surrey KT17 2AF.

The Branch operates entirely through its dedicated volunteers without whom the service could not be provided.

Induction and Training of Directors

Directors are inducted and trained in accordance with Samaritans' national policy.

Training and new recruits

Dermot186, Recruitment Deputy Director, is the lead on the management of the Business Management Tool (BMT) as it is designed to assist in the recruitment of new volunteers. When potential volunteers are interviewed and accepted for training the BMT creates their individual Samaritans account and this enables them to access the online modules of the training programme.

Two training programmes were completed this year, with 12 new recruits completing their training and being registered on the Register of Members. Eight new recruits were selected for the spring 2023 training programme.

Kieran165, Training Deputy Director, organised the training to be delivered, face-to-face, in an outside venue to reduce the risk of Covid19 infection.

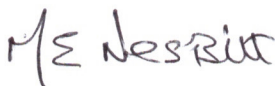

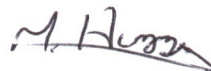

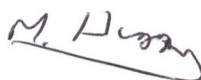

Objectives and Activities

The objects of the Charity are:

Outreach and Awareness Raising

For the first time since the Covid19 lockdown we had a stand at the Ballymena Agriculture Show and distributed leaflets with information about Samaritans. We were invited to attend a civic reception hosted by the borough's Mayor on the longest night, 21st December. This was reported in the local papers, raising awareness of the work of Samaritans. A number of articles were published throughout the year, encouraging people to take care of their mental health and informing them how to contact Samaritans if they needed our support. Our street collections were augmented with information stands at Tesco supermarkets in the local towns, including a collection on the 24th July to highlight Samaritans' availability around the clock (24:7). Volunteers attended the two day annual flower show in Antrim and took part in an awareness-raising walk to Lough Neagh on 21st June, the longest day of the year. The Mid Antrim 150 motorcycle club continues to have the branch as their nominated charity and volunteers attended their meeting in Ballymena Rugby Club building in November to raise awareness of Samaritans among the club members. They invited us to attend the two-day Ballymoney Motorcycle Show in March and a rota of volunteers ensured we were available to speak to people throughout the event.

Financial Review

At the year-end, the charity had unrestricted funds of £191,274.

The principal sources of income were donations from the public and also grant funding. Among grants received was £1,000 received from the Black Santa Christmas sit-out. The purchase and installation of a lift at a cost of £33,000 is the first phase of ongoing renovations to 45 Mount Street. With the exception of the current building works, expenditure is focused on core service provision, together with property maintenance and running costs. Income and expenditure for the year were £24,205 and £12,207 respectively, resulting in a surplus of £11,998.

Principal Risks

The principal risks facing the branch are insufficient volunteers to keep the branch open and the possibility of breach of confidentiality.

- New volunteer recruitment is essential to ensure that we always have adequate cover. Through a comprehensive training programme, with the theory and role-play once again delivered face-to-face to 12 new volunteers, we have maintained the number of volunteers with 62 listening volunteers at the year end.
- Fundraising is also essential in order to meet running costs as well as to pay a contribution to the central charity towards the costs of the services and systems, without which branches could not operate.
- A corner-stone of Samaritans' service is that all those who contact us are guaranteed absolute confidentiality. Policies and procedures, including DBS checks for all volunteers, are in place to reduce the possibility of inadvertent breach of confidentiality.

Reserves policy

As branch income is heavily dependent on donations and fundraising activities it cannot be guaranteed. The directors consider that around 18 months of annual, non-capital, expenditure (£18,000) is an appropriate level of reserves to maintain in order to meet working capital needs. Expendable reserves, which excludes fixed assets, were £191,274 at the year-end (2022: £212,664).

Appointment of Directors

Directors are elected by the members of the Branch at the Annual General Meeting. Appointment of the Director is subject to approval by the Samaritans Central Charity.

Organisational Structure

The Branch Board, which is responsible for the day-to-day management of the charity, meets on a monthly basis.

Samaritans of Ballymena is a recognised branch of Samaritans, a company limited by guarantee (No 757372), having its registered office at The Upper Mill, Kingston Road, Ewell, Surrey KT17 2AF.

The Branch operates entirely through its dedicated volunteers without whom the service could not be provided.

Induction and Training of Directors

Directors are inducted and trained in accordance with Samaritans' national policy.

Training and new recruits

Dermot186, Recruitment Deputy Director, is the lead on the management of the Business Management Tool (BMT) as it is designed to assist in the recruitment of new volunteers. When potential volunteers are interviewed and accepted for training the BMT creates their individual Samaritans account and this enables them to access the online modules of the training programme.

Two training programmes were completed this year, with 12 new recruits completing their training and being registered on the Register of Members. Eight new recruits were selected for the spring 2023 training programme.

Kieran165, Training Deputy Director, organised the training to be delivered, face-to-face, in an outside venue to reduce the risk of Covid19 infection.

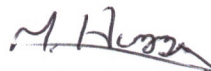

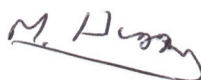

1.ACCOUNTING POLICIES

Basis of Preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice, applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the United Kingdom and Ireland (FRS 102) (effective 1 January 2015) – (Charities SORP (FRS102)), the Financial Reporting Standard applicable in the United Kingdom (FRS102)- (Charities SORP(FRS102)).

The preparation of financial statements in compliance with FRS102 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the Charities accounting policies.

The financial statements have been prepared under the historical cost convention. The financial statements include all transactions, assets and liabilities for which the company is responsible in law. The Charity meets the definition of a public benefit entity under FRS (remove space)102.

The following principal accounting policies have been applied:

Going Concern

The financial statements are prepared on the going concern basis.

Funding Accounting

General funds are unrestricted funds which are available for use at the discretion of the Directors in furtherance of the objectives of the Charity and have not been designated for other purposes. Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for specific purposes. Costs relating to such funds are charged against the specific fund.

Incoming Resources

All incoming resources are included in the Statement of Financial Activities when the charity is legally entitled to the income, normally on receipt.

Tangible Fixed Assets and Depreciation

Fixed assets comprise the premises at 45, and 47, Mount Street, Ballymena. Details of historic costs of the building at 45, Mount Street are not available and as a result an independent valuation of £80,000, obtained in 2017, is included in the accounts. During 2022 47 Mount Street was purchased at a cost of £59,127. Land and Buildings were valued at £139,127 at 1st April 2022.

Tangible Fixed Assets and Depreciation (continued)

This year, 2023, £33,388 was spent on the installation of a lift and the valuation was increased to £172,515.

During the current year there are plans to further develop the premises. The additions will be capitalized and added to the 31st March 2023 valuation of £172,515.

At 31st March 2024 an independent valuation will be obtained and included in the accounts. The shortfall, if any, will be recorded as a deficit on revaluation.

Resources expended

All expenditure is accounted for as incurred and has been classified under headings that aggregate all costs related to that category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with use of resources. Support costs have been allocated on the basis of spend to programme areas and to Fundraising and Governance activities. The Charity is not registered for VAT, thus all costs are shown inclusive of VAT charged.

Volunteer help

The value of any voluntary help received is not included in the accounts, in line with the SORP (FRS 102).

Cash on hand

Cash consists of cash on hand and on deposit.

Taxation

The Charity is not liable to corporation tax or capital gains tax on its charitable activities.
