Purposes of the Charity:

The Society was established to educate the public in all aspects of the history of Cullybackey and the immediate surrounding area by:

1. Collecting local historical material and artefacts
2. Input information on our website www.cullybackeyhistory.co.uk
3. Answer queries about local and family history received via email
4. Organise speakers for monthly meetings from September to May for public historical talks on local and other historical and cultural themes and to mix socially
5. To further the aims of the Society by giving talks about the history of Cullybackey and the surrounding area to other groups when asked

Main Activities and Achievements:

For everyone's safety the Society's Health and Safety Policy and Risk Register has been updated. This is done annually by our Health and Safety Officer.

The society held one event during the year for the benefit not only of its members but for all the community. This was on the 7th March 2024 when we had a very enjoyable evening with Mr Joe Mahon, from the TV programme Mahon's Way.

Quite a bit of outreach was carried out this year. The chairperson was asked to speak on the 4th April 2024 to the Friendship Group at Killymurriss Presbyterian Church, on the 15th April to the Pentagon Probus Group, the 1st November 2024 to the Mid-Antrim Bee-keeper's Association, the 26th November 2024 to the Friendship Group at Ballyclare Reformed Presbyterian Church, and on the 21st January 2025, to the Cullybackey Senior Citizens. The society also took a stall at the First Cullybackey Scouts Car Boot Sale on Friday 14th June 2024, and at the Killymurriss Presbyterian Church Vintage Day on the 14th September 2024.

A wreath was laid in November on Remembrance Sunday by the chairperson on the Society's behalf at a wreath laying ceremony organised by the Royal British Legion, Cullybackey Branch.

A new website has been built for the society which went live on the 5th December 2024, research has been carried out and more new material has been added.

There has been an opportunity to again promote the history of Cullybackey and the work of the Society this year.

Public Benefit:

The Society's beneficiaries are the general public, mainly in the Cullybackey and surrounding area who come together at our monthly lectures to listen to, discuss and reflect on the history and culture of Cullybackey and beyond and have a greater knowledge and a better understanding and appreciation of their local history and heritage. Members and visitors at our lectures also benefit socially as it gives people, especially those who are more isolated or live alone, the opportunity to meet together regularly, enjoy the company while learning together and talking to one another over a cup of tea.

Access to the information on our website is of great public benefit, not only to our own members, but to the wider community and to people worldwide. This enables a wide section of the population to have access to an educational facility and to have a greater understanding of the history of Cullybackey and the surrounding area.

Finance:

The Society was established to educate the public in all aspects of the history of Cullybackey and the immediate surrounding area by:

2. Input information on our website www.cullybackeyhistory.co.uk
3. Answer queries about local and family history received via email
4. Organise speakers for monthly meetings from September to May for public historical talks on local and other historical and cultural themes and to mix socially
5. To further the aims of the Society by giving talks about the history of Cullybackey and the surrounding area to other groups when asked

Main Activities and Achievements:

For everyone's safety the Society's Health and Safety Policy and Risk Register has been updated. This is done annually by our Health and Safety Officer.

The society held some events during the year for the benefit not only of its members but for all the community. On the 25th March 2023 a Coronation coffee morning and book sale was held in conjunction with the Cullybackey Branch of the Royal British Legion. On the 4th September 2023 the society hosted Canadian singer Ann Walker, whose ancestors originated from Cullybackey. Anne wrote a song entitled, "Cullybackey." The society received a large donation of books and this enabled it to hold a book sale on the 13th and 14th October 2023.

A wreath was laid at the memorial in Cullybackey by the chairperson on Remembrance Sunday on behalf of the society.

Quite a bit of outreach was carried out this year. The chairperson was asked to speak on the 28th April 2023 to the Ballymena History Group, on the 18th May to the Rasharkin History Group and on the 27th June 2023 the chairperson, along with Mr Bertie McNeilly from the Cullybackey Community Partnership, hosted visitors from the Ballymena Church Forum Walking Group, and later on the 9th August the chairperson of the society spoke to and did a walking tour of the village with a group from Kilrea and again on the 7th September with the Rasharkin History Group when they visited the village. On the 31st October the chairperson spoke to the Cullybackey Senior Citizens and on the 26th January 2024 the chairperson hosted

the Ballymena History Group on a walking tour of the village. Our chairperson did a recording on the 27th June 2023 for Radio Ulster's Ulster-Scots programme hosted by William Hill about the society's poetry collection, and on the 29th August 2023 a recording of Mahon's Way about Cullybackey in which the chairperson took part was broadcast. In May 2023 the society was asked to provide some photographs for Robinson's supermarket on the Cullybackey Road, for their new window after renovations.

More new material has been donated in October 2023 to the society for its archive in the form of postcards, and again some more postcards in January 2024, all addressed to local people. A wreath was laid on Remembrance Sunday by the chairperson on the Society's behalf at a wreath laying ceremony organised by the Royal British Legion, Cullybackey Branch.

There were 14 queries received via our website which have been answered. From the 1st February 2023 until the 31st January 2024 we had a total of 15,018 hits on our website, an average of 1,251 hits per month, which is an increase on the previous year.

Ongoing research has been carried out by some members and more material has been prepared for the Society's website and will be added. There has been an opportunity to again promote the history of Cullybackey and the work of the Society this year.
