TRUSTEES REPORT (INCLUDING DIRECTOR'S REPORT)

FOR THE YEAR ENDED 5 APRIL 2025

The trustees present their annual report and financial statements for the year ended 5 April 2025.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's memorandum, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)"

Objectives and activities

Coleraine Street Pastors involves 24 Christian volunteers from local interdenominational churches, including those from Coleraine, Ballymoney, Portstewart, Portrush and Castlerock. These volunteers commit to serving at least once a month, primarily in the evenings or at night, to listen, care for, and assist the community. The charity also includes a smaller group of Prayer Pastors who support the street teams by praying from their base or home. Volunteers receive training in areas such as drug and alcohol awareness, first aid, and suicide awareness. We collaborate with the Northern Ireland Housing Executive (NIHE), the Police Service of Northern Ireland (PSNI), and the local Policing and Community Safety Partnership (PCSP). These partners have noted that our weekend presence on the streets helps make Coleraine, Portrush, and Portstewart safer for those out at night.

We engage with the local community by listening to and talking with individuals to understand their needs and offer support or guidance. Our efforts positively impact those dealing with mental health issues, emotional distress, suicidal thoughts, substance abuse, financial difficulties, homelessness, domestic abuse, social isolation, and fear of crime. We also work with young people who may lack ambition and are at an increased risk of engaging in criminal activities.

On Friday nights, teams patrol Coleraine town centre, parks, the railway station, and retail areas to deter crime and antisocial behaviour while engaging with community members. In housing estates, our presence provides reassurance to older, lonely, or socially isolated residents who may feel vulnerable to such activities. We interact with teenagers to inform them about who the Street Pastors are and our role within the estates. Additionally, we visit youth clubs and mental health outreach centres to promote seeking help when needed.

On Saturday nights, teams of 3-4 volunteers patrol Portrush and Portstewart, focusing on nightlife around pubs and nightclubs. We aim to identify anyone who may be vulnerable to assault, assist individuals of all ages needing help, and ensure they arrive home safely. We also remove bottles and potential weapons to prevent violence and vandalism. Volunteers serve as a visible presence and mediators, helping to reduce tension and antisocial behaviour, which allows police officers to respond to more urgent community calls. Our presence during events, such as Easter Monday, emphasises our commitment to listening, caring, and helping keep people safe. We maintain a continuous presence to proactively address issues such as antisocial behaviour and ensure everyone's safety.

The trustees have considered the guidance issued by the Charity Commission in determining the charity's activities.

Achievements and performance

From April 6, 2024, to April 5, 2025, the charity has assisted approximately 1,500 individuals on the streets. Volunteers have collected and disposed of 432 bottles and glasses to prevent their potential use as weapons or to avert injuries among barefoot individuals. We have responded to antisocial incidents and distributed 102 street supplies to the public. Additionally, we provided first aid when needed and facilitated transportation for 84 individuals to ensure their safe return home.

During this period, our Street Pastor volunteers, both new and experienced, attended training sessions, including first aid training. Furthermore, we gave in-person presentations to community and Church groups to inform and educate them about our work.

Financial review

The charity's policy states that unrestricted funds not allocated for a specific purpose should be maintained at a level equivalent to three to six months' worth of expenditures. The trustees believe maintaining reserves at this level will ensure the charity can sustain its current activities in the event of a significant funding reduction. Concurrently, we are considering methods to secure additional funding. This reserve level has been consistently upheld throughout the year.

The trustees have assessed the significant risks to which the charity is exposed and are confident that systems are in place to mitigate these risks.

Our current balance sheet value is £9,058, which is £5,213 lower than last year.

Structure, governance and management

The Charity has held regular management meetings for the running of the project, and followed the guidelines for street pastors initiatives laid down by Ascension Trust (London), our umbrella body, supplying quarterly reports to our funders.

**INDEPENDENT EXAMINER'S REPORT



NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 5 APRIL 2025

1 Accounting policies

Charity Information

Coleraine Street Pastors is a private company limited by guarantee incorporated in Northern Ireland. The registered office is 14 Carthall Manor, COLERAINE, Co Londonderry, BT51 3GR.

1.1 Accounting convention

The financial statements have been prepared in accordance with the charity's governing document, the Companies Act 2006, FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Charities SORP "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)". The charity is a Public Benefit Entity as defined by FRS 102.

The charity has taken advantage of the provisions in the SORP for charities not to prepare a statement of cash flows.

The financial statements are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

1.2 Going concern

At the time of approving the financial statements, the trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

1.3 Charitable funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of their charitable objectives.

Restricted funds are subject to specific conditions by donors or grantors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

1.4 Incoming resources

Income is recognised when the charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

1.5 Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities.

Basic financial assets

Basic financial assets, which include debtors and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Financial assets classified as receivable within one year are not amortised.

Basic financial liabilities

TRUSTEES REPORT (INCLUDING DIRECTORS' REPORT)

FOR THE YEAR ENDED 5 APRIL 2024

The trustees present their annual report and financial statements for the year ended 5 April 2024.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's memorandum, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)"

Objectives and activities

Coleraine Street Pastors comprises 41 volunteers from local interdenominational Churches, including Coleraine, Ballymoney, Portstewart and Castlerock. These volunteers are committed to going out at least once a month at various times, usually evening or night, to Listen, Care and Help within the local community. The Charity has a smaller number of Prayer Pastors who support the teams out on the streets by praying from the base or home. Our volunteers are trained in various aspects of our work, from Drugs & Alcohol, First Aid to Suicide Awareness. We work in partnership with NIHE, PSNI and the local PCSP. These agencies have said that our presence on the streets at weekends makes Coleraine, Portrush and Portstewart safer for those out and about at night.

We listen to, talk to and get to know people in our local community to determine their needs and offer support or guidance. This makes the difference to those who are often dealing with mental health problems/emotional distress/suicidal ideation, tackling alcohol/drug addiction, living with debt worries/in poverty/coping with homelessness/domestic abuse, struggling with apathy/social isolation/fear of crime; or young people who have a general lack of ambition, who may be at increased risk of committing crime.

On Friday nights, teams patrol Coleraine town centre, parks, railway station, and retail park, deterring crime and antisocial behaviour and engaging with people. In housing estates, their presence reassures older, lonely, or socially isolated people who may feel vulnerable to antisocial behaviour. They engage with teenagers and explain who Street Pastors are and what they do on the estates. They also visit youth clubs and mental health outreach facilities to encourage people to seek assistance if required.

On Saturday nights, teams of 3-4 volunteers patrol Portrush and Portstewart, focusing on nightlife at pubs and nightclubs. Their aim is to look out for anyone who may be vulnerable to assault, support people of all ages who need help for various reasons, and ensure they get home safely. They remove bottles and potential weapons to discourage violence and vandalism. Volunteers are also a visual presence/mediator, which helps to reduce tension and anti-social behaviour and 'free up' Police officers to deal with more urgent calls from members of the community who need their help. There are other events throughout the year, e.g., Easter Monday, when our presence in 'listening, caring and helping keep people safe' is valued. We are represented on an ongoing basis, where issues such as anti-social behaviour are raised, to be proactive instead of reactive to ensure the safety of all.

The trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the charity should undertake.

Financial review

Over the period 6 April 2023 – 5 April 2024, the charity has helped approximately 1500 people on the streets. Volunteers have lifted and disposed of 478 bottles and glasses to prevent them from being used as lethal weapons or causing injury to people going barefoot. We have attended antisocial incidents and issued 137 street supplies to the public.

We have administered first aid, as required, and assisted 84 people in transport, ensuring they got home safely.

During this period, 22 of our more experienced Street Pastors attended a refresher training session, and we delivered First Aid training. We also gave in-person presentations to community and Church groups to inform and educate them about our work.

FOR THE YEAR ENDED 5 APRIL 2024

It is the policy of the charity that unrestricted funds, which have not been designated for a specific use, should be maintained at a level equivalent to between 3 and 6 months' expenditure. The trustees consider that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the charity's current activities while consideration is given to ways in which additional funds may be raised. This level of reserves has been maintained throughout the year. The trustees have assessed the major risks to which the charity is exposed, and are satisfied that systems are in place to mitigate exposure to the major risks.

Our current balance sheet value is £14,271.00, which is £7,019.00 lower than last year. While our charity's expenses this year are similar to those of the previous year, our income has fallen. This decline is primarily due to the charity receiving a significant one-time donation of £10,000 for the year ending in April 2023.

Our primary funding sources include support from local Churches and cash donations to our charity collection boxes. Moving forward, we plan to increase our funding by identifying more supporting Churches and applying for grants from charitable trusts and foundations.

1 Accounting policies

Charity information

Coleraine Street Pastors is a private company limited by guarantee incorporated in Northern Ireland. The registered office is 14 Carthall Manor, COLERAINE, Co Londonderry, BT51 3GR.

1.1 Accounting convention

The trustees present their annual report and financial statements for the year ended 5 April 2024.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's memorandum, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)"

Objectives and activities

Coleraine Street Pastors comprises 41 volunteers from local interdenominational Churches, including Coleraine, Ballymoney, Portstewart and Castlerock. These volunteers are committed to going out at least once a month at various times, usually evening or night, to Listen, Care and Help within the local community. The Charity has a smaller number of Prayer Pastors who support the teams out on the streets by praying from the base or home. Our volunteers are trained in various aspects of our work, from Drugs & Alcohol, First Aid to Suicide Awareness. We work in partnership with NIHE, PSNI and the local PCSP. These agencies have said that our presence on the streets at weekends makes Coleraine, Portrush and Portstewart safer for those out and about at night.

We listen to, talk to and get to know people in our local community to determine their needs and offer support or guidance. This makes the difference to those who are often dealing with mental health problems/emotional distress/suicidal ideation, tackling alcohol/drug addiction, living with debt worries/in poverty/coping with homelessness/domestic abuse, struggling with apathy/social isolation/fear of crime; or young people who have a general lack of ambition, who may be at increased risk of committing crime.

On Friday nights, teams patrol Coleraine town centre, parks, railway station, and retail park, deterring crime and antisocial behaviour and engaging with people. In housing estates, their presence reassures older, lonely, or socially isolated people who may feel vulnerable to antisocial behaviour. They engage with teenagers and explain who Street Pastors are and what they do on the estates. They also visit youth clubs and mental health outreach facilities to encourage people to seek assistance if required.

On Saturday nights, teams of 3-4 volunteers patrol Portrush and Portstewart, focusing on nightlife at pubs and nightclubs. Their aim is to look out for anyone who may be vulnerable to assault, support people of all ages who need help for various reasons, and ensure they get home safely. They remove bottles and potential weapons to discourage violence and vandalism. Volunteers are also a visual presence/mediator, which helps to reduce tension and anti-social behaviour and 'free up' Police officers to deal with more urgent calls from members of the community who need their help. There are other events throughout the year, e.g., Easter Monday, when our presence in 'listening, caring and helping keep people safe' is valued. We are represented on an ongoing basis, where issues such as anti-social behaviour are raised, to be proactive instead of reactive to ensure the safety of all.

The trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the charity should undertake.

Financial review

Over the period 6 April 2023 – 5 April 2024, the charity has helped approximately 1500 people on the streets. Volunteers have lifted and disposed of 478 bottles and glasses to prevent them from being used as lethal weapons or causing injury to people going barefoot. We have attended antisocial incidents and issued 137 street supplies to the public.

We have administered first aid, as required, and assisted 84 people in transport, ensuring they got home safely.

During this period, 22 of our more experienced Street Pastors attended a refresher training session, and we delivered First Aid training. We also gave in-person presentations to community and Church groups to inform and educate them about our work.

It is the policy of the charity that unrestricted funds, which have not been designated for a specific use, should be maintained at a level equivalent to between 3 and 6 months' expenditure. The trustees consider that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the charity's current activities while consideration is given to ways in which additional funds may be raised. This level of reserves has been maintained throughout the year. The trustees have assessed the major risks to which the charity is exposed, and are satisfied that systems are in place to mitigate exposure to the major risks.

Our current balance sheet value is £14,271.00, which is £7,019.00 lower than last year. While our charity's expenses this year are similar to those of the previous year, our income has fallen. This decline is primarily due to the charity receiving a significant one-time donation of £10,000 for the year ending in April 2023.

Our primary funding sources include support from local Churches and cash donations to our charity collection boxes. Moving forward, we plan to increase our funding by identifying more supporting Churches and applying for grants from charitable trusts and foundations.

Structure, governance and management

The Charity has held regular management meetings for the running of the project, and followed the guidelines for street pastors initiatives laid down by Ascension Trust (London), our umbrella body, supplying quarterly reports to our funders.



The company is entitled to the exemption from the audit requirement contained in section 477 of the Companies Act 2006, for the year ended 5 April 2023.


The directors acknowledge their responsibilities for complying with the requirements of the Companies Act 2006 with respect to accounting records and the preparation of financial statements.

1 Accounting policies

Charity information

Coleraine Street Pastors is a private company limited by guarantee incorporated in Northern Ireland. The registered office is 14 Carthall Manor, COLERAINE, Co Londonderry, BT51 3GR.

1.1 Accounting convention

The financial statements have been prepared in accordance with the charity's [governing document], the Companies Act 2006, FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the Charities SORP "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (effective 1 January 2019). The charity is a Public Benefit Entity as defined by FRS 102.

The charity has taken advantage of the provisions in the SORP for charities not to prepare a Statement of Cash Flows.

The financial statements are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

1.2 Going concern

At the time of approving the financial statements, the trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

1.3 Charitable funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of their charitable objectives.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

1.4 Incoming resources

Income is recognised when the charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

1.5 Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities.

Basic financial assets

Basic financial assets, which include debtors and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Financial assets classified as receivable within one year are not amortised.

Annual report

TRUSTEES REPORT (INCLUDING DIRECTORS' REPORT) FOR THE YEAR ENDED 5 APRIL 2023

The trustees present their annual report and financial statements for the year ended 5 April 2023.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's memorandum, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)"

Objectives and activities

Coleraine Street Pastors comprises 32 volunteers from local interdenominational Churches, including Coleraine, Ballymoney, Portstewart and Castlerock. These volunteers are committed to going out at least once a month at various times, usually evening or night, to Listen, Care and Help within the local community. The Charity has a smaller number of Prayer Pastors who support the teams out on the streets by praying from the base or home. Our volunteers are trained in various aspects of our work, from Drugs & Alcohol, First Aid to Suicide Awareness. We work in partnership with NIHE, PSNI and the local PCSP. These agencies have said that our presence on the streets at weekends makes Coleraine, Portrush and Portstewart safer for those out and about at night.

We listen to, talk to and get to know people in our local community to determine their needs and offer support or guidance. This makes the difference to those who are often dealing with mental health problems/emotional distress/suicidal ideation, tackling alcohol/drug addiction, living with debt worries/in poverty/coping with homelessness/domestic abuse, struggling with apathy/social isolation/fear of crime; or young people who have a general lack of ambition, who may be at increased risk of committing crime.

On Friday nights, teams patrol Coleraine town centre, parks, railway station and retail park, deterring crime and antisocial behaviour and engaging with people. In housing estates, their presence reassures older, lonely, or socially isolated people, who may feel vulnerable to anti-social behaviour. They engage with teenagers and explain who Street Pastors are and what they do on the estates. They also visit youth clubs and mental health outreach facilities to encourage people to seek assistance if required.

On Saturday nights, teams of 3-4 volunteers patrol Portrush and Portstewart, focusing on nightlife at pubs and nightclubs. Their aim is to look out for anyone who may be vulnerable to assault, support people of all ages who need help for various reasons, and ensure they get home safely. They remove bottles and potential weapons to discourage violence and vandalism. Volunteers are also a visual presence/mediator, which helps to reduce tension and anti-social behaviour and 'free up' Police officers to deal with more urgent calls from members of the community who need their help. There are other events throughout the year, e.g., St Patrick's Day, when our presence in 'listening, caring and helping keep people safe' is valued. We are represented on an ongoing basis, where issues such as anti-social behaviour are raised, to be proactive instead of reactive to ensure the safety of all.

The trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the charity should undertake.

Financial review

Over the period 6 April 2022 – 5 April 2023, the charity has helped approximately 1500 people on the streets. Volunteers have lifted and disposed of 375 bottles and glasses to prevent them from being used as lethal weapons or causing injury to people going barefoot. We have attended antisocial incidents and issued 105 street supplies to the public.

We have administered first aid, as required, and assisted 110 people in transport, ensuring they got home safely.

During this period, 28 of our more experienced Street Pastors attended a refresher training session, and we delivered First Aid training. We also gave in-person presentations to community and Church groups to inform and educate them about our work.

It is the policy of the charity that unrestricted funds, which have not been designated for a specific use, should be maintained at a level equivalent to between 3 and 6 months' expenditure. The trustees consider that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the charity's current activities while consideration is given to ways in which additional funds may be raised. This level of reserves has been maintained throughout the year.

The trustees have assessed the major risks to which the charity is exposed, and are satisfied that systems are in place to mitigate exposure to the major risks.

Structure, governance and management

The Charity has held regular management meetings for the running of the project, and followed the guidelines for street pastors initiatives laid down by Ascension Trust (London), our umbrella body, supplying quarterly reports to our funders.
