The information in this report refers to the 2024-2025 financial year.


### **Main Activities 2024-2025**

- Finance from Cairde Na mBráithre was used to support students with purchase of school uniform items, to subsidise costs for non-educational trips and support for transport for extra-curricular activities.
- Fundraising Event: A Gala dinner was held on Friday 12<sup>th</sup> April in the Armagh City Hotel to raise funds for Cairde Na mBráithre to support the work of the charity and to provide finance the costs of the CBS School Oratory when the Strule Campus opens in September 2025. Additional funding will also be required to supplement the provision of equipment in the IT, Science and Engineering classrooms to support students studying these specialist subjects.
- A donation was received from a former pupil of the school which was designated for the promotion of the Irish language in the school.
- Trustees were made aware that the reporting of the activities above is a legal requirement of the charity known as 'public benefit' reporting.




