The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 July 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The Charity's objects are to promote the benefit of the inhabitants of the Belvoir and Milltown areas and their environs without distinction of gender, sexual orientation, age, disability, race, ethnicity, or political, religious or other opinion and in particular to:-

(1) Advance community development by:

- (i) Providing facilities and support for community and voluntary groups and organisations;
- (ii) Organising community and family events and providing facilities for recreation and other leisure time occupations for those individuals who have need of such facilities by reason of their youth, age or social and economic circumstances or for the public at large;
- (iii) Promoting active citizenship and volunteering in the community;

FINANCIAL REVIEW

The company (Belvoir Community Hub) had net incoming resources for the year of £12,821. (2023 net incoming resources of £19,631. The Unrestricted fund at 31 July 2024 was £20,160 and the Restricted fund was £46,305. This is detailed on page 6 of the accounts.

The Company received grant income totalling £99,429, detailed on page 10, note 4. There was an Unrestricted fund surplus for the year of £7,141. This evidences the desire to create a sustainable organisation moving forward.

Review of the Year

This is the second full year that Belvoir Community Hub has operated with paid employees, including a Health & Wellbeing Manager and a part-time Administrator. Their presence has allowed for greater consistency, strategic planning, and the delivery of a broader range of high-quality services. Their work, alongside that of our dedicated volunteers, continues to strengthen Belvoir as a connected, resilient and inclusive community.

During the year, significant progress was made in consolidating the strategic direction and governance of the organisation. In November 2023, an independent Interim Review of Big Lottery funding was undertaken by Dr. Liz McShane and Gillian Gibson. The evaluation highlighted substantial achievements in engaging the community, attracting and supporting volunteers, and delivering meaningful services with and for local residents. The report's central recommendation was the development of a Strategic Plan to guide future direction and funding sustainability.

With the support of Collaboration Ireland, the Board and staff worked intensively to develop a Strategic Plan that would underpin all future operations. This Strategic Plan was officially launched at our Annual General Meeting in April 2024, marking a milestone in the Hub's evolution from a grassroots initiative to a structured, mission-driven organisation.

The Hub continued to deliver a diverse programme of community events and development activities, including:

- " A family-focused Summer Scheme,
- " Holistic health workshops,
- " Arts and cultural events,
- " Training programmes,
- " Personal development sessions, and
- " A Health Fair that brought together services, practitioners and residents to promote accessible and preventative wellbeing practices.

In line with our strategic focus on Education & Training, we delivered an NCFE-accredited course in Vegetable Growing to volunteers and local residents, combining community engagement with skills development. Our Healthy Homes project, funded by Belfast City Council, addressed healthy eating, cooking on a budget, and home wellbeing and mental health. It was well attended and provided practical support during a time of high economic pressure for many households.

Further progress was made in building maintenance and accessibility improvements, with targeted upgrades to better accommodate older adults and disabled community members, reinforcing our commitment to inclusion and dignity for all.

These activities directly supported the charity's three core focus areas:

- " Health & Wellbeing
- " Culture & Arts

" Education & Training

There has also been increased emphasis on environmental sustainability, reflecting the charity's belief that strong communities and sustainable living go hand-in-hand. This included practical engagement with community members on issues such as, community gardening, and responsible resource use.

We are acutely aware of the ongoing economic pressures facing our community, with many families and individuals experiencing hardship. The Board, staff and volunteers have responded with compassion and innovation, reshaping our services to offer greater support and ensure that Belvoir Community Hub remains a welcoming, respectful and inclusive space for all.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Risk management

The principles of good governance are embedded in all areas of the Hub's operations. Trustees take seriously their responsibility to ensure the organisation is protected from financial and reputational risk and that high standards are maintained throughout.

There is a strong working relationship between the Trustees, staff and volunteers, with regular oversight and communication to ensure all are aware of their responsibilities and feel equipped to uphold the values and practices of the charity.

CHARITABLE STATUS

The Trustees have registered the company as a charity with CCNI. The charity number is NIC 108405.

STATEMENT OF TRUSTEES' RESPONSIBILITIES

The trustees (who are also the directors of Belvoir Community Hub for the purposes of company law) are responsible for preparing the Report of the Trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice) including Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland".

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period. In preparing those financial statements, the trustees are required to

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charity SORP;
- make judgements and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company and to enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

FINANCIAL REVIEW

The company (Belvoir Community Hub) had net incoming resources for the year of £19,631. (2022 net incoming resources of £23,120. The Unrestricted fund at 31 July 2023 was £13,019 and the Restricted fund was £40,625. This is detailed on page 6 of the accounts.

The Company received grant income totalling £105,830, detailed on page 10, note 4. There was an Unrestricted fund surplus for the year of £11,483. This evidences the desire to create a sustainable organisation moving forward.

Review of the Year

The Charity's Policy is to retain a level of reserves, which matches the needs of the organisation both at the current time and in the foreseeable future. The charity has developed a plan to establish and maintain this agreed level of reserves. The charity will continue to monitor compliance with this policy on a regular basis and the Board will review the appropriateness

This is the first full financial year where Belvoir Community Hub have had paid employees in a Health & Wellbeing Manager and part-time Administrator. The result of this has resulted in a calculated growth of community-based engagement and opportunities, that contribute towards an inclusive, supportive and sustainable community organisation. This growth in the organisation has brought much needed partnership working towards a collective response to addressing local community needs. The year has seen the financial hardship of families and the emotional needs of individuals within the community grow. The board, staff and volunteers have reshaped their responses and partnerships in the attempt to provide a welcoming, respectful and inclusive space for everyone.

With our main grant income coming from the National Lottery, it has been important to reach out to other funding bodies and sustainable sources of income to ensure that the organisation is in a healthy and sustainable place to continue the important work moving forward. The staff have worked tirelessly with local volunteers to provide creative workshops, holistic health opportunities, community events, personal development and training opportunities with the aim of building a resilient and positive sense of community.

Our programmes this year have attempted to enhance the focus of our three core areas of work, Culture & Arts, Health & Wellbeing and Education & Training as well as promoting and implementing environmental engagement of the organisation and wider community. Sustainable living and sustainable community require a holistic and collective approach, which we aim to provide.





1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

Expenditure

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

FINANCIAL REVIEW

The company (Belvoir Community Hub) had net incoming resources for the year of £19,631. (2022 net incoming resources of £23,120. The Unrestricted fund at 31 July 2023 was £13,019 and the Restricted fund was £40,625. This is detailed on page 6 of the accounts.

The Company received grant income totalling £105,830, detailed on page 10, note 4. There was an Unrestricted fund surplus for the year of £11,483. This evidences the desire to create a sustainable organisation moving forward.

Review of the Year

The Charity's Policy is to retain a level of reserves, which matches the needs of the organisation both at the current time and in the foreseeable future. The charity has developed a plan to establish and maintain this agreed level of reserves. The charity will continue to monitor compliance with this policy on a regular basis and the Board will review the appropriateness

This is the first full financial year where Belvoir Community Hub have had paid employees in a Health & Wellbeing Manager and part-time Administrator. The result of this has resulted in a calculated growth of community-based engagement and opportunities, that contribute towards an inclusive, supportive and sustainable community organisation. This growth in the organisation has brought much needed partnership working towards a collective response to addressing local community needs. The year has seen the financial hardship of families and the emotional needs of individuals within the community grow. The board, staff and volunteers have reshaped their responses and partnerships in the attempt to provide a welcoming, respectful and inclusive space for everyone.

With our main grant income coming from the National Lottery, it has been important to reach out to other funding bodies and sustainable sources of income to ensure that the organisation is in a healthy and sustainable place to continue the important work moving forward. The staff have worked tirelessly with local volunteers to provide creative workshops, holistic health opportunities, community events, personal development and training opportunities with the aim of building a resilient and positive sense of community.

Our programmes this year have attempted to enhance the focus of our three core areas of work, Culture & Arts, Health & Wellbeing and Education & Training as well as promoting and implementing environmental engagement of the organisation and wider community. Sustainable living and sustainable community require a holistic and collective approach, which we aim to provide.





1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

FINANCIAL REVIEW

The company (Belvoir Community Hub) had net incoming resources for the year of £19,631. (2022 net incoming resources of £23,120. The Unrestricted fund at 31 July 2023 was £13,019 and the Restricted fund was £40,625. This is detailed on page 6 of the accounts.

The Company received grant income totalling £105,830, detailed on page 10, note 4. There was an Unrestricted fund surplus for the year of £11,483. This evidences the desire to create a sustainable organisation moving forward.

Review of the Year

The Charity's Policy is to retain a level of reserves, which matches the needs of the organisation both at the current time and in the foreseeable future. The charity has developed a plan to establish and maintain this agreed level of reserves. The charity will continue to monitor compliance with this policy on a regular basis and the Board will review the appropriateness

This is the first full financial year where Belvoir Community Hub have had paid employees in a Health & Wellbeing Manager and part-time Administrator. The result of this has resulted in a calculated growth of community-based engagement and opportunities, that contribute towards an inclusive, supportive and sustainable community organisation. This growth in the organisation has brought much needed partnership working towards a collective response to addressing local community needs. The year has seen the financial hardship of families and the emotional needs of individuals within the community grow. The board, staff and volunteers have reshaped their responses and partnerships in the attempt to provide a welcoming, respectful and inclusive space for everyone.

With our main grant income coming from the National Lottery, it has been important to reach out to other funding bodies and sustainable sources of income to ensure that the organisation is in a healthy and sustainable place to continue the important work moving forward. The staff have worked tirelessly with local volunteers to provide creative workshops, holistic health opportunities, community events, personal development and training opportunities with the aim of building a resilient and positive sense of community.

Our programmes this year have attempted to enhance the focus of our three core areas of work, Culture & Arts, Health & Wellbeing and Education & Training as well as promoting and implementing environmental engagement of the organisation and wider community. Sustainable living and sustainable community require a holistic and collective approach, which we aim to provide.





1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

Expenditure

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.
