It comprises of 8 adults who by grace and through faith are dedicated to helping others heal trauma and rise again out of the ashes of tragedy to rebuild a new and different journey.

Eva is our brave brain tumour warrior who is Forever 7 and the inspiration behind Caring Adventures. As we struggled to navigate the world of “childhood cancer” we came to recognise the barriers children and families face when they hear those words, words no family should ever have to hear about their precious child.

We have been in existence since March 2018 as Eva’s Adventures and received Charitable Status on 7th June 2022 (Charity Number: 108632) under the name Caring Adventures. We have developed and maintained an excellent relationship with local councillors, MLA’s and local community activists. We have a developed website: evasadventures.com and are active on the social media platforms of Facebook and Instagram to highlight that showing love and giving cuddles can support even the toughest adventures with incredible memories.
