OBJECTIVES AND ACTIVITIES

Objectives and Aims

Focus/ Focusing On Community & Understanding Suicide is a youth-driven organisation committed to ending youth suicide. FOCUS is there to assist in supporting young people at risk of suicide and who ultimately choose life through the engagement of our intervention support programmes and initiatives.

OUR VISION

Our aim is to provide education and intervention where suicide is a risk and help prevent it.

OUR PURPOSE

is to work collaboratively as a community providing information and education to aid with suicide prevention and directly support those young people identified at risk of suicide, helping them thrive and fully Focus on life going forward.

The charity will achieve this by associating with other relevant statutory authorities, voluntary organisations and inhabitants of the area in a common effort to advance education and opportunities and to provide facilities in the interests of social welfare for the protection of health and recreation, with the object of improving the conditions of life for the inhabitants.

Public Benefit

FOCUS (Focusing on community and understanding suicide)meet and comply with all requirements of the Charities Act 2008 and have due regard to the public benefit guidance published by the Charity Commission for Northern Ireland.

Financial review

The main source of funding throughout the year was from grants. In calculating the required level of reserves the charity takes into account the risks of income and expenditure, the trustees believe it is beneficial to hold an amount in unrestricted funds to cover running costs for a period of nine months to enable the company to continue at its current level of activity.

Reserves policy

The trustees consider the Reserve Policy an important part of the internal financial management. It assists with strategic planning when reviewing new or potential projects/activities; informs the budget process and enables planning for a balanced budget or use of reserves; and it informs the budget and risk management process by identifying any uncertainty in future income streams. Reserves are reviewed in detail annually but also monitored throughout the year to assess any build up of reserves or unexpected depletion of these.

Operational Reserves are required to allow the organisation to continue to deliver its charitable objectives and seek alternative funding sources, should existing annual funding be restricted and to provide assurance against a risk of an unforeseen emergency or other unexpected need for funds. In addition, Operational Reserves provide the organisation with the ability to react to short term opportunities. In quantifying the level of Operational Reserves required, the level of net current assets and liabilities are compared to the average monthly expenditure. The risks associated with future income, grants and expenditure are also considered. As a result, the Trustees have determined in their last review that 9 months of the annual recurring expenditure are required as Operational Reserves.

Risk

The trustees has assessed the major risks to which the charity is exposed, and are satisfied that systems are in place to mitigate exposure to the major risks.

Structure, governance and management

The charity constitutes a non-profit charity , It is controlled by its governing document.

Recruitment and appointment of new trustees

Organisational Structure

A manager is appointed by the trustees to manage the daily operations of the charity. To facilitate effective operations, the manager has delegated authority, within the terms of delegation approved by the trustees, for operational matters. Induction and training of new trustees New Trustees undergo orientation to brief them on their legal obligations under charity law, the content of the Trust Deed, decision making processes, the business plan and the recent financial performance of the charity. During induction, they meet key members of staff and other Trustees. Trustees are encouraged to attend appropriate training events where these will facilitate the undertaking of their role.
