The third year of Baltic Together has continued with the activities of year one again with no income during the period.

Since our set up in 2022 we have continued to promote our organisation throughout the events, partnership and social media.

The trustees continue to work with Mid Ulster Council, schools, Migrant and Ethnic Minority Peace Builders, Lithuanian school "Lietuvytis" and many families which based in the Mid Ulster Area in NI. This organisation has grown considerably over this past year and as a result has made connections with other nationals originally from the Baltic Region in Ireland.

We would like to thank everyone for their fantastic support over the past year and we hope that we and to many others who give their time to help support the organisation.

The trustees are pleased to present their annual committee report together with the financial statements of the Organisation for the year ending 31 March 2025

The financial statements comply with the Charities Act 2008 and Accounting and Reporting by Charities.

Our purposes and activities

Baltic Together is established to enhance promote the benefit of the inhabitants currently residing in the MID Ulster Area and originally from the area defined as the Baltic State -Lithuania (hereinafter called the "beneficiaries") of the Mid Ulster Area (herein called the area of benefit) to advance education, and to provide or assist in the provision of facilities in the interests of social welfare for recreational or other leisure time occupation, with the object of improving the conditions of life of the said inhabitants and in particular to Invite people to join joint projects, activities, join the community building process and organize various initiatives with the aim of gathering and growing community. Provide or secure the provision of welfare rights advice and information and refer those in need of professional assistance to the relevant agencies.

Our Lithuanian Library is open 3 days per week set times and we also have regular meetings which is announced on our social media beforehand. We are an equal opportunity group where elderly, parents and their children, women and man are welcome. As a Charity we are running regular sessions and meetings for woman; parents and kids stay and play sessions (trial stage at the moment); Lithuanian book library where everyone welcome to come and pick a book, have a chat, meet new people; we also organize Mid-summer festival for all community, Christmas family event and coffee mornings. Many more activities planned but haven't taken place yet.

In shaping our objectives for the year and planning our activities, the trustees have considered the Charity Commission's guidance on public benefit, including the guidance 'public benefit: running a charity (PB2)'. The Organisation relies on grant income and donations to cover its operating costs.

There is no private benefit to any individual - the only private benefit flowing from this purpose that it is incidental and is necessary for staff to receive on-going training in safeguarding children. These benefits are necessary to ensure the highest quality of service benefits the beneficiaries.

Governing Document

Appointment of trustees

As set out in the Trust Deed, the maximum Board members 7.

When considering co-opting trustees, the Board has regard to the requirement for any specialist skills needed.

The Trustees shall be entitled to invite members of the public to attend as observers at any Annual General Meeting or any other meetings of the Trustees.

Trustee induction and training

New trustees undergo an orientation session to brief them on: their legal obligations under charity law, the Charity Commission guidance on public benefit, and inform them of the content of the Trust Deed, the committee and decision-making processes, the business plan and recent financial performance of the charity.

Any person wishing to become a board member must apply in writing for approval by the Trustees. It is a requirement that the board members attend an induction process covering good governance. During the induction they meet key employees and other trustees. Trustees are encouraged to attend appropriate external training events where these will facilitate the undertaking of their role.


