## Activities

**Purposes:** Little China Dog Rescue (LCDR) has been set up to relieve the suffering of animals in need, provide and maintain rescue homes through foster care and eventually find forever homes for each animal, where they will be loved and safe. Although the primary focus will be for dogs, LCDR will not refuse care to any animal in need, where capacity and finances allow. LCDR's commitment will be to those animals that have been abused, abandoned, neglected or simply unwanted. LCDR's dedication to care will extend beyond Northern Ireland and Great Britain, rescuing dogs, worldwide, with a specific focus on saving dogs that have fallen victim to the Chinese meat markets. LCDR operates a "no kill" policy, meaning they will never put a healthy dog down. Further to this, the benefits of LCDR's charitable work extend to the public. LCDR will reduce the distress experienced by members of the public when they encounter or see a dog in need or possess an unwanted dog themselves. LCDR will ensure promotion of animal welfare to members of the public through responsible rehoming that complies with local law and policies regarding importing animals, and safeguards the general public's health. The charity rescues dogs with complex needs, and through their fostering policy, educate the public on how to care for those with specific needs. In addition to this, the charity is educating and supporting local vets by exposing them to illnesses and disabilities not often seen or treated in NI. This is achieved by leveraging the network LCDR has built up around the world, liaising with rescues and veterinary teams around the UK, Europe and beyond to share learnings and experiences. A number of LCDR's dogs are rescued with permanent disabilities, many of which require specialist equipment in order to go about their day to day lives, such as dog wheelchairs. LCDR goes beyond just caring for their own rescues, often providing disability equipment to the local community with a focus on those most in need, such as low income homes (as and when availability and finances allow). This is achieved because of the collaboration between LCDR and local veterinary and rehabilitation teams who inform LCDR of pets and homes in need. LCDR aims to promote humane behaviour towards animals by raising awareness through social media and educational days at schools and public venues, encouraging positive interactions between the public and LCDR's rescued dogs. In addition to this, LCDR have formed their own dog therapy team, consisting of a small number of rescued dogs that have each suffered abuse in the past and as a result, live with a range of disabilities and physical impairments. The purpose of the therapy team, is to promote health and improve mental well-being by holding dedicated sessions in schools and care homes, encouraging the public to have positive attitudes towards their own disabilities to promote better inclusion and reduce discriminatory behaviours. Finally, through LCDR's team leader programme; team leaders will gain training in canine first aid, human first aid and canine behaviour. This will also allow them to promote animal welfare in the local community, but also develop their leadership skills; enabling them to become better citizens in society. For the avoidance of doubt, the system of law governing the articles of association of the charity is the law of Northern Ireland.

#### Summary of significant accounting policies and key accounting estimates

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

#### Statement of compliance

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice (applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)) (issued in October 2019) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

#### Basis of preparation

Little China Dog Rescue Ltd meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy notes.

#### Going concern

The trustees consider that there are no material uncertainties about the charity's ability to continue as a going concern nor any significant areas of uncertainty that affect the carrying value of assets held by the charity.

#### Taxation

The charity is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the charity is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

#### **Borrowings**

Interest-bearing borrowings are initially recorded at fair value, net of transaction costs. Interest-bearing borrowings are subsequently carried at amortised cost, with the difference between the proceeds, net of transaction costs, and the amount due on redemption being recognised as a charge to the Statement of Financial Activities over the period of the relevant borrowing.

Interest expense is recognised on the basis of the effective interest method and is included in interest payable and similar charges.

Borrowings are classified as current liabilities unless the charity has an unconditional right to defer settlement of the liability for at least twelve months after the reporting date.

2. To promote humane behaviour towards animals by providing appropriate care, protection, treatment and security for animals which are in need of care and attention by reason of sickness, maltreatment, poor circumstances or ill usage. Through raising awareness through social media and educational days at schools and public venues.
3. To promote positive interactions for members of the public that can have therapeutic effects through promoting health and well being of one of our rescues as a foster carer. In addition to the daily care, cleaning, feeding and exercising of the animals, is socialisation.
4. Reduce the distress experienced by members of the public when they encounter or see a dog in need or possess an unwanted dog themselves. The public can contact us via a variety of means. We then place dogs under our care; if here locally or from China's slaughterhouses, ex medical testing dogs and meat markets. Till responsible rehoming in NI or the UK. To ensure promotion of animal welfare to members of the public through responsible rehoming that complies with local law and policies regarding importing animals, to safeguard the general public's health. When rescues are brought to NI from China.
5. To promote positive sense of well being with members of the public, to encourage positive attitudes towards their own disabilities to promote better inclusion and reduce discriminatory behaviours. This is achieved through therapeutic sessions for school children, nursing home residents and hospitals, with our rescue dogs and their adopters. Many of our dogs are left with ranging disabilities and physical impairment due to the abuse they suffer.



Little China Dog Rescue Ltd meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy notes.

#### Going concern

The trustees consider that there are no material uncertainties about the charity's ability to continue as a going concern nor any significant areas of uncertainty that affect the carrying value of assets held by the charity.

#### Taxation

The charity is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the charity is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

### Notes to the Financial Statements for the Year Ended 30 April 2024

#### **Borrowings**

Interest-bearing borrowings are initially recorded at fair value, net of transaction costs. Interest-bearing borrowings are subsequently carried at amortised cost, with the difference between the proceeds, net of transaction costs, and the amount due on redemption being recognised as a charge to the Statement of Financial Activities over the period of the relevant borrowing.

Interest expense is recognised on the basis of the effective interest method and is included in interest payable and similar charges.

Borrowings are classified as current liabilities unless the charity has an unconditional right to defer settlement of the liability for at least twelve months after the reporting date.

#### **3 Taxation**

The charity is a registered charity and is therefore exempt from taxation.

To ensure promotion of animal welfare to members of the public through responsible rehoming that complies with local law and policies regarding importing animals, to safeguard the general publics health. When rescues are brought to NI from China.
5. To promote positive sense of well being with members of the public, to encouragement positive attitudes towards their own disabilities to promote better inclusion and reduce discriminatory behaviours. This is achieved through therapeutic sessions for school children, nursing home residents and hospitals, with our rescue dogs and their adopters. Many of our dogs are left with ranging disabilities and physical impairment due to the abuse they suffer.


- examine the accounts under section 65 of the Charities Act (Northern Ireland) 2008;
