Purposes: 4) The Company's objects are specifically restricted to the advancement of informal education, the promotion of community and youth participation in healthy recreation, the promotion of social inclusion and the promotion of the benefit and wellbeing of children and young people aged 5-25 years old (hereinafter called the 'beneficiaries') in the Kilkeel area and its surrounding environs in County Down, Northern Ireland (hereinafter called the 'area of benefit') without distinction of age, gender, sexual orientation, disability/ability, race, political, religious or other opinion by associating the statutory authorities, voluntary organisations and the inhabitants in a common effort to advance education and to provide or assist in the provision of facilities in the interests of social welfare with the objective of improving the conditions of life for the said inhabitants and in particular: A) To promote or assist in promoting youth community capacity building programmes and projects for the beneficiaries within the area of benefit who have need of such assistance as a result of their youth, age, disability or infirmity or social and economic circumstances, in an effort to increase the abilities, leadership skills and self confidence of such inhabitants in the area of benefit; B) To encourage youth participation in healthy recreation through the provision of a safe environment for children and young people to learn and participate in sporting activities, healthy recreation and through such other physical, mental and social capabilities that they may grow to full maturity as individuals and members of society; C) To provide programmes of recreational, cultural and educational activities for young people in the area of benefit D) To promote social inclusion for the public benefit by working with people who are socially excluded on grounds of their youth, unemployment, financial hardship, poverty or social and economic position in order to relieve the needs of those people who are socially excluded and assisting them to integrate into society E) To advance any other exclusively charitable purpose as the directors may from time to time decide in accordance with the law of charity

Independent Examiner's Report to the Trustees of Kingdom Youth Club

For The Year Ended 30 June 2025

1. General Information

Kingdom Youth Club is a company limited by guarantee, incorporated in Northern Ireland, registered number N161382 and registered charity number 109881. The registered office is 10 Dunnaval Road, Kilkeel, Co Down, BT34 4JT.

2. Accounting Policies

2.1. Basis of Preparation of Financial Statements

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)", Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006.

The charitable company is a Public Benefit Entity as defined by FRS 102.

2.2. Incoming Resources

Income resources received during the year comprised:

Donations and gifts
Grants receivable
Government Grants

All income has been applied solely towards the charitable objectives of the organisation. There is no private benefit arising from the charity's activities.

2.3. Resources Expended

All restricted funds were applied in accordance with their original intended purposes. No reallocation or extension of use occurred during the year.

2.4. Tangible Fixed Assets and Depreciation

Tangible fixed assets are measured at cost less accumulated depreciation and any accumulated impairment losses. Depreciation is provided at rates calculated to write off the cost of the fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

Leasehold	Straight line over the life of the lease
Fixtures & Fittings	25% Reducing Balance
Computer Equipment	25% Reducing Balance

2.5. Cash and Cash Equivalents

Cash and cash equivalents are basic financial assets and include cash in hand and deposits held at call with banks, other short-term highly liquid investments that mature in no more than three months from the date of acquisition and are readily convertible to a known amount of cash with insignificant risk of change in value, and bank overdrafts.

2.6. Government Grant

Government grants are recognised in the statement of financial activities in an appropriate manner that matches them with the expenditure towards which they are intended to contribute.

Grants for immediate financial support or to cover costs already incurred are recognised immediately in the statement of financial activities. Grants towards general activities of the entity over a specific period are recognised in the statement of financial activities over that period.

Grants towards fixed assets are recognised over the expected useful lives of the related assets and are treated as deferred income and released to the statement of financial activities over the useful life of the asset concerned.

All grants in the statement of financial activities are recognised when all conditions for receipt have been complied with.
