Advancement of Citizenship and Community Development To advance citizenship and community development by providing opportunities for individuals and groups to participate in volunteering, learning, and community activities within Castlewellan Arboretum and the Annesley Walled Garden that promote social inclusion, civic engagement, health and wellbeing. 5. Advancement of Health and Wellbeing To promote the health and wellbeing of the public by encouraging access to, enjoyment of, and engagement with high-quality green spaces and natural environments within Castlewellan Arboretum and the Annesley Walled Garden. 6. Provision of Facilities and Resources To improve, or assist in the improvement of, Castlewellan Arboretum and the Annesley Walled Garden by providing or assisting in the provision of equipment, plants, infrastructure, facilities and other resources consistent with the charitable purposes of the Company.
