### **Legal and Administrative Arrangements**

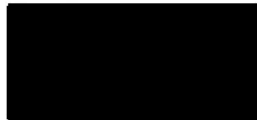
### **Objectives and Organisational structure of the Inverurie Academy School Fund**

The Objectives and Organisation of the Inverurie Academy School Fund are set out in the School Fund's written constitution. The objective of the School Fund is to encourage educational activities and additional courses for pupils at Inverurie Academy, especially pupils participating in social, musical and sports activities in connection with the school. The affairs of the School Fund are conducted by the Trustees who meet and act as frequently as necessary to conduct the business of the School Fund. The Management committee consists of three Trustees elected at the Annual General Meeting. The Trustees, namely the Rector, Deputy Rector and the School Administrative Assistant of Inverurie Academy Secretary and Treasurer are appointed as per the constitution.

### **Financial Review**

The net surplus for the year was £29,075 (2024: surplus of £16,734). Total income for the year amounted to £246,630 (2024: £187,272) and total expenditure for the year amounted to £217,555 (2024: £170,538).

### **Activities in the year**

This has been a busy year of activities at Inverurie Academy with a number of additional experiences provided for pupils. Residential overseas trips to Disneyland Paris with the Science Faculty, Paris also with the Modern Languages Faculty, and a Battlefields trip with the Humanities Faculty, enjoyed by all who participated. Closer to home, residential trips to Millport with the Humanities Faculty and Loch Eil adventures, for S2 pupils, Royal Highland Show with HE staff, Edinburgh Fringe with Creative Arts staff, Gothic Edinburgh with the English Faculty, Culloden with the Humanities Faculty were all very successful. Football and Netball teams continue to compete against other schools in Aberdeenshire and across Scotland. Duke of Edinburgh at various levels with staff supporting pupil out of school experiences. Geography and Science field trips were supported again this year, as were Business and Languages visits to RGU and the University. Drama staff led day trips to the theatre and to Sky offices in Livingston. Humanities staff led a prison experience trip.

Our Barista Coffee Club is providing further pupil experiences. The school was delighted to receive generous donations from our Parent Council, a gardening grant, football donation, a travel grant and a grant to support a trip to the Gordon Highlanders museum. We have an additional local business sponsorship for our annual awards trophies. A donation from Build Your Future as a result of pupil participation in a competition. Grants also received to enable individual pupil participation on residential trips. Our school Charity group fundraising supports our donations to other groups.

### **Management committee remuneration and expenses**

The management committee did not receive any remuneration or reimbursement of expenses during the year.

**Future plans**

In the year ahead, plans are well underway for another residential overseas trip to Iceland run by Humanities staff, a Naples trip run by HE staff, and a Disneyland trip run by Science staff. We also plan to run another residential S2 Outward Bound experience to Loch Eil . We will also support sporting, Duke of Edinburgh, and ongoing department proposals to enhance pupil experiences . We will also continue to support our various sporting groups.

**Reserves**

As a result of the surplus of £29,075 (2024: surplus of £16,734) for the year, the School Fund held unrestricted funds of £211,552 (2024: £182,477) at the year end. Restricted funds showed no movement in the year and totalled £2,168 (2024: £2,168).

**Assets**

Assets of the School Fund at the year end which is made up of cash at bank totalled £213,720 (2024: £184,645).

**Independent Examiner's Report to the Trustees of Inverurie Academy School Fund**

**Basis of independent examiner's statement**

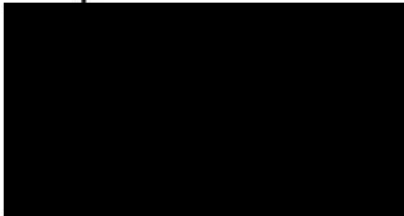

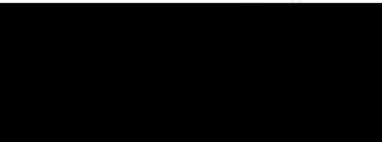

**Notes to the accounts for the year ended 31st March 2025**

### **Note 1 Basis of preparation**

#### **Basis of accounting**

These accounts have been prepared on the Receipts and Payments basis in accordance with the Charities & Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations (as amended).

### **Note 2 Accounting policies**

#### **Incoming resources**

##### **Recognition of incoming resources**

These are included in the Statement of Financial Activities (SOFA) when:

The charity becomes entitled to the resources;

The Trustees are virtually certain they will receive the resources;

The monetary value can be measured with sufficient reliability.

#### **Investment income**

This is included in the accounts when receivable.

#### **Expenditure and liabilities**

##### **Liability recognition**

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

#### **Support costs**

Include costs of the preparation and examination of statutory accounts, and are included when paid.

### **Note 3 Transactions with Trustees and related parties**

There were no transactions during the year with any of the School Fund Trustees, and there are no related parties of the School Fund.

### **Note 4 Restricted Funds**

The Miss Hadden Fund is held to provide funds for any pupils who intend to travel with the intention of furthering an interest in the work of the church abroad.

There was no movement in this fund during the year to 31st March 2025.
