The PTA provided help with removing old play equipment.

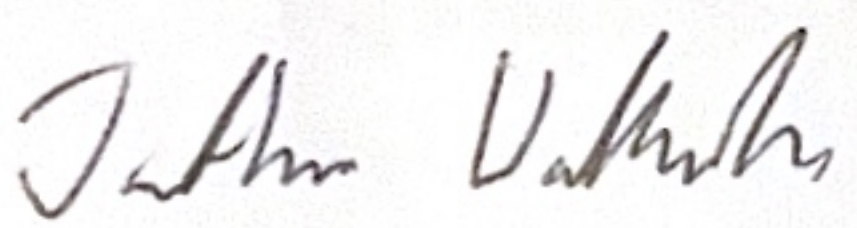
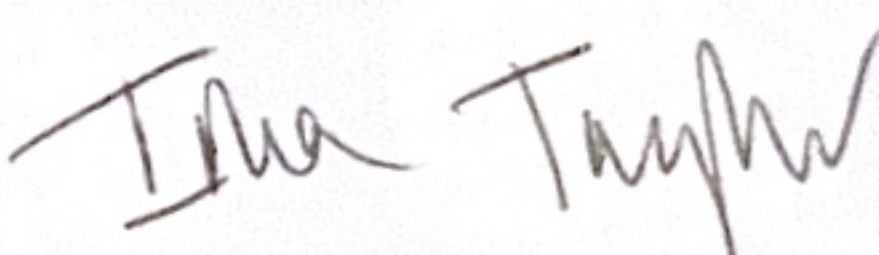
