### **Governing Document**

The Church is administered in accordance with the terms of the Unitary Deed of Constitution.

### **Recruitment and Appointment of Trustees**

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

### **Organisational Structure**

The Kirk Session, which meets 10 times during the year is responsible for spiritual affairs within the church. There are a number of committees to oversee various aspects of church life who report back to the Kirk Session on a regular basis. These include groups focusing on strategy, worship, nurture and mission.

### **Objectives and Activities**

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Online monthly prayer meeting

Tea-pot Café held weekly where Kirk and Community come together

A weekly Scripture Union group is held at McLaren High School

Weekly youth group

Monthly Music & Memories meeting - with familiar songs, a friendly blether and a cuppa. All are welcome including those living with dementia and their carers.

Junior Choir - regularly participates in worship services

### **Other activities:**

Under the Presbytery Mission Plan, Callander Kirk, as of 1st January 2025 is now linked with the churches at Killin & Ardeonaig, and Balquhidder. When the minister is at the other charges members of the church lead the service

A pastoral care team offer support through illness and bereavement, distribute copies of the weekly service to those who can no longer attend in person and bless others through distribution of the church flowers

Prayer Co-ordinator assists the Congregation with its prayer Ministry, producing a monthly prayer diary and coordinating the monthly online prayer times

'Just Praying' booklets were given out as part of the Easter Mission to encourage prayer

We also provide prayer & financial support for our overseas partners, the Waddells, raising money towards the purchase of a truck as well as providing knitted garments for new babies

As a response to the cost of living crisis a table was set up outside the hall where donations of food and surplus garden produce can be accessed by members of the community

Tearfund Big Quiz night is organised annually to raise money for Tearfund

Harvest festival home baking - a fundraising event for Start up Stirling

Start Up Stirling and Citizen Advice Bureau meet weekly in the kirk hall, providing support and advice to the community

We are a signed up member of Eco-Congregations Scotland

We work with other Christians in Callander to distribute Easter and Christmas cards and gifts to residents, and are involved in the setting up of an SU group in Callander Primary School

## Financial Review

The Accounts have been prepared on a Receipts and Payments basis. Unrestricted funds show a surplus of £2,727. However it must be noted that £59,524 was drawn from that held by the General Trustees from the sale of the manse, to enable maintenance work to be carried out on the Kirk roof and the stonework, as well as paying for the building feasibility studies. The restricted funds have a deficit of £8241, while the endowment funds have a £704 surplus.

It is the Trustees' policy to hold reserves, including designated funds, of approximately six months expenditure. At the end of 2025, reserves held met this criteria.

The Church also held £49,445 of restricted funds which have been provided for the purposes specified in Note 2.

## Trustees Contributions

Over the course of the financial year voluntary donations received from the Trustees amounted to £8,080


## Statement of Trustees' Responsibilities

## **Independent Examiner's Report to the Trustees of Callander Kirk, Church of Scotland**

I report on the accounts of Callander Kirk church of Scotland for the year ended 31 December 2025 which are set out on pages 7 to 14.

### **Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

### **Basis of independent examiner's statement**

An examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

#### **Purposes of Restricted Funds**

##### **Callander Kirk Hall**

This was set-up in 1992 to administer Callander Kirk Hall which is used by the Church and local community of Callander

##### **Callander Kirk Maintenance**

Two legacies had been received which were to be used for the maintenance of Callander Kirk - all now used

##### **Restricted Trossachs**

Funds are raised to help for the upkeep, maintenance and purposes of Trossachs church- all now used

##### **Restricted Trossachs - Dickson legacy Fund**

A legacy was received which is to be used for the maintenance and upkeep of Trossachs church

##### **Trossachs Graveyard Fund**

This fund was set-up to pay for any damage to the boundary wall of the graveyard which was being eroded away by cattle in the adjoining field

##### **Guild**

Funds are raised by the Guild Members and are used as they see fit

##### **Callander Kirk Youth Fund**

There is a separate Youth Trust (SC036576) which covers the costs of a youth worker

##### **Thursday Club**

The Thursday club is no longer in operation but the former members decided that they wanted the balance in the fund to be put towards refurbishing the hall.

##### **Other Restricted funds**

Occasionally small amounts are given for a specific purpose and they are collectively included here

This includes money donated for flowers, for the Christmas and Easter missions, for the hall refurbishment and for the audio system

#### **Purpose of Unrestricted Funds**

##### **Designated Manse Fund**

A legacy received in 2021 was used to create this fund to help towards the purchase of a manse

#### **Purposes of Endowment Funds**

##### **McAdam Bequest**

This was set up in 1983 and is to be used solely for the upkeep of the family grave. This is to be managed by the Kirk Session

##### **Wilson Bequest**

This bequest was set-up in the early 1960s by an elder Mr Walter Wilson and his wife Elizabeth of St Kessog's Church, Callander. It is to be used to help to provide assistance to members of the Church at Christmas - now known as "The Wilson Parcels"

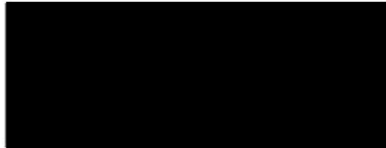

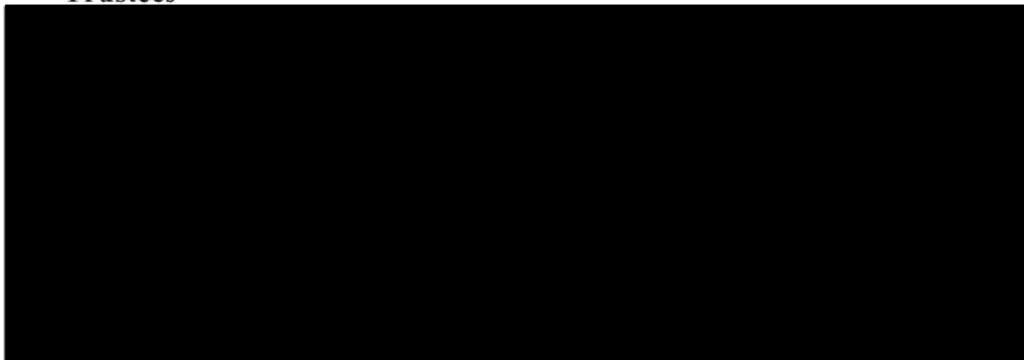

## **Financial Review**

The Accounts have been prepared on a Receipts and Payments basis. Unrestricted funds show a net surplus after transfers of £9,017. At the end of 2024 there remains an outstanding balance to 'Giving to Grow' of £7,283. The restricted funds show a deficit of £3,737 for the year.

It is the Trustees' policy to hold reserves, including designated funds, of approximately six months expenditure. At the end of 2024, reserves held met this criteria.

The Church also held £63,417 of restricted and endowment funds which have been provided for the purposes specified in Note 2.

## **Trustees Contributions**

Over the course of the financial year voluntary donations received from the Trustees amounted to £9,410

## **Statement of Trustees' Responsibilities**

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

## **Independent Examiner's Report to the Trustees of Callander Kirk, Church of Scotland**

I report on the accounts of Callander Kirk church of Scotland for the year ended 31 December 2024 which are set out on pages 7 to 14.

### **Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

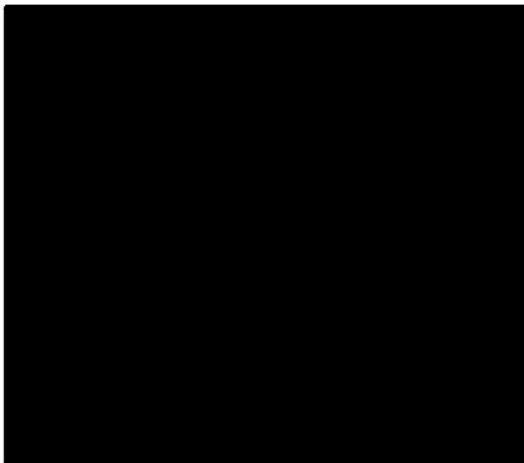
### **Basis of independent examiner's statement**

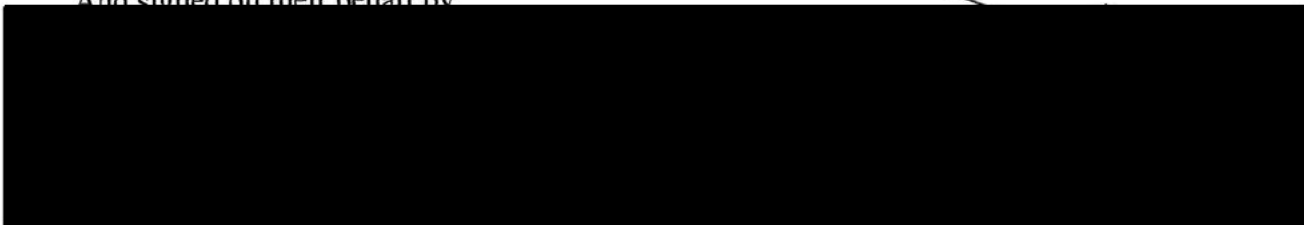

#### Purposes of Restricted Funds

##### **Callander Kirk Hall**

This was set-up in 1992 to administer Callander Kirk Hall which is used by the Church and local community of Callander

##### **Callander Kirk Maintenance**

A couple of legacies have been received which are to be used for the maintenance of Callander Kirk

##### **Restricted Trossachs**

Funds are raised to help for the upkeep, maintenance and purposes of Trossachs church

##### **Restricted Trossachs - Dickson legacy Fund**

A legacy was received which is to be used for the maintenance and upkeep of Trossachs church

##### **Trossachs Graveyard Fund**

This fund was set-up to pay for any damage to the boundary wall of the graveyard which was being eroded away by cattle in the adjoining field

##### **Guild**

Funds are raised by the Guild Members and are used as they see fit

##### **Callander Kirk Youth Fund**

There is a separate Youth Trust (SC036576) which contributes to the costs of the youth worker

##### **Thursday Club**

The Thursday club is no longer in operation and the funds have been passed to the kirk to be held until the former Thursday club committee decide what to spend them on

##### **Other Restricted funds**

Occasionally small amounts are given for a specific purpose and they are collectively included here  
This includes money donated for flowers, for the Christmas and Easter missions and for the audio system

#### Purpose of Unrestricted Funds

##### **Designated Manse Fund**

A legacy received in 2021 was used to create this fund to help towards the purchase of a manse

#### Purposes of Endowment Funds

##### **Vanderbyl**

The Vanderbyl Bequest is to be used to help with the Stipend and minister's expenses  
The fund now receives no income and the residual balance was spent in full during the year

##### **McAdam Bequest**

This was set up in 1983 and is to be used solely for the upkeep of the family grave. This is to be managed by the Kirk Session

##### **Wilson Bequest**

This bequest was set-up in the early 1960s by an elder Mr Walter Wilson and his wife Elizabeth of St Kessog's Church, Callander. It is to be used to help to provide assistance to members of the Church at Christmas - now known as "The Wilson Parcels"

**5. Minister's Stipend**

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Ministers' stipends are paid in accordance with the national stipend scale which is related to years of service. For 2024 the minimum Stipend is £31,642 and the maximum stipend (after 5 years and subsequent years of service is £38,884)
