Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution (or Deed of Constitution (Unitary Form)).

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The Minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. Our Interim Moderator is appointed by the Presbytery.

Organisational Structure

The Kirk Session is moderated by the minister/interim moderator. As Trustees, all financial decisions rest with the Kirk Session. The Kirk Session is responsible for spiritual and temporal affairs within the congregation.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

During 2025, Sunday worship was conducted at 10.30 am with the Sacrament of the Lord's Supper being celebrated 5 times.

Due to the on-going vacancy, our services were conducted by Rev. John Carrick (Retired Baptist Minister), some Supply Clergy and a number of elders trained as Worship Leaders. The Junior Church met during worship time on Sunday morning. Sacraments of Communion and Baptism were conducted by various ordained ministers.

The Guild, for women and men, met weekly between September and May and supported members and non-members alike. The Livingstone Players are a drama group which performs an annual pantomime in the large hall and this group forms a significant part of the outreach and the congregation's commitment to Christian Aid.

Other organisations which make regular use of the premises are the Boy's and Girl's Brigades, Guides, Brownies, Rainbows, Badminton and Caravan clubs. Further community outreach is by the use of halls on a Saturday via the Lynda Turner School of Dance.

Monthly Youth Group meetings for the young folk of late primary and secondary age were held.

The church maintains a digital presence with website and social media. The services are video recorded and uploaded to the website/You Tube. This enables some with an interest in the church to view/listen to the weekly services. The recording is also burnt onto DVD/CD and distributed to the housebound so that they can participate and still feel part of the congregation.

The Roll of the the church stands at 219.

Achievements and Performance

Holy Week, Easter and Christmas Eve services were conducted in 2025.

A Prayer Group meets on a Wednesday morning and a Bible Study Group on a Thursday evening.

In response to the harvest time services, food parcels were donated to North Ayrshire Foodbank. At Christmas, the "Gift" service donated toys and money to North Ayrshire Council (Client Account) and Churches Homeless Action North Ayrshire (CHANA) to assist their works in connecting with those in need at Christmas time.

Throughout the year, the church supported Christian Aid, CHSS (Scotland), North Ayrshire Social Work, McMillan Cancer Care, CHANA, Leprosy Mission & TearFund. A further congregational collection to Stevenston Town Christmas Lights took place.

Financial Review

Following on from the union of three Churches of Scotland in Stevenston on 01/08/2024, the financial year for 2025 proved to be one of absorbing the activity of union in financial terms. Transfer in of one-off funds from the former Ardeer Parish Church was completed in August 2025 that assisted in maintaining year end combined bank balance of £76112. This is a reduced figure from the previous year largely due to one-off costs of closing down redundant buildings and on-going insurance costs of those buildings that amounted to £22501 (15%) of total expenditure. This was a significant factor in the overall resulting year end decrease in Statement of Balances of £24049. Donation income increased (as a result of the union) and work was undertaken to optimise donation income as the union process was working throughout the year. Energy costs were a challenging £9943 (6%) of total expenditure, whilst affordable, grew in concern during the year. These costs are under fixed term pricing structures that all revolve once the terms complete. Property maintenance costs are well managed and within compliance regulations. Insurance costs of £8805 (6% of total expenditure) are problematic given the need to fully insure on a replacement cost basis not only the occupied buildings but also the redundant buildings, a situation that can only be resolved by disposal of the redundant buildings, a matter within the hands of the Church of Scotland Law Department. Investments held with the Church of Scotland Investors Trust rose to a year end value of £123371, reflecting previous achievement of keeping the investments intact for future use.

Reserves Policy

It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds, with the surplus held in the General Trustees Growth and Income Funds.

As of September 2024, the new united congregation started a Prayer Group on a Wednesday morning and a Bible Study Group on a Thursday evening.

In October 2024 in response to the harvest time services, food parcels were donated to North Ayrshire Social Work. At Christmas, the "Gift" service donated toys and money to North Ayrshire Council (Client Account) to assist their work in connecting with those in need at Christmas time.

Throughout the year, the church supported Christian Aid, North Ayrshire Social Work, McMillan Cancer Care & Churches Homeless Action North Ayrshire (CHANA).

The church remains in a period of uncertainty due to incomplete decision on future site of Worship and activity.

Financial Review

A major change to the overall finances occurred due to the union of the three Stevenston Churches of Scotland on 01/08/2024. By way of transfer of final bank balance from the former High Kirk of Stevenston during November 2024, catapulted income of the continuing charity (SC000452), former Livingstone Church of Scotland from £54,544 (2023) to £135,773 (2024), a one-off income uplift. Expenditure increased from £46,931 (2023) to £73,877 (2024) resulting in substantial funds at bank of £101,192. This is a holding position as detail and subsequent costs of the Union continue to be worked through. Active cost factors such as significantly increased energy and other overhead costs have been well managed and within affordability during the second half of the year. The inherited value of investments in the name of the former Livingstone Church have passed over to the new Stevenston Parish Church. These are held with the Church of Scotland Investors Trust, remain intact with a year end value of £115,936. In summary, financial position for 2024 is secure.

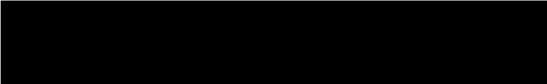

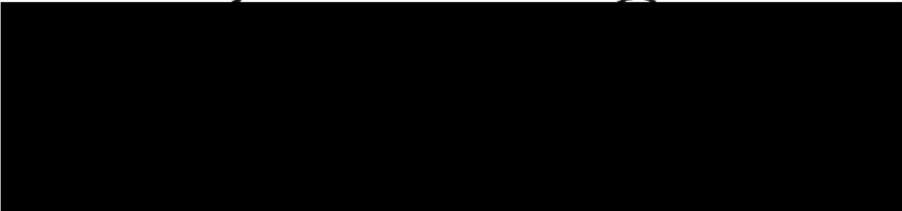

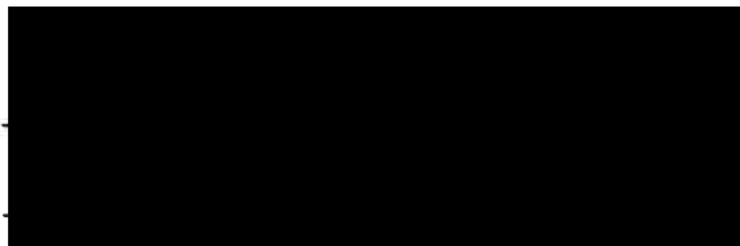

9 Other Matters

As noted in the Trustees' Report, this charity (previously known as Livingstone Church of Scotland) formed a union with High Kirk of Stevenston and Ardeer Parish Church on 1 august 2024 under a new congregation number (070448) known as Stevenston Parish Church. The acquisition method of accounting was used and the charity's accounts incorporate the transactions of the former Livingstone Church for the full year. As the Receipts & Payments method is used in these accounts, only the bank balances of the High Kirk of Stevenston have included as the Ardeer Parish Church balances had not been transferred at the balance sheet date. There were no other significant assets/investments to be transferred from the other churches.

Stevenston Parish Church holds the title to adjacent land which was gifted during 1979 from the former owner. This asset has not been valued and is not included in the Statement of Balances. There are no other substantial assets to include in the Statement of Balances.
