Activities

Activities: 'It carries out activities or services itself'

Purposes: 'the advancement of education', 'the advancement of health', 'the advancement of citizenship or community development', 'the relief of those in need by reason of age, ill-health, disability, financial hardship or other disadvantage'

What the charity does: Hansel provides care and support services for people with additional needs, within registered residential care settings or within their own homes. Accommodation-based respite services also offer short-breaks for visitors throughout the year. Through Hansel's 3e team employment opportunities are available for people with additional support needs, and employability programmes are delivered alongside a number of social enterprise activities. Care and support services are funded through local contracts with health and social care partnerships, though some individuals' support will be funded privately. External revenues are also generated through operation of social enterprise activities, including a commercial laundry and tearoom, and the organisation also undertakes fundraising initiatives to raise funds to develop or enhance services provided.

Beneficiaries: 'Children or young people', 'Older People', 'People with disabilities or health problems'

learning disabilities, mental health or any other special needs or circumstances, 4.3 the relief of stress and financial needs experienced by their families and carers through, but not limited to, the provision of accommodation, support, education and training, and 4.4 the advancement of citizenship, enabling people who are in need to be active citizens individually and through employment or community organisations and networks.
