Structure, Government & Management Governing Document

The Trust is governed by its Constitution, last updated 29 October 2011. As a charity, it is registered with the Office of the Scottish Charity Regulator (OSCR) reference SC002778.

Trustees and Organisation

The Trust is an unincorporated association with a maximum of 8 Trustees, at least 2 of whom require to be members of the Saltire Society. Throughout 2025 the Trust had a full complement of Trustees. The Trust is required to have a minimum of 3 board meetings each year, and during 2025 the Trustees met on 5 occasions in January, April, July, September and December.

Objectives

As set out in the Constitution, the purposes of the Trust are:-

- a) the advancement of the heritage of the birthplace of Scotland's national flag – the St Andrew's Cross or Saltire – including the maintenance and upkeep of the Saltire Memorial and associated floodlighting and the Flag Heritage Centre located within Athelstaneford Kirkyard, East Lothian.
- b) the advancement of the education of the public at large and Scots as to the origins of Scotland's national flag, and the encouragement of the proper use of the flag both within and outwith Scotland.

Risk Management

The Trust regularly reviews policies and assesses risk. The gradual deterioration of the structures and pathways at the birthplace had been identified in 2021 as a major concern, and a programme of refurbishment and renewal was drawn up to address this. The Trustees had also identified the urgent need to increase revenue streams to meet annual maintenance costs, and measures to address this have been put in place.

2025 ACHIEVEMENTS

Visitor Season: The Heritage Centre was able to open for the full 7 month season April to October. Visitor numbers remained steady. Thanks are due to custodian Tora Harrison who is responsibility for ensuring the Centre and toilet are opened daily throughout the season. The Tap to Donate facility in the Heritage Centre continues to be a worthwhile investment in attracting card donations. A new footfall camera was installed in the Centre, and this will allow visitor numbers to be more accurately monitored,

Project – Timeline: Following on from the successful upgrading of the path network and installation of the 12 timeline roundels in 2024, the Trust erected in June a timeline information panel on the outer wall of the churchyard, facing the Doocot. This comprises a robust galvanised framework within which are set individual panels providing historical background for each of the roundels, together with details of the sponsors.

Project – The Saltire Memorial: The main focus during the year shifted to the condition of and future prospects for the Saltire Memorial. Opened at a public ceremony in 1965, the Memorial comprises a concrete monolith with a tall flagpole attached. Recent inspections of the structure had revealed hairline cracks in the structure, while a preliminary report had outlined various treatment options and costs.

Thanks to a very generous donation of £10,000 by one of the Trust's supporters, the Trust was able in the Spring to commission specialist conservation architects Simpson &

Brown to carry out a more detailed investigation. Simpson & Brown's first report, a *Statement of Significance*, looked at the history and condition of the Memorial. The main finding was that the structure did not merit statutory listing.

Their second report considered a range of *Future Options* for the Memorial. Options based on the retention and repair were felt to be expensive, with no guarantee that the repairs would be long lasting. Instead, the Trustees supported the option involving the removal of the Memorial and replacing it with a new Monument in the

form of a semicircular wall to the rear of circular stone base. Behind the wall would be a tall free standing flagpole. The face of the wall would have appropriate features in text and images about the Saltire appearing in the sky above the 9thC battle.

In October, the Trustees held a public meeting to gauge a reaction to the Simpson & Brown reports, and broad support was expressed for a replacement monument as outlined above. This allowed the Trust to commission further work on the likely costs of constructing the new Monument (around £380k), and then to launch its appeal for funding on St Andrew's Day.

3. Project – AV Upgrade: Because of higher priority being given to a replacement Saltire Monument, little progress was made with this project.

Marking St Andrew's Day: On Sunday 30 November, Scotland's national day, the Trust organised a special St Andrew Service in Athelstaneford Kirk. The date was 60 years to the day since the opening of the Memorial, and the Trust opted to mark this with the official launch of its appeal to build a new and fitting replacement Saltire Monument. The Trust worked closely with the Kirk Session and the minister Rev Douglas Hamilton to make the day a memorable occasion.

The First Minister John Swinney and the Secretary of State for Scotland Douglas Alexander were present and gave readings in the Kirk, as did the Moderator of the Church of Scotland the Right Rev Rosie Frew. Other faith leaders and consuls attended, the event, together with Heralds from the Lyon Court. Haddington Pipe Band welcomed the guests as they arrived at the Kirkyard, and Dunbar Sings Choir and Andrea Baker performed wonderfully during the service. The weather was kind, and television camera were present.

365 Saltire Sponsorship: This initiative has continued to provide an important revenue stream for the Trust. People are invited to sponsor the flying of the national flag on a day of their choice, such as a birthday or anniversary, or as a gift for a friend or relative. By the end of 2025, 171 supporters were sponsoring dates on which to fly the Saltire.

A guided tour in Athelstaneford, taking in the Doocot, the Memorial and the Kirk, was organised in early November for Patrons of the Saltire, followed by lunch.

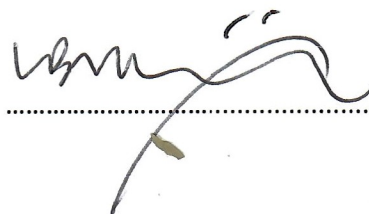

1 Basis on which accounts have been prepared

With effect from 1st January 2007, the Trust's accounts have been prepared on the Receipts and Payments basis which is applicable to smaller charities with an annual income below £250,000.

The charity is entirely dependent on the continuing support of its subscribing member donors, both individual and corporate, Gift Aid recovered and public donations.

2 Taxation

As a registered charity, the trust is exempt from income and corporation tax to the extent that its income and gains are applicable to charitable purposes only. Value Added Tax is not recoverable by the trust and is therefore included in any relevant costs.

If upon winding up or dissolution of the charity there remain any assets, after the satisfaction of all debts and liabilities, the assets represented by the accumulated fund shall be transferred to some other charitable body or bodies having objects similar to those of the charity.

3 Remuneration and expenses for Trustees

The executive committee, who are trustees, receive neither remuneration nor round-sum expenses. A trustee making a necessary payment to Flag Trust purposes is only reimbursed for receipted approved expenditure.

4 Endowment Funds

The charity had no endowment funds in the year ended 31 December 2024.

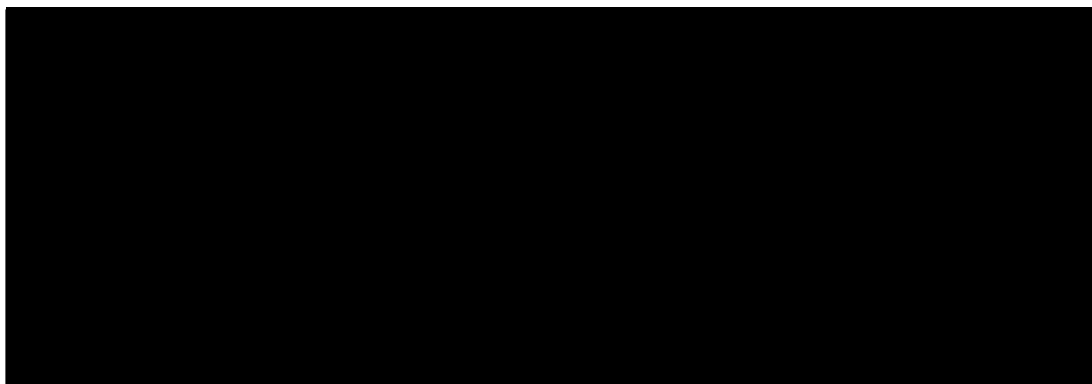

- a) the advancement of the heritage of the birthplace of Scotland's national flag – the St Andrew's Cross or Saltire – including the maintenance and upkeep of the Saltire Memorial and associated floodlighting and the Flag Heritage Centre located within Athelstaneford Kirkyard, East Lothian.
- b) the advancement of the education of the public at large and Scots as to the origins of Scotland's national flag, and the encouragement of the proper use of the flag both within and outwith Scotland.

Risk Management

The Trust regularly reviews policies and assesses risk. The gradual deterioration of the structures and pathways at the birthplace had been identified in 2021 as a major concern, and a programme of refurbishment and renewal was drawn up to address this. The Trustees had also identified the urgent need to increase revenue streams to meet annual maintenance costs, and measures to address this have just been put in place.

2024 ACHIEVEMENTS

Visitor Season: The Heritage Centre was able to open for the full 7 month season April to October, though there was some disruption in the summer for visitors during the implementation of the path upgrade and timeline works (see below). Visitor numbers remained steady. Thanks are due to custodian [REDACTED] who took over responsibility for ensuring the Centre and toilet were opened daily throughout the period. The Tap to Donate facility in the Heritage Centre continues to be a worthwhile investment in attracting card donations.

Arising from the last VisitScotland report and recommendations, a number of improvements were carried out prior to the Heritage Centre opening in April 2024. These included a thorough cleaning of the high level screen in the Doocot, and the cutting back of vegetation immediately in front of the viewpoint.

Renewal Project – Paths Resurfacing and Timeline: Much of the Trust's focus in the year related to the implementation of the pathways project. This involved the upgrading of the entrance to the Kirkyard, the replacement of steps by the War Memorial with a ramp, and the laying of a resin bound aggregate surface path to the Heritage Centre with a spur to the toilet to the rear of the Kirk. The work was successfully carried out by Ashwood Scotland Ltd during June/July, with great care to avoid disruption to weddings in the Kirk during that period. There was a delay in the delivery and installation of the 12 timeline roundels, and this was finally signed off at the start of November. Some additional costs were incurred during the project due to unforeseen issues relating to pipework by the toilet and at the site entrance. The Kirkyard gates also had to be removed temporarily.

The overall project costs were in the region of £125,000. Particular thanks are due to the main funding partners – East Lothian Council and Valencia Communities Fund. There were also welcome contributions from East Lammermuir Community Council and from East Lothian Community Rail Partnership. Thanks are also due to the sponsors of each of the 12 timeline roundels. Towards the year end, a planning application was submitted for consent to erect a timeline information panel on the Kirkyard wall adjacent to the Heritage Centre, and this will also acknowledge all of the sponsors.

Trustee [REDACTED] generously hosted a special lunch for sponsors on 30 November, followed by an inspection on site of the upgrade path and the timeline roundels.

Future Project – The Saltire Memorial: Following the upgrading of the path to the Heritage Centre and timeline, attention turned to the next phase of work, namely the enhancement of the Memorial and its setting, together with the path leading to it. A preliminary inspection of hairline cracks in the concrete plinth of the Memorial was commissioned and carried out in May by firm CRL (Concrete Repairs Limited). This was followed by a more detailed report from CRL outlining various treatment options and costs, but a decision on these has still to be taken.

Future Project – AV Upgrade: While the Trust holds a final report from [REDACTED] the University of the Highlands & Islands identifying innovative ways in which the light show within the Heritage Centre can be enhanced using the latest digital technology, little progress was made during 2024 in identifying funding.

Marking St Andrew's Day: On Saturday 30 November, a special St Andrew Service was held in Athelstaneford Kirk to mark Scotland's national day. The Trust worked closely with the Kirk Session and the minister [REDACTED] in making this a memorable occasion. The weather was kind as the Haddington Pipe Band performed by the Memorial as guests arrived, with Heralds from the Lyon Court present at the ceremonial hoisting of the new Saltire. Gifford Community Choir had been invited to perform at the Service, and their singing of Scottish numbers was warmly received by a packed congregation. Everyone was invited back to the Village Hall afterwards for refreshments.

In the run up to St Andrew's Day, on 28 November, the Trust invited guests to a Saltire Race Day at Musselburgh Racecourse, courtesy once more of the generosity of Trustee [REDACTED]. The 1.00pm race was named *The Athelstaneford Home of the Saltire Juvenile Maiden Hurdle Race*.

Athelstaneford Primary School marked the national day by raising a new Saltire on the school flagpole, courtesy of Trustee [REDACTED]

365 Saltire Sponsorship: This initiative has continued to provide an important revenue stream for the Trust. People are invited to sponsor the flying of the national flag on a day of their choice, such as a birthday or anniversary, or as a gift for a friend or relative. By the end of 2024, 159 supporters were sponsoring dates on which to fly the Saltire. The names of all sponsors are displayed within the Heritage Centre.

It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently I do not express an opinion on the view given in the accounts.

Independent Examiner's Statement

In the course of my examination, no matter has come to my attention

1) which gives me reasonable cause to believe that, in any material respect, the requirements:

to keep accounting records in accordance with Section 44 (1) (a) of the 2005 Act and Regulation 4 of the 2006 Accounts Regulations, and

to prepare accounts which accord with the accounting records and comply with Regulation 9 of the 2006 Accounts Regulations,

have not been met, or
