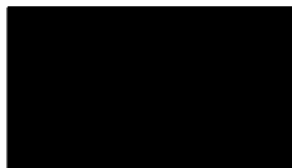

ANNUAL REPORT OF THE TRUSTEES

Liberty Church enjoyed another very encouraging year during 2024-2025 with a number of significant developments.

Our Sunday worship gatherings continued to be well attended, to the point that we had to rearrange set up of the hall to accommodate the growing numbers, and also to make further plans for increased seating. We also noticed a growing diversity of people becoming part of the Liberty family with different ethnic and social backgrounds. This has been very encouraging and also quite challenging as it has made us examine our culture in light of these changes. Growing numbers has also meant a growing need for new Life Groups (small groups to provide a more intimate connection) and two new groups were formed at the end of 2024.

Our Sunday morning kids' environment (Treasure Zone) and youth environment also grew during the year and required us to split the age groups for our younger kids and also create new space for them to meet. We also employed a part time children's worker to coordinate this environment and to build a team of leaders and helpers, which is always a challenge.

Sunday preaching covered various themes in line with our vision and identity. These included a series on examining the character and identity of Jesus, an Advent series on 'Jesus the King', a series on how to live out our faith with confidence in an increasingly complex world and a Lent series on the Lord's prayer.

Beyond our Sunday morning teaching series we also started an evening series called 'Going Deeper' giving us the opportunity to look into areas of faith (including the nature of God, healing and atonement) in more depth than is possible on a Sunday morning.

We also continued our monthly worship evenings, an opportunity to worship together in a more relaxed and less time-pressured manner.

We continued to serve the community around us in a number of ways, building connections, relationships and bringing hope. These included serving the local primary school through our Transforming Lives for Good (TLG) program and also helping out at their breakfast club. Our weekly 'Connect' group for seniors continued to attract new people and combined well with our Lunch at Liberty (Warm Space) café. Also we continued to run our Kintsugi Hope mental wellbeing group which attracted people both from the church and outside the church.

Our Gathering with God, weekly alternative worship service, continued to provide a vital community of hope and faith. And our Men's and Women's ministries both thrived through the year with regular events. Our Men's ministry, in particular, had a fresh surge of life in the latter part of the year with breakfasts, Bible studies and evening social gatherings, all including a strong faith element.

Other Church events included a picnic, a Scottish evening and Christmas events, all of which were very well attended and really helped to encourage, to build community and to act as easy connect points for those outside the church.

In terms of mission we continued to see a real growth with our mission partners during the year. Our partnership with Comfort International, and particularly their mums and babies project in Rwanda, was greatly strengthened by a missions trip at Easter which included four people from Liberty on the team. One of these people subsequently was invited onto the management team for the mums and babies which helped to strengthen our partnership. We

also saw an increase in our sponsorship within Liberty and a number of fundraising events including a garden party and kiltwalk which, again, really embedded this ministry into the life of the church.

We continued our partnership with Bethany Christian Trust including being a pickup point for their Caring Christmas Trees which we combined with our own Festive Fun event. We also continued to provide meals for the Welcome Centre in Edinburgh with a growing team of volunteers.

Mischi and Senta, our church partners in Romania, had a difficult year with the sudden death of their son and we were able to support them through prayer, encouragement and finances at a very difficult time.

Liberty's finances were given a boost through the year with significant new rental income and a substantial bequest. In addition to this the land owned by Liberty which we have been trying to sell for many years was granted planning permission for change of use which is a significant step towards finalising the sale. Another significant shift within the vision and plans for Liberty was the decision not to proceed with developing an auditorium within Liberty Centre due to the cost both in finances and time and also because it would not give us much more space for Sunday meetings than we currently have. Instead we would continue to use our current hall for gathered worship and invest in maximising its capacity through some smaller adaptations. This strategic shift also allows us to invest time and money into other areas that we believe will serve God, serve our community and bring life and hope to many more.

Again, through this year, we continued to testify to the love and faithfulness of our God, and to seeing his kingdom come amongst us and in the lives of those around us.

Make judgements and estimates that are reasonable and prudent.

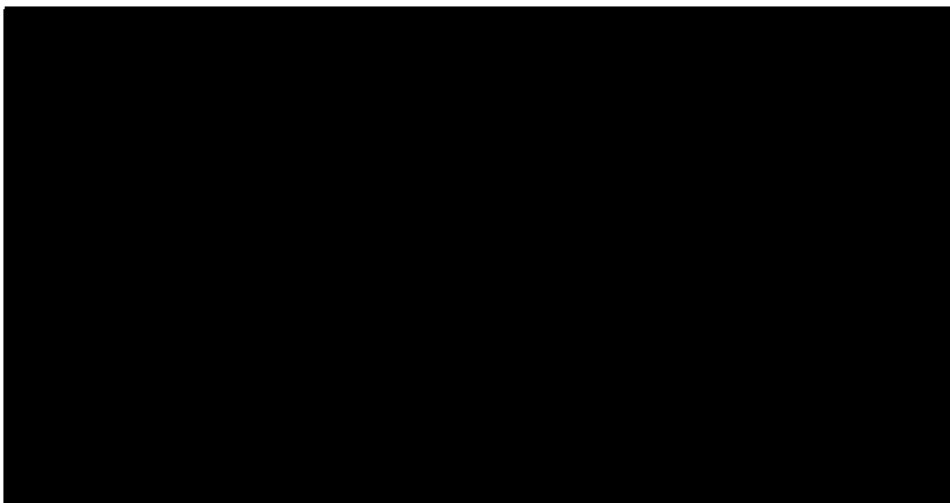
Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Church will continue its activities.

The Trustees are also responsible for taking such steps as are reasonably open to them to safeguard the Church's assets, and for the prevention and detection of fraud and other irregularities.

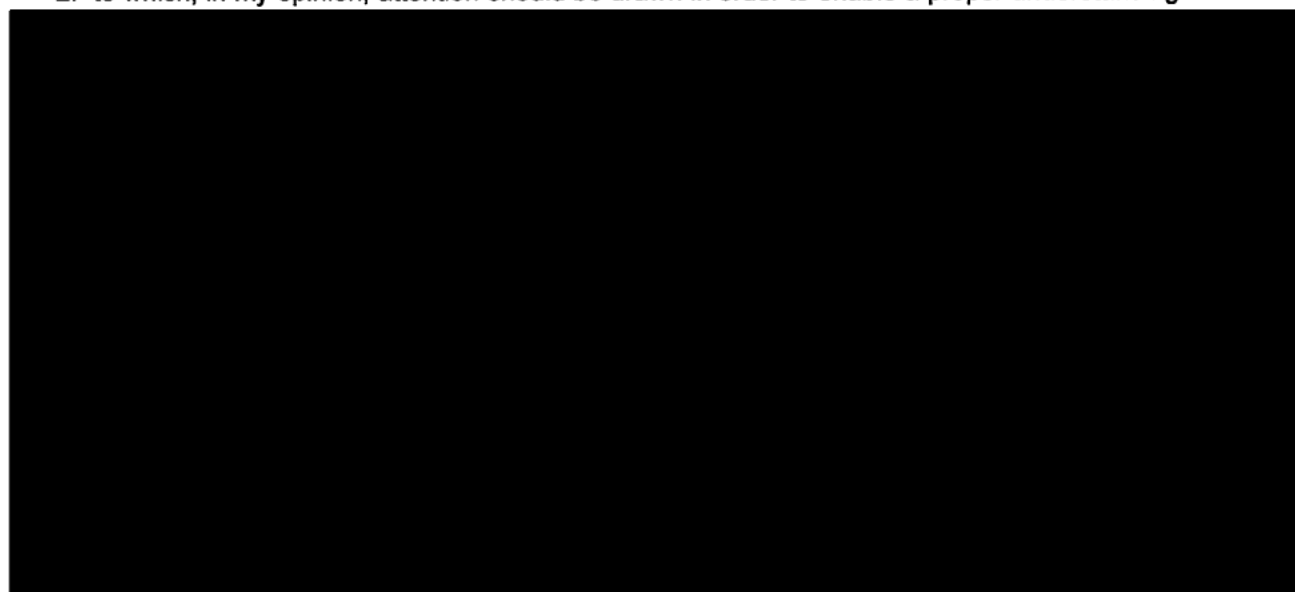

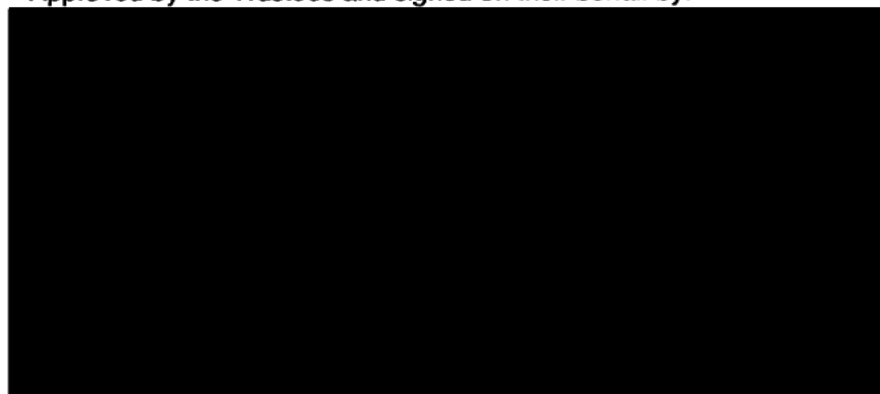

Notes to the Financial Statements for the Year Ended 31st March 2025

1. Accounting policies

Accounting convention

Financial Statements have been prepared under the historical cost convention and under the guidelines as laid down in the Statement of Recommended Practice for Accounting and Reporting by Charities (FRS 102).

Church income

Voluntary income and investment income are accounted for when received. Tax recovered under Gift Aid is accounted for when the amounts become due. This reclaimable Gift Aid on donations made to the Church is included with the amount received.

Restricted and Unrestricted Funds

For the purpose of the Statement of Financial Activities and the Balance Sheet, these funds are defined as follows:

Unrestricted funds – Gifts and other income received for the objects of the charity without specified purpose and available as general funds. They are subdivided into two: **Designated** funds, where a purpose has been allocated by the Trustees, and which can later be changed by the Trustees as required; and **Undesignated** or **General** funds. This division is reflected in the Statement of Financial Activities.

Restricted funds – Gifts and other income received for purposes as specified by the donor.

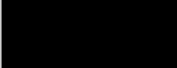
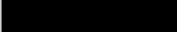
