Trustees Annual Report Year ended 31 December 2024

The Trustees present their annual report and financial statements for Larkhall New Parish Church of Scotland for the year ended 31 December 2024. The financial statements have been prepared in accordance with the accounting policies set out in the notes to the accounts and comply with the General Assembly Regulations for Congregational Finance, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published on 1 January 2019.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to people in every parish in Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

The challenge to our church's ability to work and witness continued with commitment and enthusiasm in 2024. Both the leadership and the membership managed to maintain their corporate identity and their shared calling to care for and serve the people of our community. The main objective being to revisit and revitalise the committee structure which had suffered during Covid and needed reviving.

Achievements and Performance

We are extremely grateful for the deep commitment of our leaders and the sacrificial support of our members who together ensured that the financial and fabric needs of the church were fully met and that plans for future development were still being formed and taken forward. We looked again at the vision adopted by Larkhall New at the time of the Union: "Our home in Christ and Christ in our home" and decided to change this to better reflect our new mission planning ideas by adopting the logo "Reaching In, Reaching Out, Reaching Up".

Our members continued to be involved in our community through serving in a number of local groups, including The Machan Trust youth project, Larkhall Christians Together and The Trussell Trust Food Bank.

Our buildings and facilities were very well looked after and we are deeply grateful for our fabric committees' expertise and deep commitment to the task. Since the Union took place we have been responsible for two sets of buildings. While the St Machan's sanctuary is the principal place of worship we are holding monthly services in the Chalmers' sanctuary and continue to develop plans for the future use of both sets of halls.

Achievements and Performance (continued)

In 2024 an update of a new Presbytery Mission Plan was finally agreed and implementation of this is now being progressed by the appropriate Presbytery committee.

Our fundamental and foundational functions have been well maintained throughout 2024 and in many cases they have been enhanced and advanced by hard work, innovative practice, and a willingness to change. A review of the then current committee structure was undertaken as noted below and this will enhance and continue the great Mission Revival work started in 2023.

Business Team : Leader – Linda Turnbull, Session Clerk

Following an Elders conference in March 2024, an updated version of our Logo was agreed as noted above, with the committees to be revived and revamped. The Business Team met on a number of occasions throughout the year. Over the first meeting it was agreed to replace the word Committee with the word Team. 6 teams were established – Communication, Mission, Nurture, Property, Social and Stewardship & Finance.

Each Team leader then recruited members from the Eldership and the general congregation. Throughout 2024 the Teams have been very active and busy thus ensuring that the spiritual, pastoral and temporal life of our Church continues to thrive and moved forward in faith in a way that is current and relevant to today's needs.

The work of these 6 Action Teams is co-ordinated by the Business Team, providing guidance and help where and when needed and also ensuring they report regularly to the Kirk Session. It also deals with matters referred to the Kirk Session by Presbytery or the General Assembly and ensures all major issues and proposed changes are brought to the Kirk Session for discussion and approval.

The Business Team is made up of the Leaders from each of the six Teams plus the Session Clerk, and our Minister.

Communication Team : Leader – Fiona Sandeman

The Communication Team has 6 members, We administer the Website, which is being revamped at the moment, as well as overseeing the printing of the Order of Service each Sunday, the quarterly Church Magazine and any other printing required by other Church groups.

Mission Team : Leader – Graham Duncan

The mission team met regularly during 2024 with the aim to create opportunities for folk to seek and find Jesus, to share together in social events as a church family and encourage interaction with our community. 16 folks attended a 10-week Alpha Course which started in January and a call was made to the group and adherents to consider church membership. In March, 6 new members joined the church at a special service and 2 adults were also baptized.

Intimations were made at Sunday services to encourage new folk to give their contact details to share information on church activities as part of our Sunday morning welcome protocol. Various social events were arranged to encourage the congregation and the community to interact, which were successful. A special 3 session bible study entitled, Let's Talk about Heaven, was well attended and a "Songs of Praise" Sunday Service was arranged in October with the congregation choosing their top Hymns. Monthly tea dances continued in our Chalmers building and monthly Pancake Coffee mornings continued in our St Machan's building. An Alpha course is planned for early 2025.

Nurture Team : Leader – John Martin MBE

Our Nurture Team which is made up of seven members of our congregation aim to nurture the growth and development of our congregation's faith in God, from those small children who are baptised in our church to those of an elderly age. We aspire to take care of and spiritually feed our members. The team encourages our members to be involved in our church and to recognise all external factors that affect human development such as early childhood experiences, daily habits and socioeconomic status.

The team encourages and supports our Prayer Group, our Mission Team, Youth Groups and all other organisations in our church by having close connections with our Kirk Session. Nominated members of the Kirk Session continue to visit the church organisations and are reporting back to the Nurture Team.

We encourage our congregation in daily prayer and worship by providing around 80 copies of a quarterly booklet 'Our Daily Bread'. We also provide the booklet "Try Praying". The Pastoral Care Team which is a sub group of the Nurture Team visit 17 members of our congregation who are either housebound, in hospital or are in nursing homes. All Pastoral Care Visitors have undergone CoS disclosure and attended the appropriate safeguarding training. The Pastoral Care Team distribute the recordings of church services to those who are not on line. Each household who requested the recordings have been issued with playback boxes provided by our church and receive recordings of each Sunday morning service.

Property Team : Acting Leader – Graham Duncan

The annual maintenance and unexpected general repair work which arise in the course of a year both at the Manse and in the Sanctuaries and halls have been undertaken. All essential repair work addressed, with particular attention being made to refurbishment of the Manse en suite and surfacing of a third of the Chalmers building car park with tar macadam. The St Machan's Session Room was refurbished, and significant work was carried out to repair a collapsed drain at our St Machan's building.

Stewardship & Finance Team : Leader – Bob Allan

The Stewardship and Finance Committee is responsible for all matters of Church finance, fundraising and accounting with a special emphasis on promoting all forms of stewardship and Christian giving. As always the financial team worked quietly away throughout the year ensuring our money is well looked after, spent wisely and that all our financial commitments are met. 2024 was no different.

Financial Review

The total incoming resources for the year amounted to £163,064 which is an increase of £23,976 from 2023. Compared to the income in 2023 there were increases of £4,388 in offerings and tax recovery, £2,952 in rents received, £3,500 in legacies, £7,136 in a special appeal for refurbishment purposes, £4,261 in income of organisations and £945 in interest received. Resources expended in 2024 amounted to £154,360 a decrease of £6,165 on the figures for 2023. This is largely accounted for by reduced expenditure of £17,988 on fabric expenditure offset by increased expenditure of £11,045 on other building costs. Overall the total funds carried forward at the end of the year increased by £8,704 from those at the end of 2023. Each of the funds being carried forward at the year-end are in surplus other than a small deficit of £304 in the Fabric Fund. The General Fund is carrying forward a balance of £66,199 and the designated funds a balance of £6,135 set aside for the purposes outlined on page 17. The restricted Refurbishment Fund is carrying forward a balance of £29,003 for the purpose specified in Note 12. In 2024 our Giving to Grow allocation to the Church's central funds was met in full. The Giving to Grow allocation in 2025 is £67,952 which is being met by ten monthly instalments.

Risk Management

The principal risk facing the congregation in line with most other religious charities is that of a reducing membership with an increasing age profile and an income base which is under strain. This is a problem for the whole Church to resolve, part of the answer to which is a programme to unite or link congregations and so reduce the cost base and to encourage regular promotion of stewardship to boost income levels. A further risk in the longer term is the upkeep of our buildings, particularly the sanctuaries and the halls. Some parts of our buildings are 180 years old and some repairs such as stonework are very expensive. The major refurbishment work carried out in recent years to both sets of buildings will ensure that the buildings are fit for purpose in the short to medium term but in the longer term significant expenditure will undoubtedly be required. The only exception to this is the roofs covering the St Machan's halls which require renewing. This will be a major and expensive job which we will have to face soon but the position of major costs being expended on any church building is currently sisted by the General Assembly until the future of Presbytery Mission Plans is agreed by the national Church.

Reserves Policy

It is the Trustees' policy to hold reserves of approximately six months General Fund expenditure plus an amount of at least £50,000 to cover unanticipated fabric repairs or emergency situations which may occur. At the year end the Church held unrestricted net assets of £72,334 of which -£304 had been designated for fabric purposes and £6,439 for organisational purposes. The remaining balance of £66,199 represents about six months expenditure. The Refurbishment Fund has a balance of £29,003 which leaves the reserves approximately £31,000 less than the desired level but it is not anticipated that this shortfall will be significantly reduced over the next one to two years.

Structure, Governance and Management

The congregation is a registered charity, number SC002870 and is administered in accordance with the terms of the Unitary Deed of Constitution and is subject to Acts and Regulations of the General Assembly. The Unitary Constitution was adopted in the Summer of 2016.

Under the Unitary Deed of Constitution members of the Kirk Session are the Charity Trustees. The Kirk Session members are the Elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

The Kirk Session meets on average five times a year, either in formal meeting or in conference session, and is responsible for the spiritual affairs within the congregation.

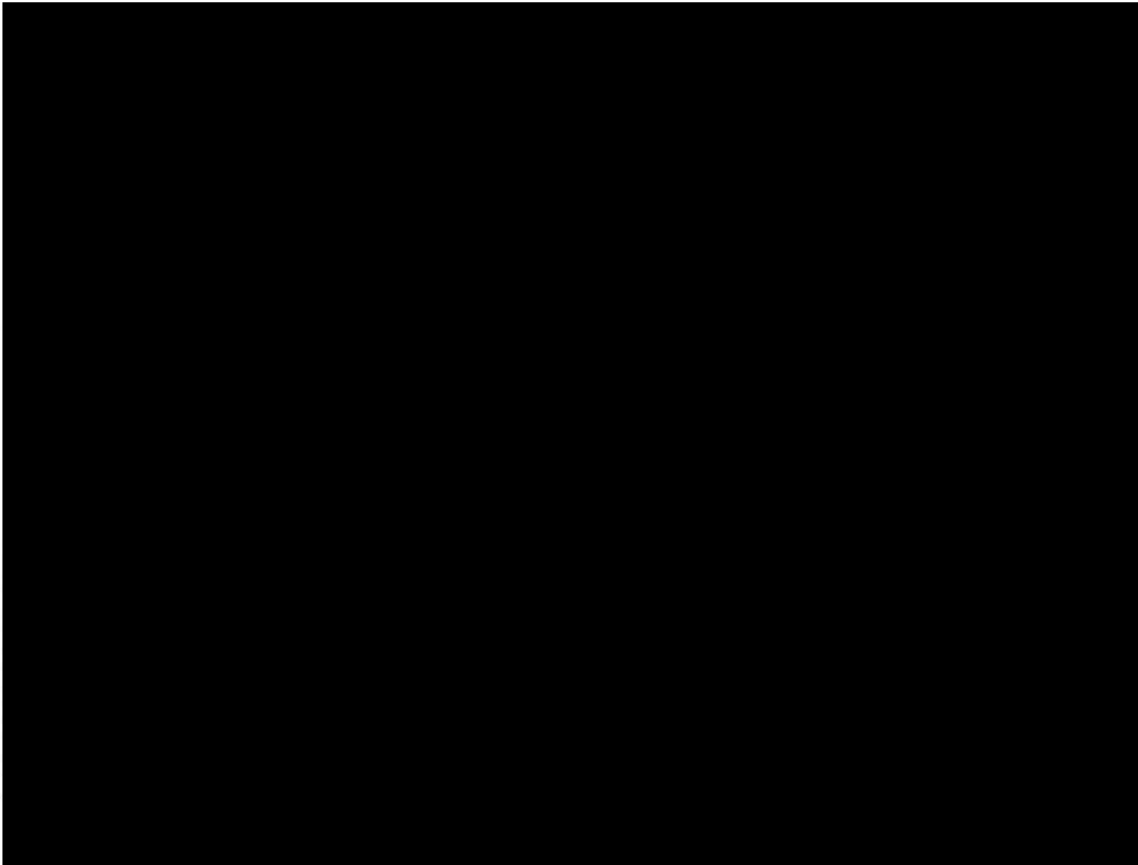

- select suitable accounting policies and then apply them consistently;
- observe the method and principles in the applicable Charities SORP;
- make judgments and estimates that are reasonable and prudent;
- state whether applicable accounting standards and statements of recommended practice have been followed, subject to any departures disclosed and explained in the financial statements;
- prepare financial statements on the going concern basis unless it is inappropriate to presume that the Charity will continue in operational existence.

The trustees are responsible for keeping proper accounting records which are sufficient to show and explain the charity's transactions and disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detections of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Larkhall New Parish Church of Scotland – Year ended 31 December 2024

I report on the accounts of the charity for the year ended 31 December 2023 which are set out on pages 10 to 19.

Respective responsibilities of trustees and examiner

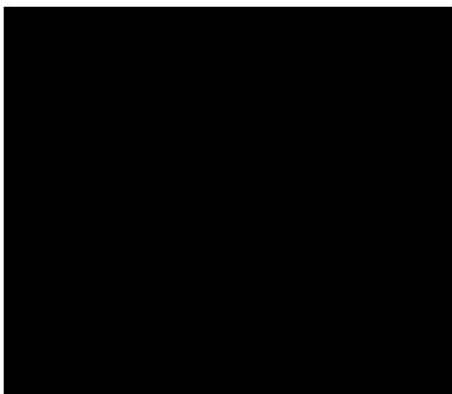
Basis of independent examiner's statement

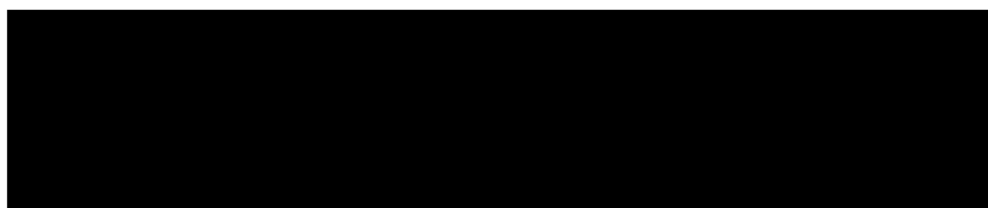

ACCOUNTING POLICIES

For the year to 31 December 2024

Accounting Policies

The principal accounting policies, which have been applied consistently in the current and preceding year in dealing with items which are considered material to the accounts, are set out below.

(a) Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102) issued on 16th July 2014, the Charities and Trustees Investment (Scotland) Act 2005, and the Charities Accounts (Scotland) Regulations 2006 (as amended).

(b) Fund accounting

Funds are classified as either restricted funds, endowment funds or unrestricted funds, defined as follows :

Restricted funds are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal process, but still within the wider objects of the charity. In the case of Larkhall New there are two restricted funds, the Vision Development Fund and the Refurbishment Fund.

Endowment funds are funds which have been given on the condition that the original capital sum is not reduced, but the income therefrom is used for the purpose defined in accordance with the objects of the charity. In the case of Larkhall New there are no endowment funds.

Unrestricted funds are expended at the discretion of the trustees in furtherance of the objects of the charity. If part of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the trustees' discretion to apply the funds. In the case of Larkhall New the designated funds are the fabric fund, the Kirk Session funds and the funds of organisations which are incorporated in the financial statements.

(c) Going concern

The Trustees consider that there are no material uncertainties about the ability of the charity to continue for the foreseeable future, and therefore has adopted the going concern basis in preparing these financial statements.

(d) Recognition of income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable the income will be received and the amount can be measured reliably.

(e) Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable.

(f) Recognition and allocation of expenditure

Expenditure is recognised in the Statement of Financial Activities on an accruals basis and is recognised when there is a legal and constructive obligation to pay for expenditure.

(g) Tangible fixed assets

The charity has the right to occupy and use for its charitable purposes certain tangible fixed assets, including Churches, halls, and the manse, title to which is vested in the Church of Scotland General Trustees. No consideration is payable for the use of these assets. Since title to these assets is not vested in the charity's trustees they are not reflected in the charity's accounts, however expenditure incurred on the repair and maintenance of these assets is charged as resources expended in the statement of financial activities in the period in which the liability arises. Title to the premises in Marshall Street are vested in local Trustees but as it is proposed that these be transferred to the General Trustees, again they are not reflected in the charity's accounts.

(h) Taxation

Larkhall New Parish Church is recognised as a charity for the purposes of applicable taxation

(i) Cash and cash equivalents

Cash and cash equivalents include cash in hand and deposits held with the Investors Trust.

(j) Debtors

Trade and other debtors are recognised at the settlement amount due after any discount offered. Prepayments are valued at the amount prepaid net of any discounts due.

(k) Creditors

Creditors are normally recognised at their settlement amount after allowing for any trade discounts due.
