Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form). The Unitary Deed of the Constitution of the Church of Scotland was adopted on 7 December 2018.

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

The Kirk Session, which meets 4 times a year, is responsible for spiritual and temporal affairs within the church.

Certain responsibilities are delegated to the Property Committee as appropriate.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a National Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

1. Worship services:

Weekly on Sunday at 9.45am. There is a formal communion on the first Sunday of the year, and also on the last Sundays of April and October. We hold services on Christmas Eve and Christmas Day and some evening services during Holy Week, with a Communion Service on Maundy Thursday.

Sunday School meets every Sunday at 9.45am.

2. Organisations:

There is a Guild which is attended by members both from Howwood and outwith the parish. The organist and Choir lead worship using innovative music.

3. Community Involvement.

- a. One member of the Congregation is on the Community Council;
- b. Several members of the Congregation serve on the Howwood Emergency Amateur Response Team (HEART);
- c. The Church is supporting the Community Council's effort to get Fairtrade status for the village;
- d. The minister is chaplain to Howwood Primary School;
- e. We sent Christmas gifts to the Preshal Trust;
- f. We collected donations for our local Foodbank at Harvest and Christmas; in 2025 we also supported a local foodbank with a monthly collection.
- g. We provide refreshments for people attending funerals in the Church, this being paid for by our Funeral Tea Fund;
- h. Yoga and fitness classes for adults are held in hall;
- i. A Mother & Toddlers group meets in the hall;
- j. Rainbows, Brownies, Guides, Beavers and Cubs use the Church Hall for regular meetings.

4. Outreach:

- a. A Church website continues to be developed and information about the church is available there.
- b. A Community Coffee morning is held once a month. This is proving to be very popular and well attended;
- c. A charity is chosen every year as recipient for special collections and fundraising. The charity for 2025 was Beatson Cancer Charity.

Achievements and Performance

1. The number of members remains at a similar level to 2024, with new members joining in 2025 and new people becoming associated with the congregation.

Financial Review

The principal source of income for the Church is weekly offerings from the congregation. Running costs remained at a similar level to 2025, resulting in a deficit for the year on our normal activities of £3,089.

The restricted funds had a surplus of £195 for the year, and the overall deficit for the year was £2,894

All major fundraising is directed to the CHIP fund to finance property improvements, which are undertaken in accordance with the Property Committee's rolling five year plan.

Reserves Policy

It is the Trustees' policy to transfer any surplus on the General Account (excluding legacies) to the Fabric Fund.

At the year end the Church held unrestricted cash funds of £63,140 - General Account £33,304 and Fabric Fund £29,836.

The Church also held £22,624 of restricted funds and £1,487 in endowment funds, which have been provided for the purposes specified in Note 2.

Statement of Trustees' Responsibilities

The charity trustees must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The charity trustees are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.


Basis of independent examiner's statement

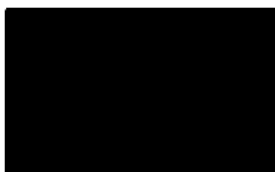

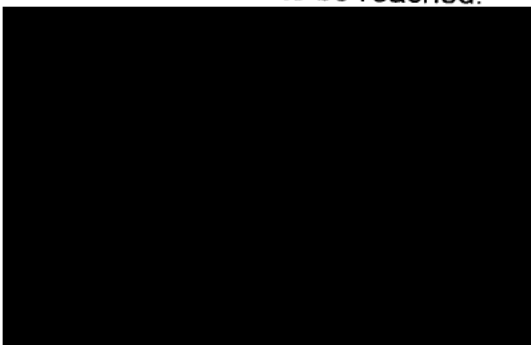

It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent examiner's statement

1. which gives me reasonable cause to believe that in any material respect the requirements:
 - to keep accounting records in accordance with Section 44(1) (a) of the 2005 Act and Regulation 4 of the 2006 Accounts Regulations, and

2. to which, in my opinion, attention should be drawn in order to enable a proper understanding of the accounts to be reached.

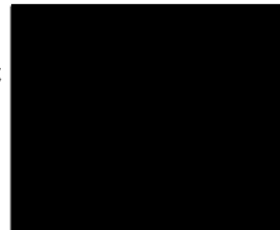
