# TRUSTEES' ANNUAL REPORT

## STRUCTURE GOVERNANCE AND MANAGEMENT

### **Governing Document**

The Church is administered in accordance with the terms of the Unitary Constitution of the Church of Scotland.

### **Recruitment and Appointment of Trustees**

Members of the Kirk Session the charity trustees. The Kirk Session members are the elders of the Church and members chosen from those members of the Church who are considered to have appropriate gifts and skills. The minister who is Moderator of the Kirk Session, is elected by the congregation and inducted by Presbytery.

### **Organisational Structure**

The Kirk Session which meets five times a year is responsible for the spiritual affairs within the Church and is responsible for the finances, property and fabric of the Church.

### **Objectives and Activities**

The Church of Scotland is Trinitarian in doctrine, reformed in tradition and Presbyterian in policy. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

In St Luke's Church Milngavie some of these activities are as follows:

- Services of Worship
- Youth activities within a Sunday School (JAM), Guides, Brownies, Rainbows and the local Boy's Brigade.
- Community activities include being part of the Association of Milngavie Churches, and Friendship House.

The following are some of the significant changes and events which have taken place in the past year:

- The Holy week services for the Milngavie churches, which were hosted by Milngavie United Free Church.
- The congregation has hosted lunches for the church family, including one to facilitate the Tearfund Big Quiz and a Christmas Lunch
- The Boys Brigade, Guides, Brownies and Rainbows, continue to be strong as an outreach to young people and meet in the church halls as they did prior to lockdown.
- Clober SU, led by Moira Shaw and her Team, meet in the Large Hall at lunchtime on Tuesdays. It is encouraging to note that the Group has been growing in number.
- Ann Shields continues to provide teaching for any children attending on a Sunday Morning. This is known as the JAM (Jesus and me) club.
- Gordon Ellis continued with his duties as Roll Keeper. Gordon also transferred a lot of the Mission Praise hymns used each Sunday to an Excel database.
- The annual attestation of the Church records took place on 27<sup>th</sup> January and were generally found to be satisfactory.

## Financial Review

The principal sources of income are Gift Aid donations either weekly, monthly or annually together with weekly Open Plate Offerings and associated tax able to be recovered through the HMRC Gift Aid and GASD Schemes. Total offering and donations showed an increase of £2,532 for the year.

This year we received legacies of NIL (2024 NIL) and income from weddings and funerals of £1,625 (2024 £1,500)

Rental of our large hall generated income of £4,376 (2024 £5,665).

Our overheads reduced to £67,386 (2024 £74,752).

As a result of the above St Luke's Milngavie showed a surplus of £2,339 (2024 deficit of £6,344).

## Reserves Policy

It is the Trustees' intention to ensure sufficient reserve funds are available to meet foreseeable reasonable and necessary expenditure including general ongoing fabric maintenance.


It is the Trustees' policy to hold reserves of approximately four months expenditure including investments. At year end the Church held unrestricted cash funds of £19,836 and investments at market value of £13,987. With monthly expenditure running at an average of £5,615, reserves at 31 December 2025 are in line with the Trustees' policy.

## STATEMENT OF TRUSTEES' RESPONSIBILITIES

The members of the Kirk Session must prepare financial statements in sufficient detail to enable the appreciation of transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which on request, must reflect the financial position at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment Scotland Act 2005, the Charities Accounts Scotland Regulations 2006 and the Regulation Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church of Scotland and must take reasonable steps for the prevention and detection of fraud or other irregularities.

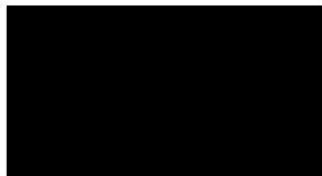

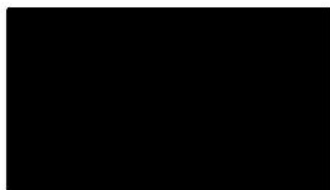

The minister who is Moderator of the Kirk Session, is elected by the congregation and inducted by Presbytery.

### **Organisational Structure**

The Kirk Session which meets five times a year is responsible for the spiritual affairs within the Church, as well as the finances and property of the church.

### **Objectives and Activities**

The Church of Scotland is Trinitarian in doctrine, reformed in tradition and Presbyterian in policy. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

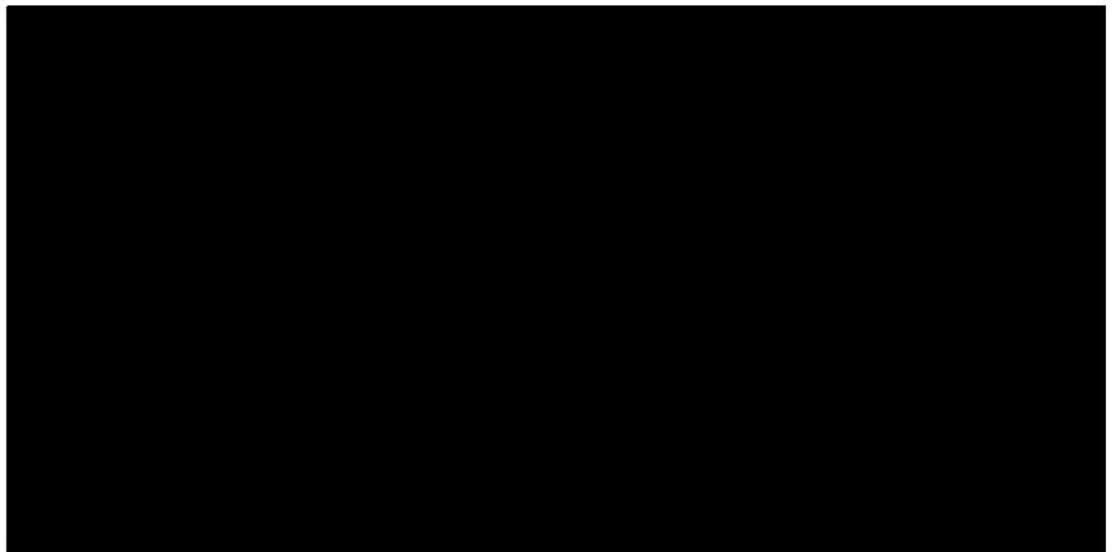
In St Luke's Church Milngavie some of these activities are as follows:

- Services of Worship
- Youth activities within a Sunday Club, Guides, Brownies, Rainbows and the local Boy's Brigade.
- Community activities include being part of the Association of Milngavie Churches, and Friendship House.

The following are some of the significant changes and events which have taken place in the past year:

- The Holy week services for the Milngavie churches, which were hosted by Allander Church.
- The Boys Brigade, Guides, Brownies and Rainbows, continued to grow in numbers and were able to meet in the church halls.
- Clober SU, led by [REDACTED] and her Team, meet in the Large Hall at lunchtime on Tuesdays. It is encouraging to note that the Group has been growing in number.
- [REDACTED] continues to provide Sunday Club teaching for any children attending on a Sunday Morning.
- [REDACTED] continued with his duties as Roll Keeper. [REDACTED] also transferred a lot of the Mission Praise hymns used each Sunday to an Excel database.
- The annual attestation of the Church records took place on 7<sup>th</sup> February 2024 and were generally found to be satisfactory.

#### STATEMENT OF TRUSTEES' RESPONSIBILITIES

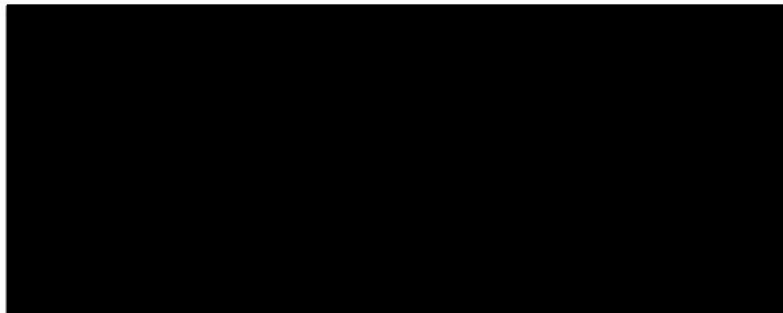
The members of the Kirk Session must prepare financial statements in sufficient

This must be done to ensure that the financial statements comply with the Charities and Trustee Investment Scotland Act 2005, the Charities Accounts Scotland Regulations 2006 and the Regulation Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church of Scotland and must take reasonable steps for the prevention and detection of fraud or other irregularities.
