Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of a Unitary Constitution which was adopted on 11 October 2010.

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

The Kirk Session moderated by the Minister or Interim Moderator usually meets five times a year. Specific responsibilities are delegated to a Treasurer, a Fabric Convenor, a Church Hall Convenor, and a Health and Safety Convenor, with ad hoc committees, set up as and when required, to facilitate other congregational matters as they arise. The Kirk Session is responsible for all matters both spiritual and secular pertaining to congregational life.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Bendochy Parish Church seeks to fulfil its part of the overall work of the church by providing the means whereby people in the parish can meet for worship on Sunday, can be cared for pastorally through a system of Elders' districts, and children and young people can be encouraged to grow in the knowledge of Christ and be encouraged to become useful members of society. In this, the members can co-operate with the other congregation, which is part of the linked charge.

Achievements and Performance

During 2025 we have continued to have Weekly Sunday Services at Bendochy, usually led by lay readers. Our Interim Moderator has been Rev. Klaus Buwert and we are grateful for his support and the support of lay readers.

The congregation remain cheerful and welcoming. We continue to support the local Foodbank and local

children at Christmas. Paul and Ann Rice arrange a monthly Community Café in our hall.

It is still the intention of Perth Presbytery to sell Bendochy Church and for our congregation to form a union with Coupar Angus Abbey Church congregation. The Bendochy Session are exploring the possibility of purchasing the church and church hall but the General Trustees have not indicated whether it will be sold on the open market or by off-market transfer.

Financial Review

Income for the year was £23,202 (2024: £20,426). Donations were £19,720 (2024: £10,107), boosted by a generous legacy of £10,000. The balance of income was made up of the dividends from the Church of Scotland Income and Growth Funds, which remained the same as last year at £3,212, and small amounts from weddings and funerals and the usual collections on behalf of Poppy Scotland.

Last year's income figure of £20,426 includes a claim of £6,437 from the Consolidated Fabric Fund of the General Trustees. A claim of £6,175 was made for the 2025 year but was not received until January 2026 and therefore is not included in these accounts. This should be considered in comparing income of current and previous years.

Payments for the year amounted to £23,313 (2024: £19,531). The major change compared to last year was in the Ministries & Missions Contribution of £11,054 (2024: £6,101). This has returned to a normal level given no Vacancy Allowance applied in 2025. The remaining difference in payments is due mainly to small increases in payroll costs and insurance against reductions in pulpit supply and repairs and maintenance costs. As previously, costs of repairs and maintenance, insurance, and heat and light are covered by the claim from the Consolidated Fabric Fund.

Activities this year have resulted in a deficit of £111 (2024: surplus of £895) and year end bank funds of £13,242 (2024: £13,353). Of course, the delayed claim from the Consolidated Fabric Fund must be taken into account for a true assessment of the results for the year.

Reserves Policy

It has been the policy of the Trustees to make regular transfers into Investors Trust Funds, though at the moment this is not possible. They will keep this policy under review.

Statement of Trustees' Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the

Independent Examiner's Report to the Trustees of Bendochy Parish Church
Year ended 31 December 2025

I report on the accounts of the charity for the year ended 31 December 2025 which are set out on pages 7 to 11.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006 (as amended). The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and, consequently, I do not express an audit opinion on the view given by the accounts.


