Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session and the Congregational Board are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. The Congregational Board is appointed from within the congregation and members of the congregation are invited to nominate individuals who are believed to have the skills and commitment to contribute to the management affairs of the Church, to become members of the Board. Members are then appointed to the Board at the Stated Annual meeting and serve for a period of three years after which they must seek re-election at the next Stated Annual Meeting.

Organisational Structure

The Congregational Board is chaired by an appointed trustee of the Board and Kirk Session and meets four times a year. Certain responsibilities are delegated to the Finance Committee, the Property and Manse Committee and Social Committee as appropriate. The Kirk Session which meets four times a year is responsible for spiritual affairs within the church.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, reformed in tradition and Presbyterian in Policy. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

The Church serves the parishes of Tarff and Twynholm. Services are held each Sunday at Twynholm Parish Church. There is also a Guild open to members and non members which meets during the year.

Achievements and Performance

The charge is linked with Gatehouse and Borgue churches and is served by the Minister Mrs Valerie Ott.

Church services and ministry are well served in the parish with services held every Sunday and pastoral care covered by the minister with the support of the Kirk Session. The number on the roll has decreased during the year.

As a rural charge with an elderly congregation it is difficult to maintain numbers and to have new members introduced to our roll.

The church has a Vision for the Future Group who arrange various outreach programmes to try and have new members added to the roll.

The church building is well maintained and the Kirk Session supported by the Congregational Board maintain a strong presence in the community for worship and support to all in the parish. With recruitment to the Congregational Board becoming ever increasingly difficult it has been decided and voted on to retire the Board and change to a Unitary Constitution from next year. This will pass all responsibilities to the Kirk Session.

Financial Review

The principal source of income is from weekly offerings and donations. During the year under review general giving income was up 7.5% from the previous year. Higher interest rates helped increase income from deposited funds. No fund raising was undertaken during the year. The total income from donations, interest and investment income was the same as the previous year. Funds being released from invested funds held by the General Trustees also helped with funding repairs for the church and other costs.

Expenditure was less than the previous year due to a reduction in building repairs and maintenance which was 71% down from the previous year. Payments to Ministry costs were up by 275% due to adjustments in Glebe Rent and investment income received towards ministry payments. Energy costs were up by 75% due to heating oil being topped up just before the year end. Shared expenses with Gatehouse were up 42%. Overall all general running expenses were costing more than the previous year due to higher charges and inflation. All fabric repairs and maintenance have been charged to the general fund account during the year.

Reserves Policy

The reserve fund now stands at £8,721 although no further funds have been added during the accounting year.


This would not be sufficient funds to maintain the charity for any long period of time in case of an emergency. However the trustees will keep the position under review during the next financial year and make further transfers if funds permit.

The trustees also hold a Fabric Fund reserve account which at the year end held a balance of £8,528. This fund can only be used for fabric repairs and maintenance but also serves as a reserves policy for any building costs.

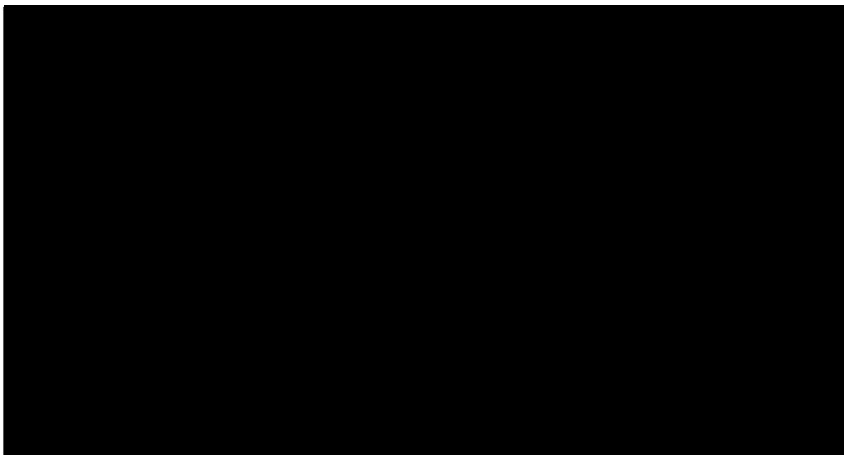

Financial Review

The principal source of income is from weekly offerings and fund raising events. During the year under review general giving income was down 4.5% from the previous year. Higher interest rates helped increase income from deposited funds. No fund raising was undertaken during the year. The total income from donations, interest and investment income was the same as the previous year. Total receipts were up 30% on last year which was partly due to income from invested funds held by the General Trustees being released to help with fabric repairs and maintenance. The total donations figure includes the opening balance for the Guild Account. Expenditure for the year was 30% up from the previous year. The largest increase being repairs to the church hall for a new disabled toilet and upgrading the church hall interior. There was a reduction of 72% to central fund payments for ministries from the previous year following adjustments for invested income and Glebe rent. Energy costs were the same as the previous year. Shared expenses with Gatehouse were up from the previous year but a final accounting was still awaited at the year end. All fabric repairs and maintenance have been charged to the general fund account during the year.

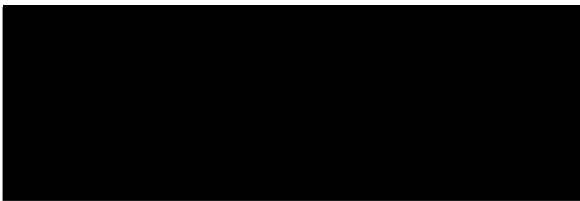

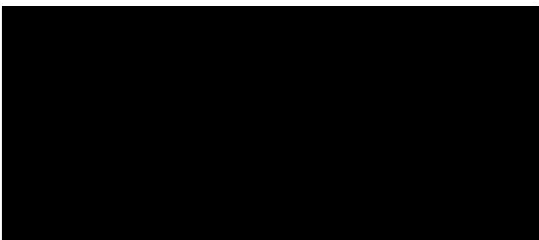

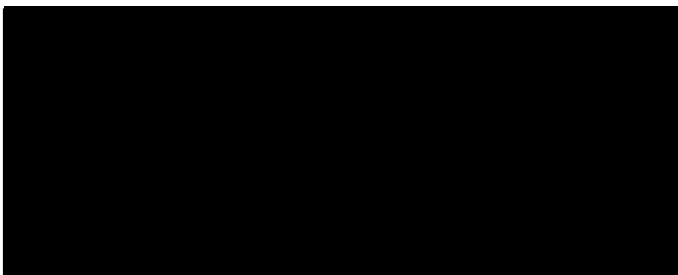
