(4) The advancement of education of the arts, heritage, culture and/or history. and (5) The advancement of environmental protection or improvement including preservation, and conservation of the natural environment, the promotion of sustainable development, the maintenance, improvement, or provision of environmental amenities for the Community and/or the preservation of buildings or sites of architectural, historic or other importance to the community.
