Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts as set out in pages four to seven in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. Basis of Independent Examiner's Statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented in those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently, I do not express an audit opinion on the accounts.

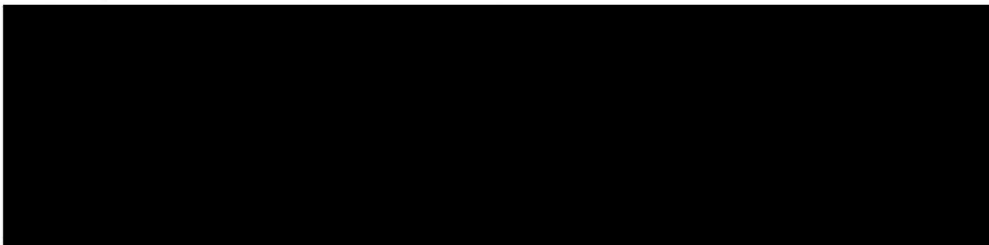
Additional Information to support Accounts prepared

For the financial year ending 31st Mar 2025 Auchterless Playgroup SC005029 has reported an operating loss of £14,044. In the last financial year, we collected significant cash grants. In this financial year, we spent most of this income on improvements to the garden area and invested in new resources. This has resulted in the operating loss this year.
