Report of the Trustees

The Trustees present their report together with the Receipts and Payments Account of the charity for the year ended 30 September 2025.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Structure, Governance and Management

St Peter's Episcopal Church: Stornoway is an unincorporated association, governed by a constitution dated 1875 and last amended in 2022. As a member congregation of the Diocese of Argyll and the Isles in the Scottish Episcopal Church, it is also governed by Canon Law and the Digest of Resolutions of the Scottish Episcopal Church. The management team of the Church is known as the Vestry. For the purposes of charities law, the members of the Vestry are the Charity Trustees of the Church. Details of the Vestry members are given on page 1.

Apart from the Rector, ordinary Vestry members are elected by the Congregation at the annual meeting. The Treasurer and Secretary are appointed by the Vestry and do not have to be elected at the annual meeting. At least one member retires at the annual meeting, generally the longest serving and will not be eligible to be re-elected that year. If there is more than one member in that category, the member to retire shall be chosen by lot. The Rector's warden is appointed by the Rector. The Rector is appointed by the Vestry and the Bishop of the Diocese.

New vestry members are given an induction pack outlining their roles and responsibilities. The vestry secretary regularly updates other members of the vestry on relevant changes in legislation and practice relating to charities

Relationship with Diocese and Province

St Peter's Episcopal Church: Stornoway is supported by the Diocese and the Province through the pastoral oversight of the Bishop, central support functions provided at Diocesan level and grants from central funds. The church is represented at Diocesan level by the Rector and the Lay Representative. As a member of the SEC, St Peter's has an obligation to contribute to the costs of the Diocese and the Province through payment of an annual 'quota'. This amount is based on the relative level of income of the church in comparison with that of other churches in the Diocese and Province.

Vestry Responsibilities

The vestry is responsible for managing and safeguarding the assets of the church, and assist the Rector in matters affecting the spiritual welfare of the congregation. They are also responsible for keeping proper accounting records and ensuring that the accounts are prepared in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The vestry regularly considers the risks faced by St Peter's and ensures that appropriate risk management procedures are in place to mitigate those risks.

FINANCIAL REVIEW

Results for the year

The receipts and payments account for the year is set out in pages 5 to 10.

At 30 September 2025 the Unrestricted General Fund had a balance of £10,404 (2024 - £5,158). Due to the delay in receiving the Mackenzie Trust funding for 2025, the Unrestricted Designated Fund relating to the St Moluag's Restoration, which at 30 September 2024 had a balance of £20,000, was transferred back to the General Fund. The intention is to restore the designated fund once the Mackenzie Trust funding has been received. Restricted funds as at 30 September 2025 were made up from the St Moluag's Restoration Fund £5,927 (2024 - £2,000), the Windows Fund £14,998 (2024 - £14,998), the Mission Seed Fund £61 (2024 - £11), the Altar Flower Fund £228 (2024 - £255), the Sister Clare Memorial Fund £500 (2024 - £500), the Special Collections Fund £613 (2024 - NIL), and the Pilgrimage Fund (previously named the Iona Pilgrimage Fund) £880 (2024 - £880). Total reserves amounted to £33,611 (2024 - £43,802). The investments in the Scottish Episcopal Church Unit Trust Pool were sold during the year, realising a total of £31,099.

Reserves Policy

St Peter's Episcopal Church: Stornoway's reserves fall into the category of unrestricted and restricted funds. Unrestricted funds can be spent on any relevant activity; restricted funds can only be spent on a defined activity.

The Vestry has adopted a policy of trying to maintain a level of unrestricted reserves such that, in the event of a significant drop in income, the church would be able to maintain its current level of activities for a reasonable period until replacement funding is obtained.

Investment policy and objectives

Monies which are not needed to fund day to day expenditure, are invested in the Scottish Episcopal Church Unit Trust Pool (UTP), administered by Baillie Gifford. The investment policy of the UTP, which accords with that of the vestry, is to earn a return on the assets, over the long term, sufficient to maintain the real value of the distribution to unit holders. The UTP has developed an ethical investment policy. No investments will be made in companies which derive more than 15% of their revenue from tobacco, gambling or armaments. The majority of the UTP is invested in UK equities.

CONCLUSION

The members of the Vestry would like to thank all those who contribute their time, energy and money so generously to ensure the continuation and development of St Peter's Episcopal Church: Stornoway as a centre of worship and a focus for the community.

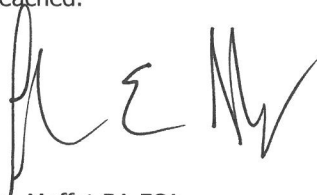
Basis of independent examiner's statement

1. Accounting Policies

Accounting Convention

The financial statements have been prepared under the historical cost convention, and under the guidelines laid down in the Statement of Recommended Practice - Accounting and Reporting by Charities (revised 2006)

Basis of financial statements

The financial statements have been prepared on a receipts and payments basis

Church Income

All voluntary income and bank interest is accounted for when received.

Statement of Balances

For the purpose of the statement of Balance as shown on page 6, funds are defined as follows:

Unrestricted funds comprise grants and other income received for the objects of the church without further specified purpose and are available as general funds

Restricted funds comprise income which has been received for the objects of the church and specified for a restricted purpose within these objects by the donor

2. Trustee Remuneration and Related Party Transactions

None of the vestry members receive any remuneration relating to their position as vestry members. However, commensurate with their post, the Rector received a stipend and contributions to a pension fund totalling £39,360 , in accordance with, for the post of Rector, the stipendiary amounts as directed and approved by the Scottish Episcopal Church (SEC). As is customary the Rector occupies the Rectory, on a rent-free basis and has the council tax on the Rectory paid for by the charity.

During the year 1 trustee was reimbursed expenses totalling £12,610

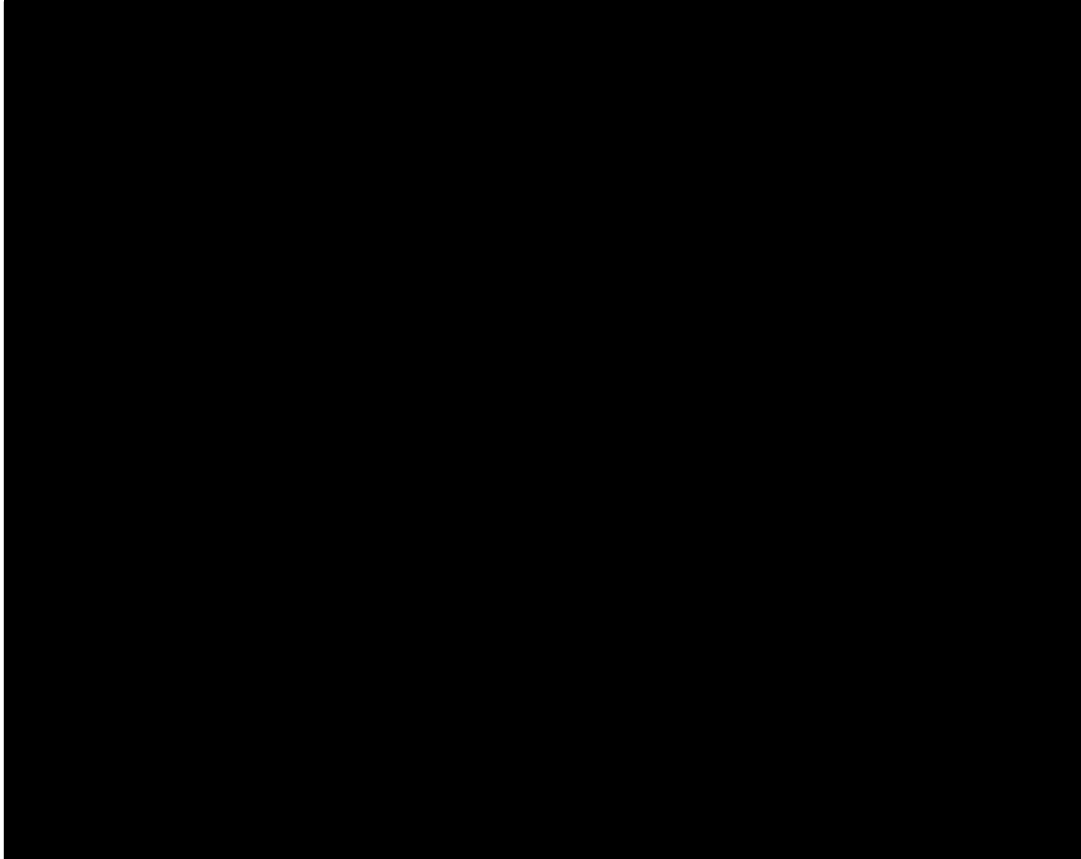

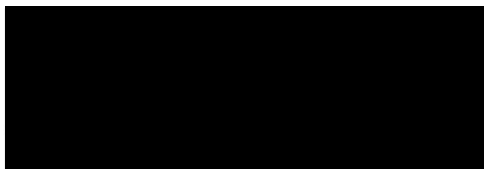

Monies which are not needed to fund day to day expenditure, are invested in the Scottish Episcopal Church Unit Trust Pool (UTP), administered by Baillie Gifford. The investment policy of the UTP, which accords with that of the vestry, is to earn a return on the assets, over the long term, sufficient to maintain the real value of the distribution to unit holders. The UTP has developed an ethical investment policy. No investments will be made in companies which derive more than 15% of their revenue from tobacco, gambling or armaments. The majority of the UTP is invested in UK equities.

The members of the Vestry would like to thank all those who contribute their time, energy and money so generously to ensure the continuation and development of St Peter's Episcopal Church: Stornoway as a centre of worship and a focus for the community.

Basis of independent examiner's statement

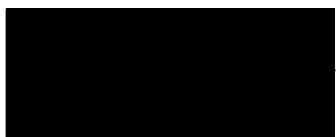
