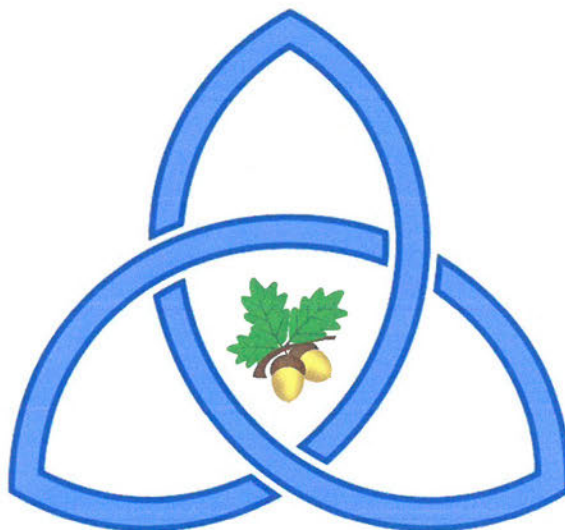

Trustees' Report

Year Ended 31 December 2024

The Trustees' present their annual report and financial statements of the Charity for the Year Ended 31 December 2024. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the General Assembly Regulations for Congregational Finance, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published on 16th July 2014.

Objectives and Activities

Both the Church of Scotland and the United Reformed Church are Trinitarian in doctrine, Reformed in tradition and Presbyterian in policy. Both Churches co-operate with other Churches in various ecumenical bodies in Scotland and beyond.

Oakshaw Trinity Church has developed a Mission Statement, which says:

Oakshaw Trinity Church, in common with all Churches, exists to proclaim the good news of Christ in our place and context.

"Proclamation" consists not only of regular worship, but service to, and presence in, the community, by which signs others see something of Christ's Kingdom.

Oakshaw Trinity is committed to care for people in pastoral need, to provide an opportunity for worship and fellowship, and to empower individual members for witness and service.

The Congregation meets for worship weekly on Sunday at 11.00 a.m. Weekly online Worship material is still available on Facebook and on the Website. Worship is held on a Thursday in the Wynd Centre, an outreach of the Congregation of Oakshaw Trinity Church. The Centre is there for the benefit of the Community. Our work with children and young people is through the Sunday School and our Uniformed Youth Organisations. We have Boys' Brigade, Girls' Brigade and Guide Companies including Brownie and Rainbow Packs. Adult Organisations include The 2 O'clock Club, Tea and Crafts, The Friendly Hour, Trinity Theatre Group, Handbell Ringers, Church Choir, Men's' Club and an Explorers Group. A monthly lunch club operates from October to April for all members and others who wish to attend.

Sunday School: 2024 started with the children looking at new beginnings and making calendars for the year ahead. In February the children took part in the Family Service, followed by an afternoon of Lego building and crafts. The children had a great time using their imagination. The Easter period saw the children learning the bible story and making Easter bonnets. In June, children attended the church family outing to Finlaystone Country Park. It was a beautiful sunny day; the children enjoyed bug hunting, den building and playing games out in the gardens. Lots of fun was had by all! We finished in June with our annual promotion service. At this service we also took time to say thank you to 4 teachers that were standing down:

We give our

sincerest gratitude for all their years' service to the Oakshaw Trinity Sunday School. In August, we started back after summer, learning about the creation of the world and Adam & Eve. At the Wynd Centre Ruby Anniversary weekend, we learned what the Wynd Centre and our volunteers do, and how we can help others. The children also made anniversary cards for the Wynd Centre, which we presented to the board of directors. We ended the year with a Christmas party and our highly anticipated nativity play called "The New Star". All children took part and were absolutely fabulous.

2 O'Clock Club: The 2 O'Clock Club is a ladies group, which meets on the last Monday afternoon of the month from September to May. Normally about 20 to 25 people attend. We have a speaker or activity for the first 30 to 45 minutes and then enjoy some chat over tea and coffee. In the early summer and before Christmas we have a lunch in a local restaurant. We also try to raise money for one or two charities over the year.

Our aims are FELLOWSHIP, FRIENDSHIP, FUN and FUNDRAISING.

Friendly Hour: The Friendly Hour meet every Tuesday afternoon from October to May. The Friendly Hour welcomes Ladies and Gentlemen and we can assure you of an afternoon of friendship and fellowship.

As well as serving tea and coffee, biscuits or cakes, the friendly chatter around the tables is something to be enjoyed. We arrange a wide variety of entertainers to come along each week, whether that be a lovely lady playing the clarsach, the Fiddlers, Choirs, some young people from local schools and also members from our own Church Choir to name a few. We enjoyed our end of session lunch in May at Caulders Garden Centre and returned there for our Christmas Lunch in December. We sometimes have fun afternoons playing Bingo or enjoying Indoor Curling, which can be quite competitive.

We welcome new members at any time of the year and look forward to welcoming anyone who would like to join us.

Rainbows, Brownies and Guides: This year our numbers are sitting at 30 girls across all three units. Which is great. We have been to many outings with the girls and are looking forward to taking them on many more next session.

This session we completed badges and took part in many different activities like crafts, games and baking.

Choir: The Choir meet on Thursday evenings at 8.00 p.m in the Lang Hall from September to May under the leadership of our Director of Music [REDACTED]. We prepare Anthems and Hymns for Sunday Services and also for the Lessons and Carol Service in December. In May our Session finishes with a Dinner.

We are a very friendly choir, numbers have gone down and would love to have some new members in all sections.

Girls' Brigade: 2nd Paisley Girls' Brigade continue to meet in The Wynd Centre every Thursday evening during school term time.

We currently have almost 40 girls aged between 5-18 years across our 3 sections. As well as this we have 9 adult leaders. We currently also have 2 Brigaders going through the PVG scheme with a view to starting leadership training over the coming months.

Our **badgework** covers 4 topics - Spiritual, Education, Service and Physical.

Over the year, we have attended Youth Services within the Church and we always have a good attendance at these from the girls. We had our annual camp up at Lapwing Lodge, joined the Church outing to Finlaystone Country Park and each Section joined in Divisional Activity days. We also attended Doors Open day and were fortunate to gain a couple of new members which was a bonus.

Towards the end of the year we had our annual panto trip, held our fundraising coffee evening – the proceeds from this were split between the Church and The Wynd Centre. Our Brigaders also helped out at the Church Christmas Coffee Morning.

Oakshaw Explorers Group: The Oakshaw Explorers continued their walks and visits to interesting places from April to September 2024. The day walks on a Saturday and outings on a Sunday afternoon each took place once a month covering a variety of areas from the Glasgow Bus Tour to inspecting the new promenade at Millport. In between saw walks at Mount Stuart, Rothesay and Lochshore Hub, Glengarnock to name but a few. While weather occasionally was not as good as hoped for the meetings went ahead with perhaps the coffee shops being visited for a longer spell.

Tea and Crafts: The tea and craft group continues to run through the year on the second Monday of the month.

It is always nice to see what kind of craft our members are doing and shared ideas.

It also provides fellowship especially for those who live alone. It is lovely to share a cuppa and sample some nice goodies.

Boys' Brigade: We currently have three sections running, Company, Juniors and Anchors. We meet on a Friday evening in The Wynd Centre, School Wynd, Paisley, from 6.30 to 9.30 / 10.00. We have a varied programme of activities - Bible Study, Crafts, Cooking, Sport and Games also badge work. We currently have 4 Company Section boys that have achieved their President's Badge Qualification and we hope to present them with their awards soon. They can then begin the journey towards the King's Badge, the highest award for Boys in Boys' Brigade. All are welcome at Boys' Brigade and we hope to instil the ethos of the Boys' Brigade in each one of them, to see them grow to young adults, with pride in themselves and the confidence to go forward.

Men's Club: The Men's Club continue to meet on Friday nights for fellowship, table tennis and snooker. We have been intending to try pickleball. We have the equipment, and one of our members has been playing pickleball while on holiday, so he can show us the ropes. We were also donated a modern table tennis table which has made life a lot easier getting the equipment set up and put away. Membership remains steady although attendance varies from week to week.

Trinity Theatre Group: Trinity Theatre Group has been around under many names since before WW2. It stopped for two years during WW2 and another two years since then when Covid struck. The Club puts on one performance each year and is supported by at least four of Oakshaw Trinity Church's organisations as well as members of the public. Anyone can be a member from Primary 7 upwards and everyone is welcome and can be engaged in the performance in whatever capacity they want. There is no charge to be a member and costumes are provided to ensure costs do not affect anyone wishing to join. Oakshaw Trinity Church provides rehearsal space in a safe environment and our recent performances have been held in the Wynd Centre. The most recent being, Disneys', 'The Little Mermaid'.

Achievements and Performance

2024 was a busy year for EMEC. The Education focus was on the **Sunday School** and it is pleasing to note the continuity despite significant staffing changes. Support by the link elders, and working on a rota, the team delivered a structured programme, using, age appropriate materials, ending the year with a successful nativity play. Attendance averaged about 8 young people, of varying ages.

Lunch Club. A less formal type of education takes place at the monthly lunch club, with a good mix of talks and friendly social interaction, with around 20 attending. Here, we must acknowledge the stalwart volunteers who prepare the lunches, as well as the guest speakers.

Continuing the theme of bringing people together, **EMEC** ran bread and soup lunches at Communion, as well as the family lunch at the Sunday School promotion service in June.

The objective for **Mission** was to build up the mission fund and it is pleasing to report that the funds at the end of the year have enabled us to donate £250 each to Ferguslie Early Learning Centre, Blue Triangle and the DEC emergency appeal for the Middle East. We were also delighted to fund and collate 30 starter packs for Blue Triangle, which were delivered to Bruce Court in late November. Further, we have promoted the work of Christian Aid both for Christian Aid week in May and throughout December.

Tea and Toast: A tangible aspect of Mission has been the weekly 'Tea and Toast' at the Wynd Centre which has a small but loyal following. We know this is valued by those attending and, recognising the value of outreach, we are exploring new approaches for 2025.

We continue to support the Renfrewshire Foodbank too.

Our main goal for Eco Congregation has been to build on the foundation established by our Silver Award and to seek ways of raising awareness of eco issues, through articles in Trinity, Facebook and in Church, with a number of initiatives, not least the Recreate Fashion Show. It was pleasing to see young people taking part in this, helping to draw attention to the need for responsible use of clothing. It is undoubtedly a big help that Fiona Catterson is an assessor for Eco Congregation Scotland and that we are seen as a 'go to' Church for other Congregations. For 2025, we have plans to restore the Eco garden and develop partnerships with existing 'green' organisation in Renfrewshire.

Financial Review

The Freewill Offering and other sources of income have increased slightly. Costs were in line with expectations except for major Church Repairs which were considered essential together with our new heating installation. The overall outcome is a deficit of £14,280 which is acceptable by the Trustees.

Risk Management

The Church lives in challenging times and the Trustees feel it is prudent to consider issues which may become more problematic for us.

Our Congregation is ageing and many of our members are housebound or require care or live in care establishments. This brings increased and changed responsibility in the way we maintain our fellowship and worship.

The cost of maintaining the Church buildings and fabric which are of historical significance, imposes a considerable burden on the income and resources of our Church. We are presently meeting this obligation thanks to the generosity of our members and the continuing support of The William Adams Trust. Continuing prudent management of our finances and funds is essential.

We continue to undertake essential repairs and maintenance which are required to keep our Church and Halls in excellent condition.

The Church halls are being let and income from lets will help revenue for the Church. This will be reviewed annually to ensure continuance of lets and the use of the halls.

Reserves Policy

The Charity Trustees' have considered the reserves required and have taken into account their current and future liabilities. It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds. At the year end the Church held unrestricted funds of £180,718 which represents just over twelve months expenditure.

The Church also hold £369,483 of restricted funds which have been provided for the purposes specified in Note 15.

Structure, Governance and Management

The Congregation is a registered Charity, number SC005362 and is administered in accordance with a constitution approved by the Congregation in 2007 and by the Church of Scotland and the United Reformed Church in September 2008. It has also been noted by ACTS Ecumenical Development Group.

Members of the Kirk Session are the Charity Trustees. The Kirk Session members are the Elders of the Church and are chosen from those members of the Church who are considered to have the appropriate gifts and skills. The Minister, who is a member of the Kirk Session, is elected by the Congregation and inducted by The Clyde Presbytery and by the Scottish Synod of the United Reformed Church.

The Kirk Session has the following Committees: Education, Mission and ECO Matters; Pastoral Care; Fabric; Finance and Administration. Members are elected for a period of three years, and are eligible for re-election

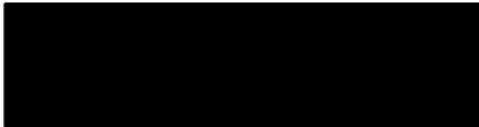

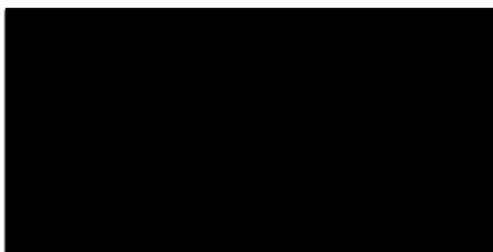

In preparing the financial statements, the Trustees are required to:

- Select suitable accounting policies and then apply them consistently;
- Observe the method and principles in the applicable Charities SORP;
- Make judgements and estimates that are reasonable and prudent;
- State whether applicable accounting standards and statements of recommended practice have been followed, subject to any departures disclosed and explained in the financial statements;
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Charity will continue in operational existence.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and to enable them to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The Trustees are responsible for the maintenance and integrity of the Charity and financial information on the Congregation's website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

I report on the accounts of the charity for the year ended 31 December 2024 which are set out on pages 11 to 21.

Respective responsibilities of Trustees and Examiner

The Charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended)

The Charity Trustees' consider that the audit requirement of Regulation 10(1) (a) to (c) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulation 2006 (as amended). An examination includes a review of the accounting records kept by the Charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the Trustees concerning any such matters. 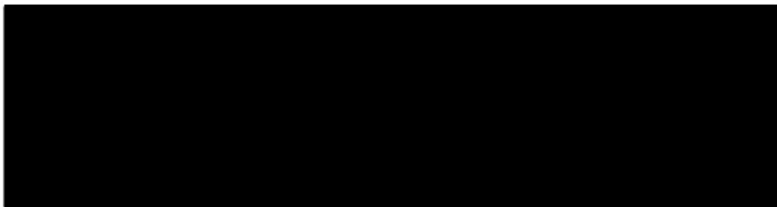

Accounting Policies

The principal accounting policies, which have been applied consistently in the current preceding year in dealing with items which are considered material to the accounts are set out below.

Basis of Preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102) issued on 16 July 2014 and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities accounts (Scotland) Regulations 2006 (amended).

Fund Accounting

Funds are classified as either restricted funds or unrestricted funds, defined as follows:

Restricted funds are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal processes, but still within the wider objects of the Charity.

Endowment funds are funds which have been given on the condition that the original capital sum is not reduced, but the income there from is used for the purpose defined in accordance with the objects of the Charity.

Unrestricted funds are expendable at the discretion of the Trustees in furtherance of the objects of the Charity. If parts of the unrestricted funds are earmarked at the discretion of the Trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the Trustees' discretion to apply the fund.

Incoming resources

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Donated services and facilities

Donated professional services and donated facilities are recognised as income when the Charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102) the general volunteer time of Congregation members is not recognised.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the Charity which is the amount the Charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised as expenditure in the period of receipt.

Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the Charity; this is normally upon notification of the interest paid or payable by the Bank.

Fixed Assets

The Charity has the right to occupy and use for its charitable objects certain tangible fixed assets, including the Church, vested in the Church of Scotland General Trustees. No consideration is payable for the use of these assets. Expenditure incurred on the repair and maintenance of these assets is charged as resources expended in the Statement of Financial Activities in the period in which the liability arises. The Charity also owns the Wynd Centre and the halls at Oakshaw Street, Paisley. The Trustees consider that it would be impractical to apply conventional valuation techniques to these buildings and accordingly no valuations are available.

Investments

Fixed asset investments are stated at market value at the balance sheet date. Unrealised gains and losses represent the difference between the market value at the beginning and end of the financial year or, if purchased in the year, the difference between cost and market value at the end of the year. Realised gains and losses represent the difference between the proceeds on disposal and the market value at the start of the year or cost if purchased in the year.

Taxation

Oakshaw Trinity Church is recognised as a Charity for the purposes of applicable taxation legislation and is therefore not subject to taxation on its Charitable activities. The Charity is not registered for VAT and resources expended therefore include irrecoverable input VAT.
