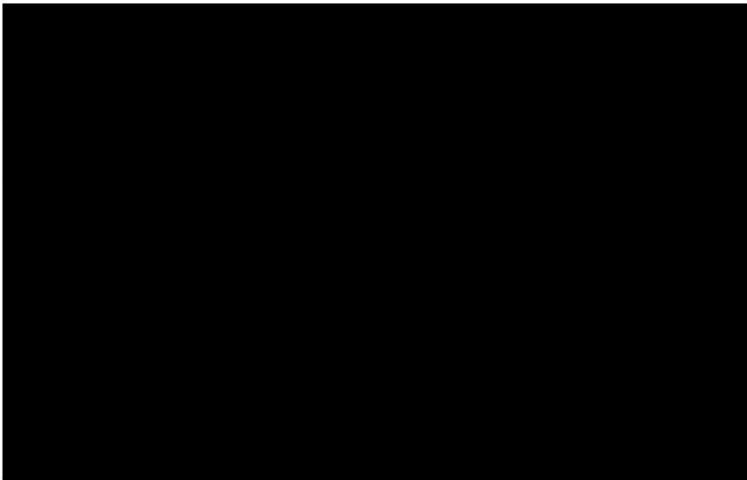

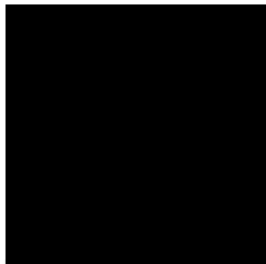

Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Model Deed of Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk of Session and the Congregational Board are the charity trustees. The Kirk Session members are elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. The Congregational Board is appointed from within the congregation and members of the congregation are invited to nominate individuals who are believed to have the skills and commitment to contribute to the management affairs of the Church, to become members of the Board. Members are then appointed at the Stated Annual Meeting and serve for a period of three years after which they must seek re-election at the next Stated Annual Meeting.

Organisational Structure

The Congregational Board is chaired by the minister and meets about four times a year. Certain responsibilities are delegated to the Finance Committee and Property Committee as appropriate. The Kirk Session, which meets about four times a year, is responsible for spiritual affairs within the church.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond. In addition to a regular service of worship every Sunday morning, Southend Parish Church holds various other services in the course of the year (some in premises other than our own) and it also runs a Guild, a Bible Study and several ad hoc events.

Achievements and Performance

The monthly Church and Parish Magazine continues to be produced and is read widely. The yearly door to door collection for Christian Aid was made throughout the Parish. The Church continues to provide child sponsorship through World Vision. During June the St Columba Conventicle was held and was well attended, the Church also held two Coffee Mornings with the proceeds from the second one going to Pickups For Peace. The Church also held a Sale of Work in the Summer. The Blythswood Shoe Box Christmas Appeal was again well supported by members of the Congregation.

Financial Review

The Congregation's principle source of income is weekly and annual offerings which in 2024, after excluding tax recovered on donations given through the Gift Aid Scheme, were down £468 on the previous year. Income from fundraising activities amounted to £5200, an increase of £550 on the previous year. Total receipts for the year were down £126. Expenses for the year were up by £17653 from 2023, this is due mainly to repairwork carried out at the Manse. There was therefore a deficit for the year of £15467 across all accounts.

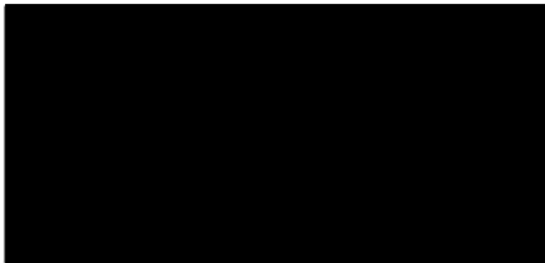
Reserves Policy

It is the Trustees' policy to hold in the low interest General Account a sum sufficient to cover the anticipated expenditure of the congregation over a six month period.

Statement of Trustees' Responsibilities

The members of the Congregational Board must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Congregational Board are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Southend Parish Church

I report on the accounts of the charity for the year ended 31st December, 2024 which are set out on pages 6 to 10.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent examiner's statement

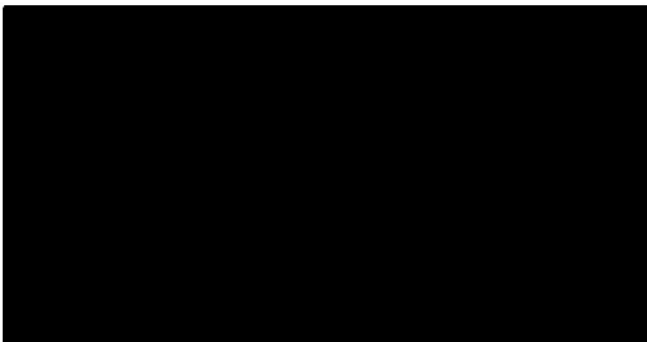
In the course of my examination, no matter has come to my attention

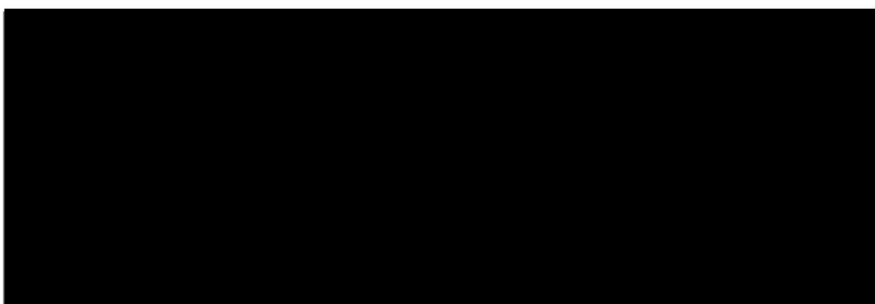
